
(57) **CLAIM**

The ornamental design for a cassette for steam sterilizer, as shown and described.

DESCRIPTION

FIG. 1 is a top, front perspective view of a cassette for a steam sterilizer showing our new design;
FIG. 2 is a top, back perspective view of the cassette;
FIG. 3 is a side view thereof, the opposite side being a mirror image thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a front end view thereof;
FIG. 6 is a back end view thereof;
FIG. 7 is a bottom view thereof;
FIG. 8 is a top perspective view of a lid that forms a part of the cassette;
FIG. 9 is a top perspective view of a tray of the cassette;
FIG. 10 is a bottom view of the lid shown in FIG. 8; and,
FIG. 11 is a top plan view of the tray shown in FIG. 9.






















