

(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevation view of a shirt and bow tie arranged in packaging showing my new design; FIG. 2 is a bottom plan view thereof; FIG. 3 is a top plan view thereof; and, FIG. 4 is a rear elevation view thereof. 




