The ornamental design for a clamp head, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and left side perspective view of a clamp head showing our new design;

FIG. 2 is a bottom, rear and right side perspective view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a right side view thereof;

FIG. 7 is a top plan view thereof;

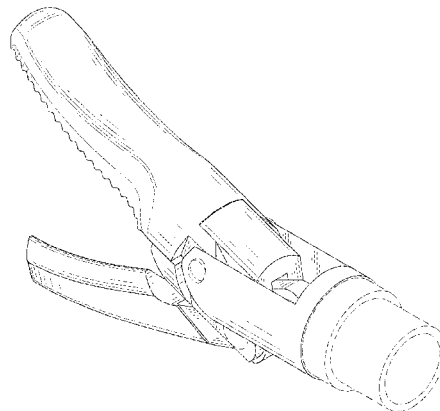
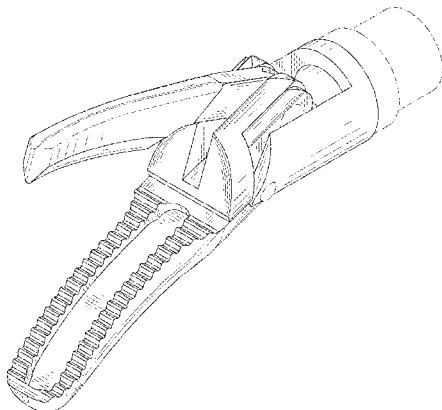
FIG. 8 is a bottom plan view thereof;

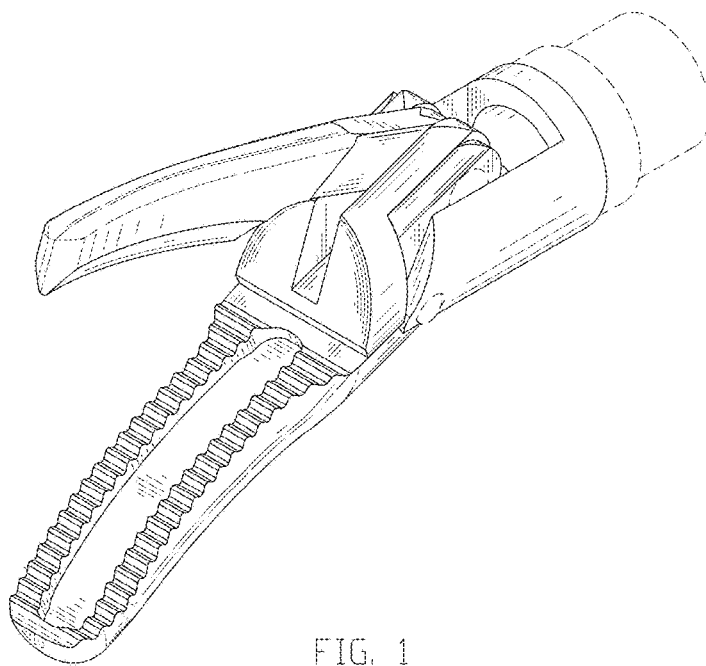

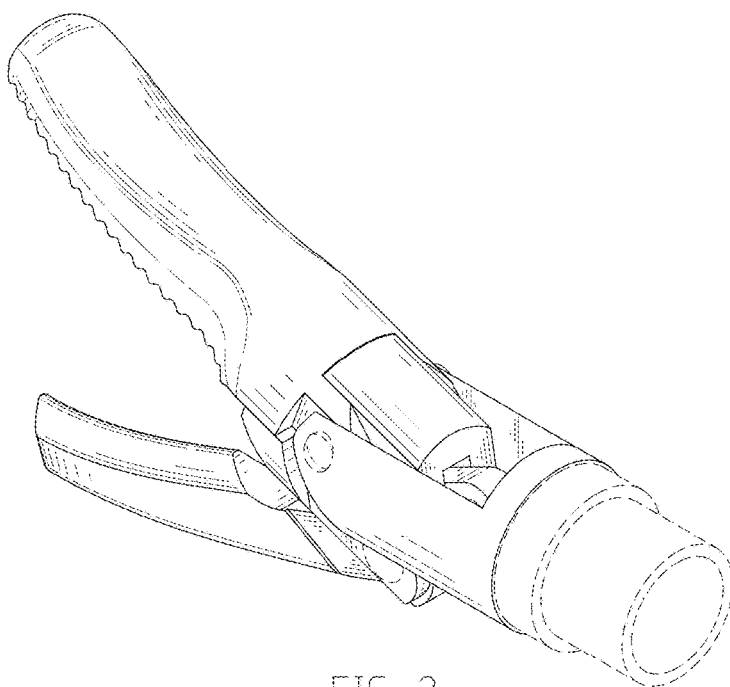

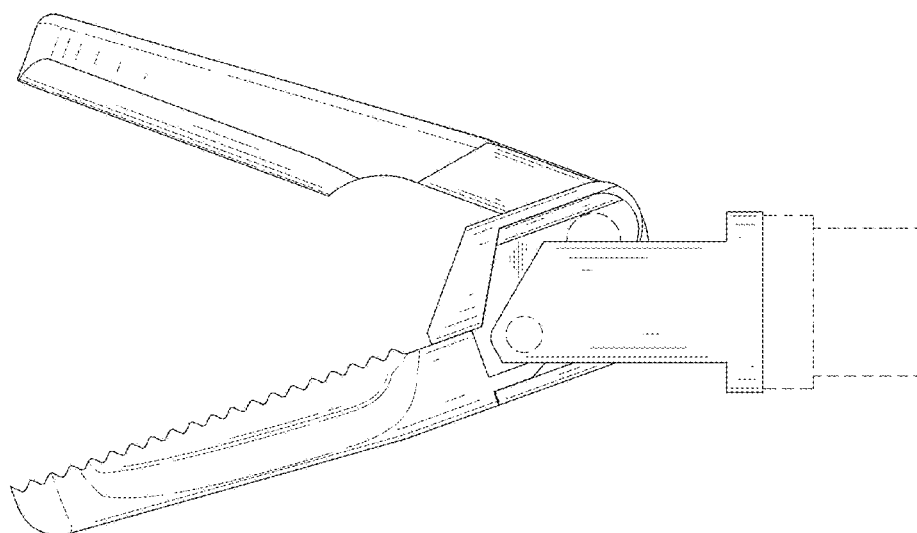

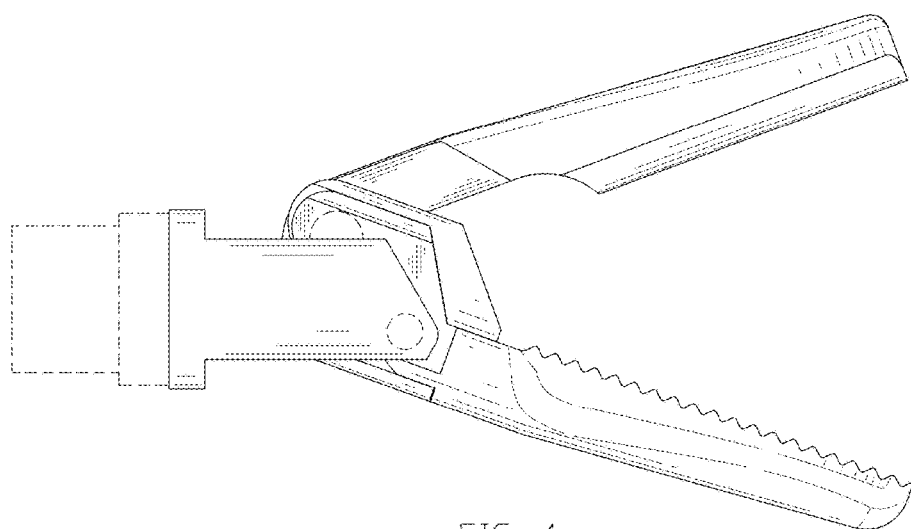

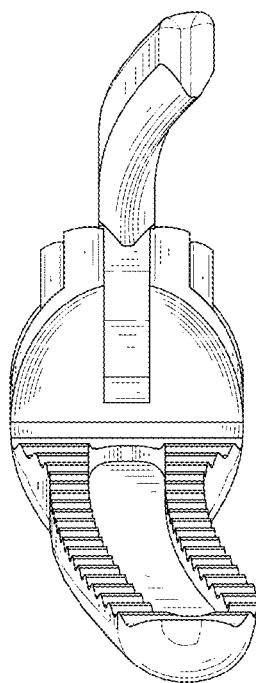

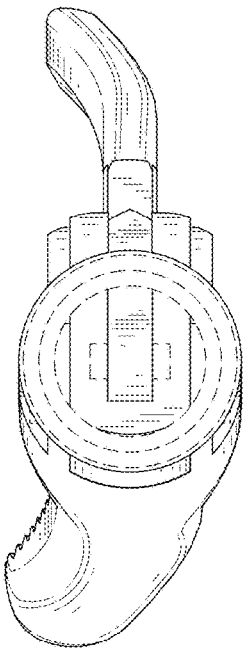

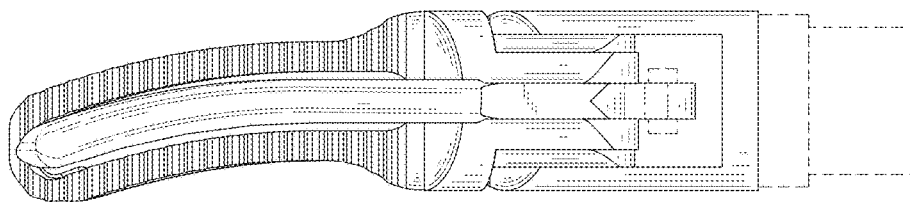

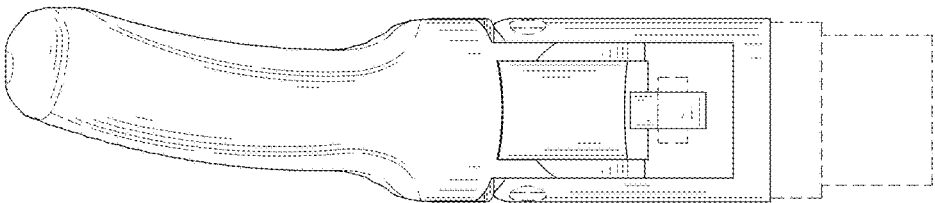
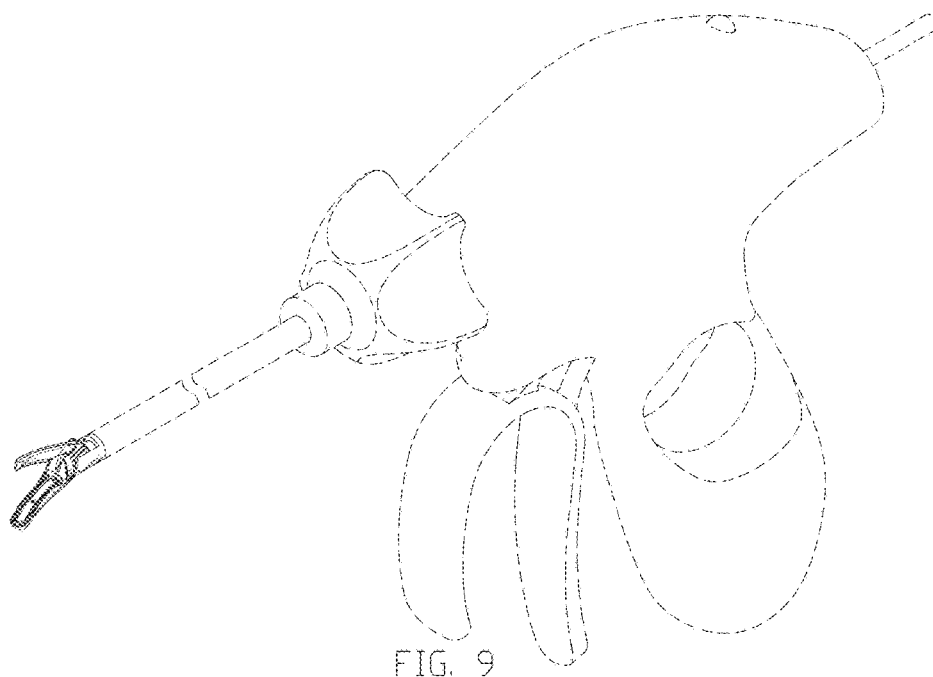

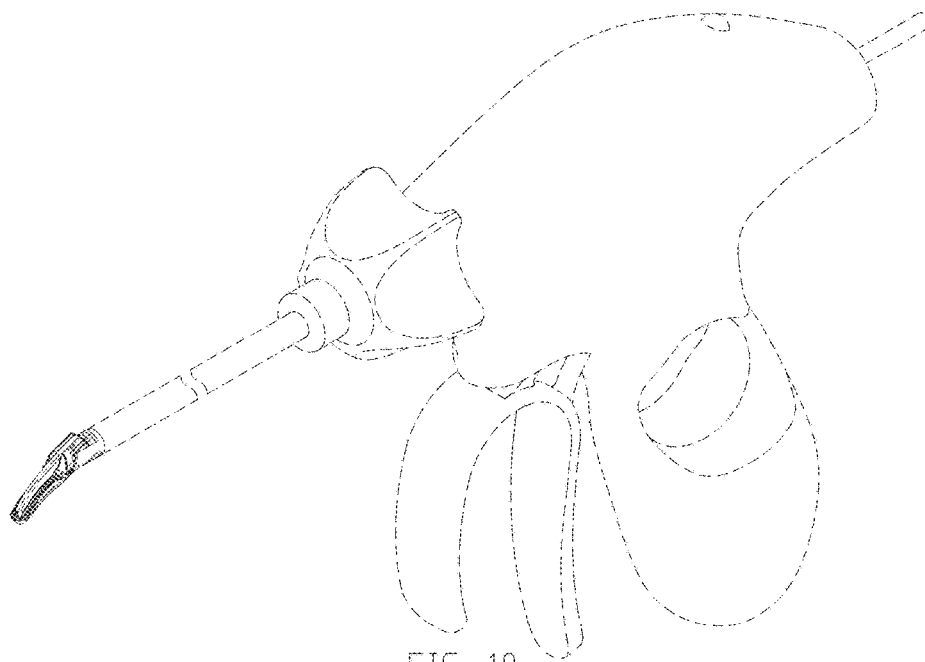
