

(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front elevational view of a canopy light showing our new design;  
FIG. 2 is a rear elevational view thereof;  
FIG. 3 is a left side view thereof;  
FIG. 4 is a right side view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a bottom plan view thereof;
















