**DESCRIPTION**

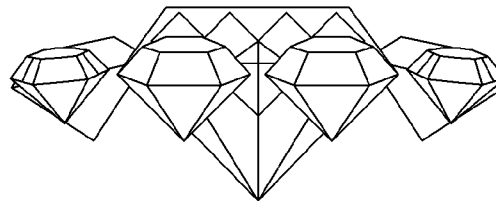
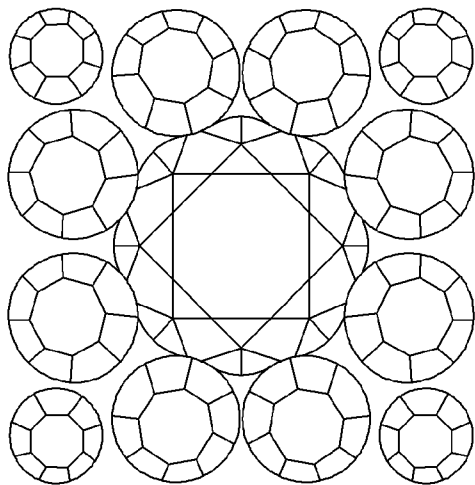
FIG. 1 is a top view of diamond jewelry showing our new design;

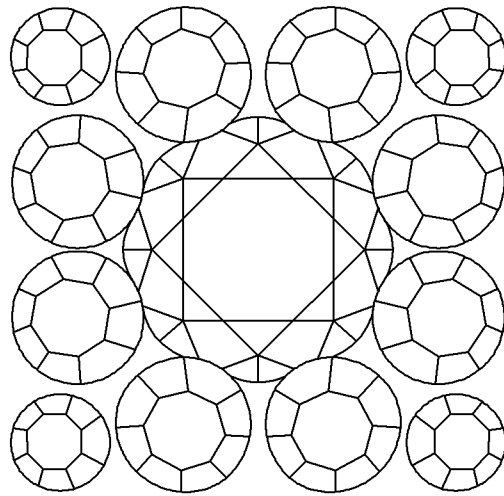
FIG. 2 is a left side elevational view thereof, the right side, front and rear views being identical;

FIG. 3 is a top view of a second embodiment of diamond jewelry showing our new design; and,

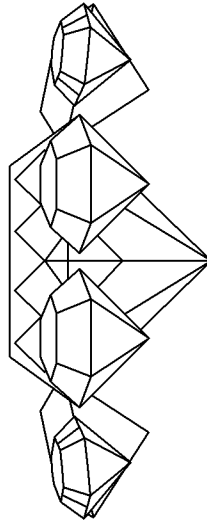
FIG. 4 is a left side elevational view thereof, the right side, front and rear views being identical.

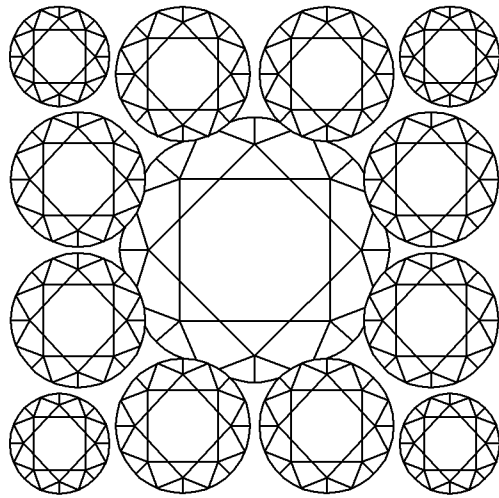




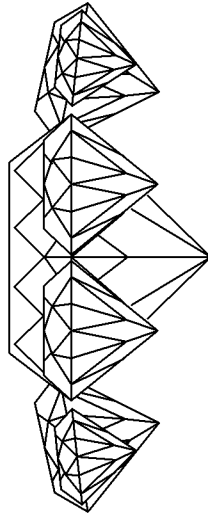
