**CLAIM**

What is claimed is the ornamental design for a styling rack, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a styling rack showing a new design;

FIG. 2 is a top view of the styling rack of FIG. 1;

FIG. 3 is a front view of the styling rack of FIG. 1;


FIG. 4 is a side view of the styling rack of FIG. 1;












