FIG. 1 is a perspective view of an lighting fixture showing our design;

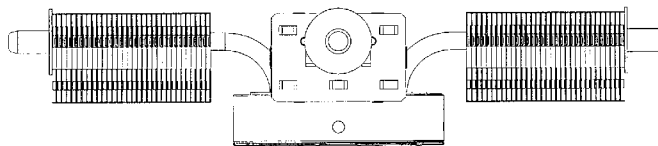
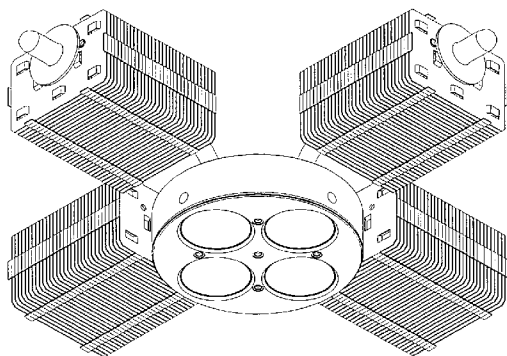
FIG. 2 is another perspective view thereof;

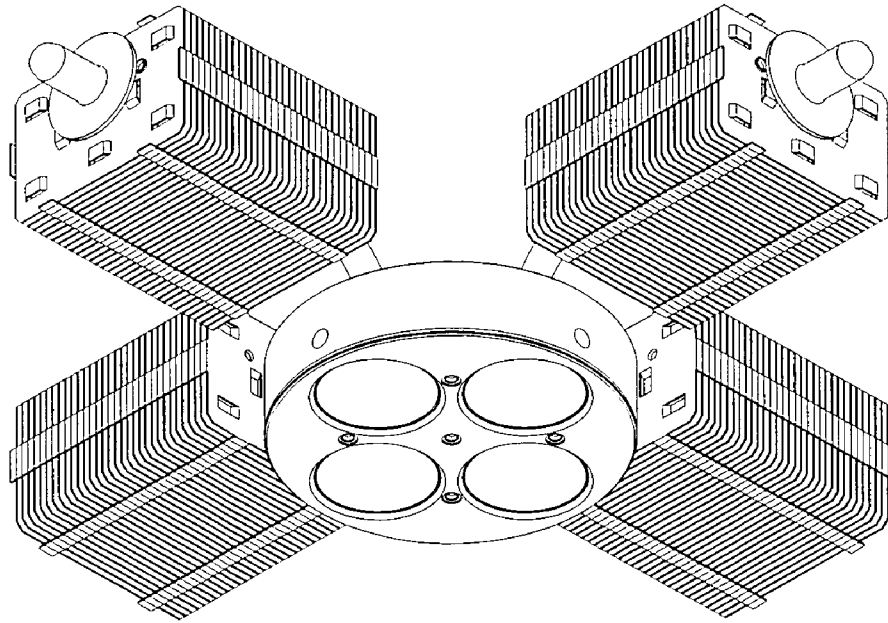

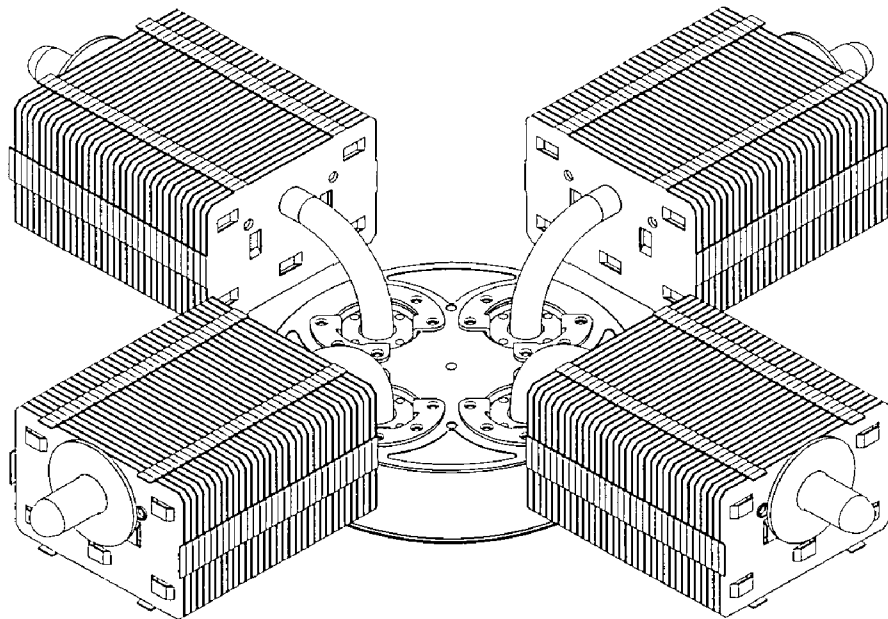

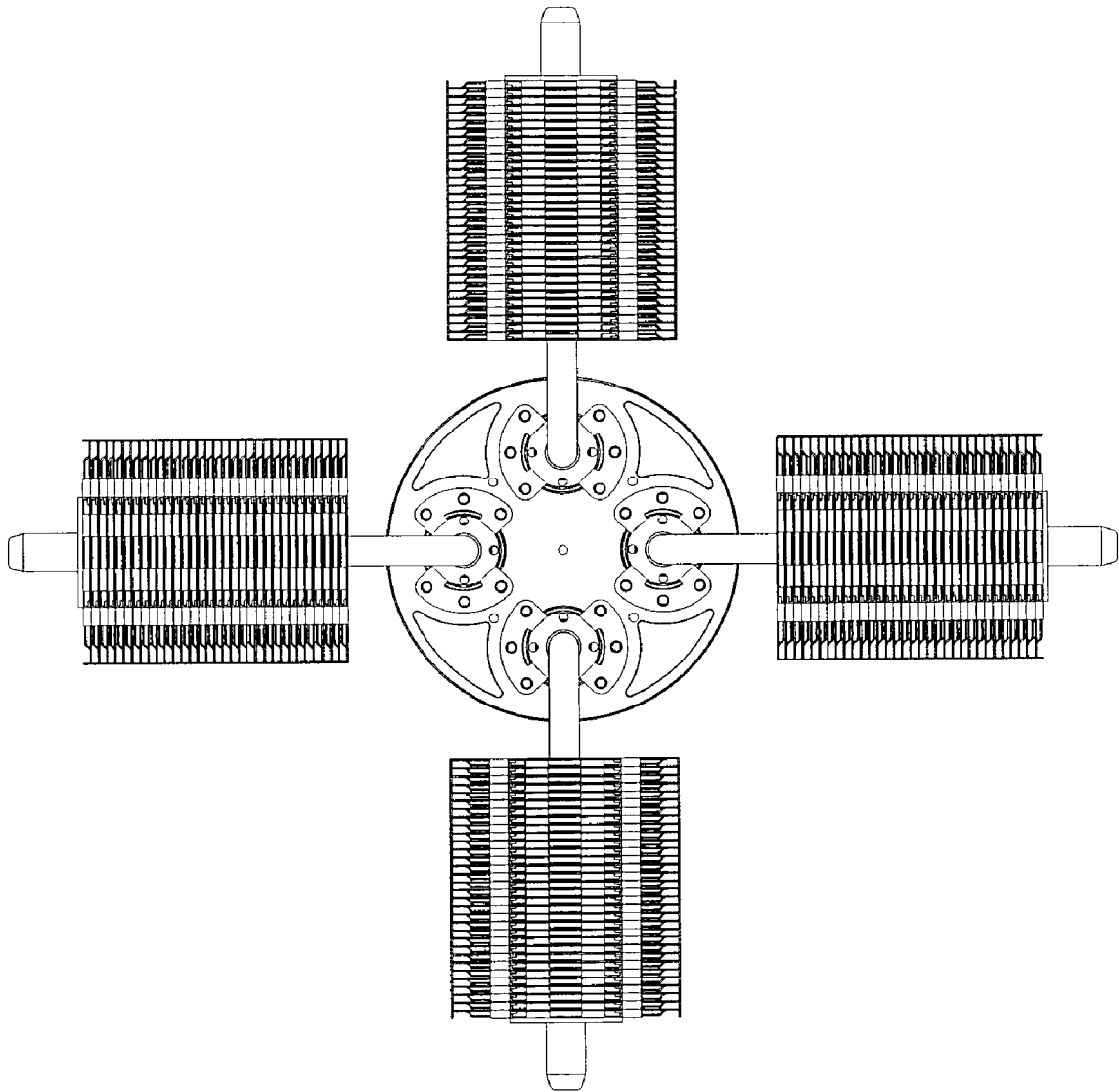

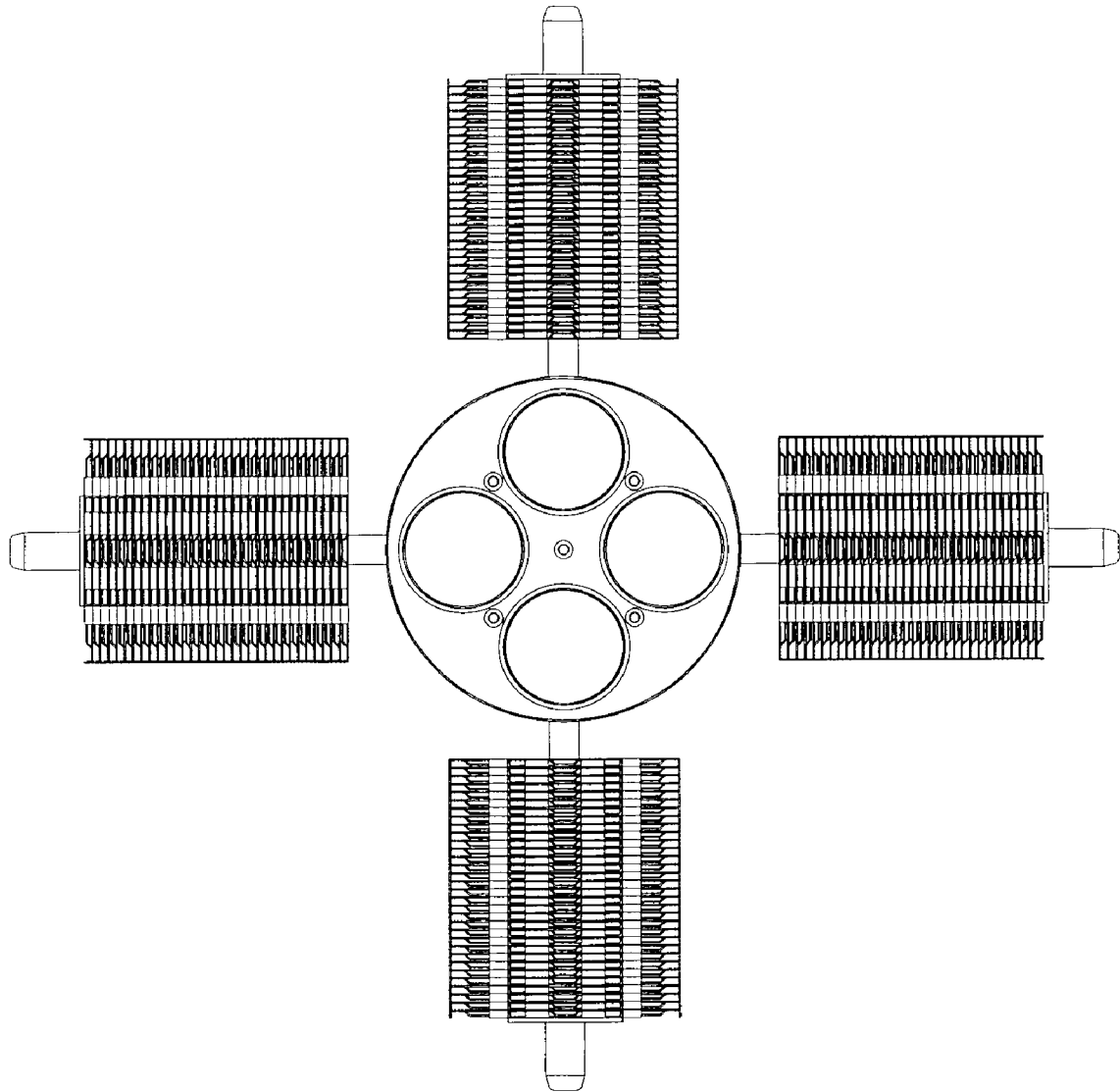

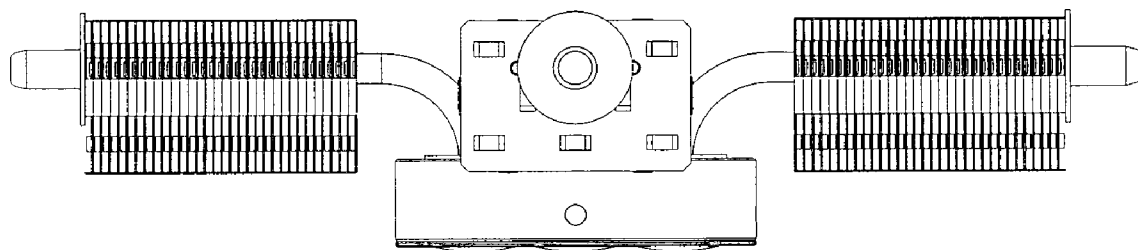
