FIG. 3 is a top view of a curved face grease fitting showing our new design; and,

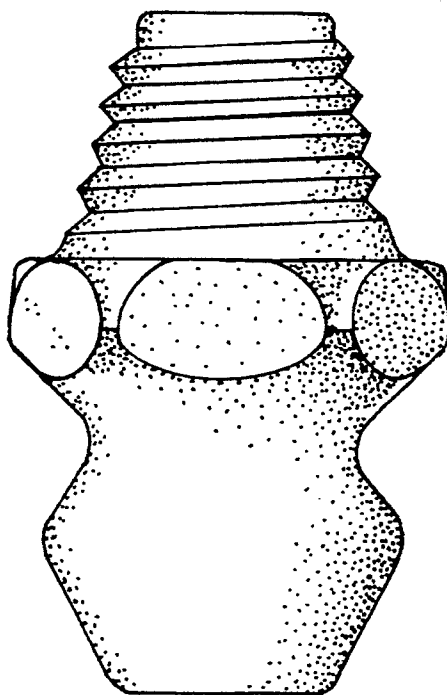

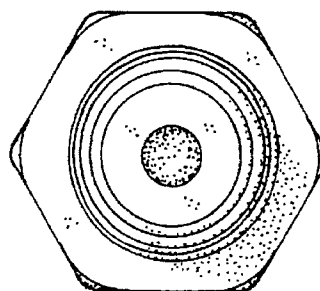

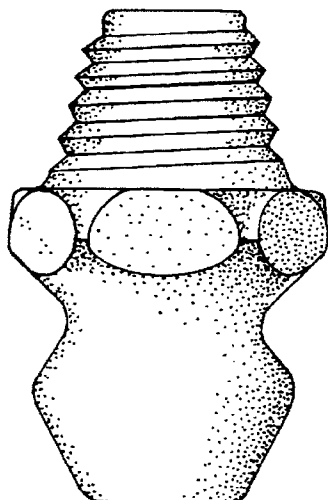

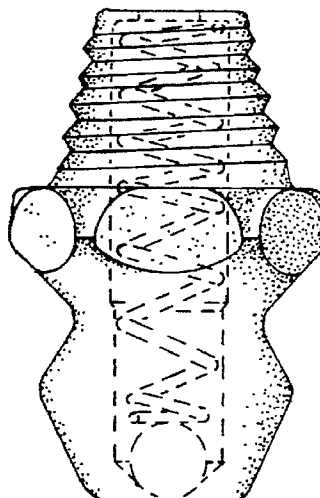




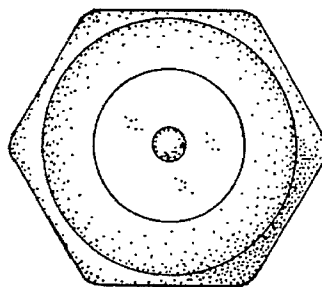
