[57] **CLAIM**

A new ornamental design for a combined telephone stand and desk organizer, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a primary embodiment of a combined telephone stand and desk organizer showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a top plan view thereof;

FIG. 10 is a front elevational view thereof;


FIG. 11 is a right side elevational view thereof with the left side elevational view being a mirror image of the right side elevational view thereof;

FIG. 15 is a rear perspective view thereof.




























