FIG. 9 is a left side view of the footwear shown in FIG. 7;

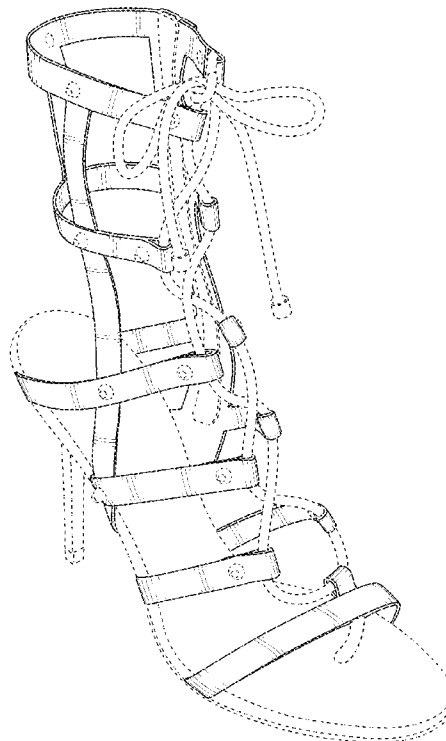
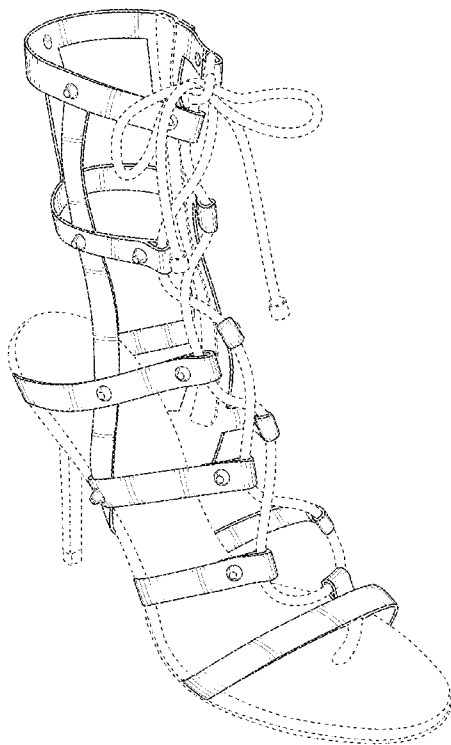
FIG. 10 is a front view of the footwear shown in FIG. 7;

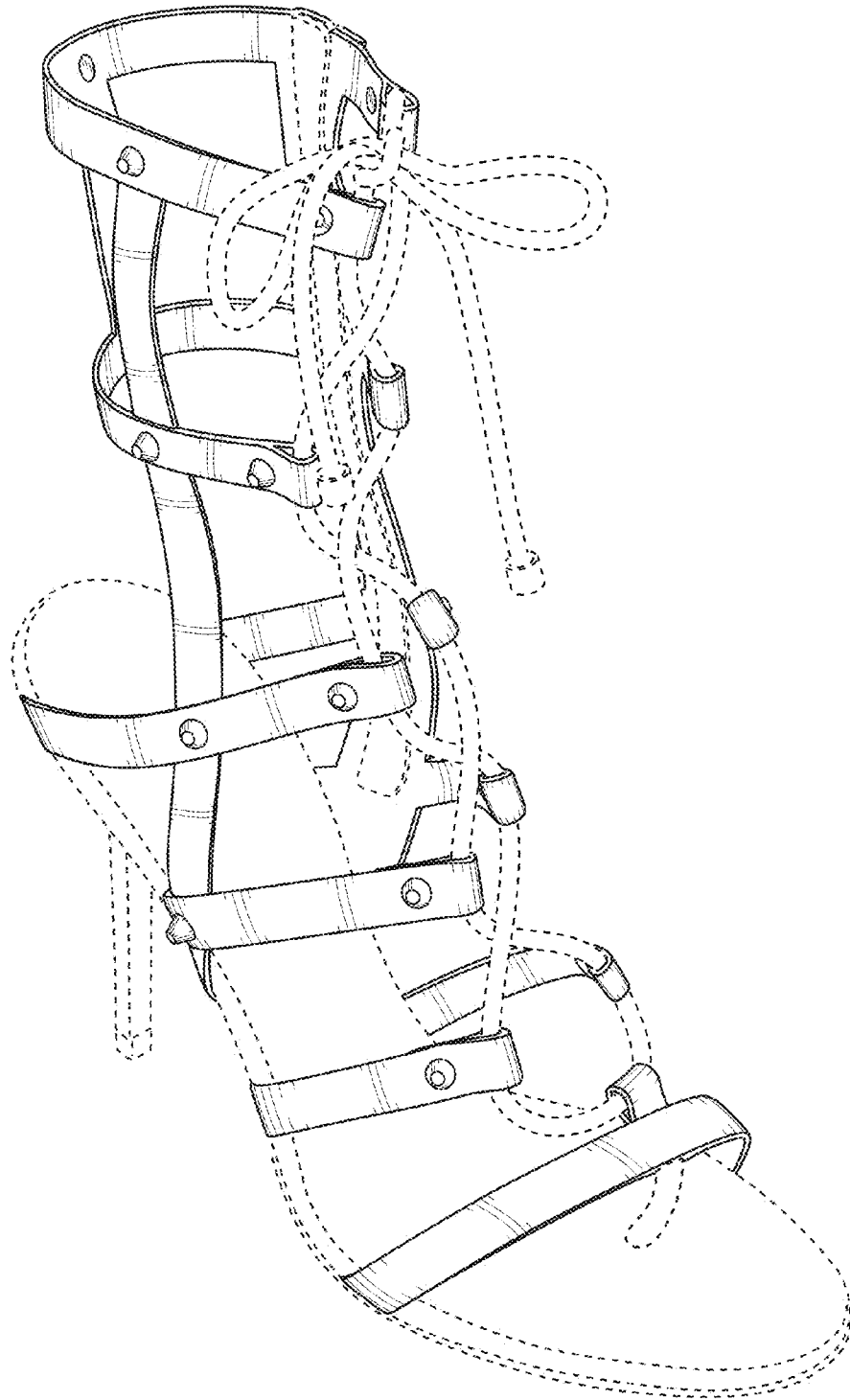

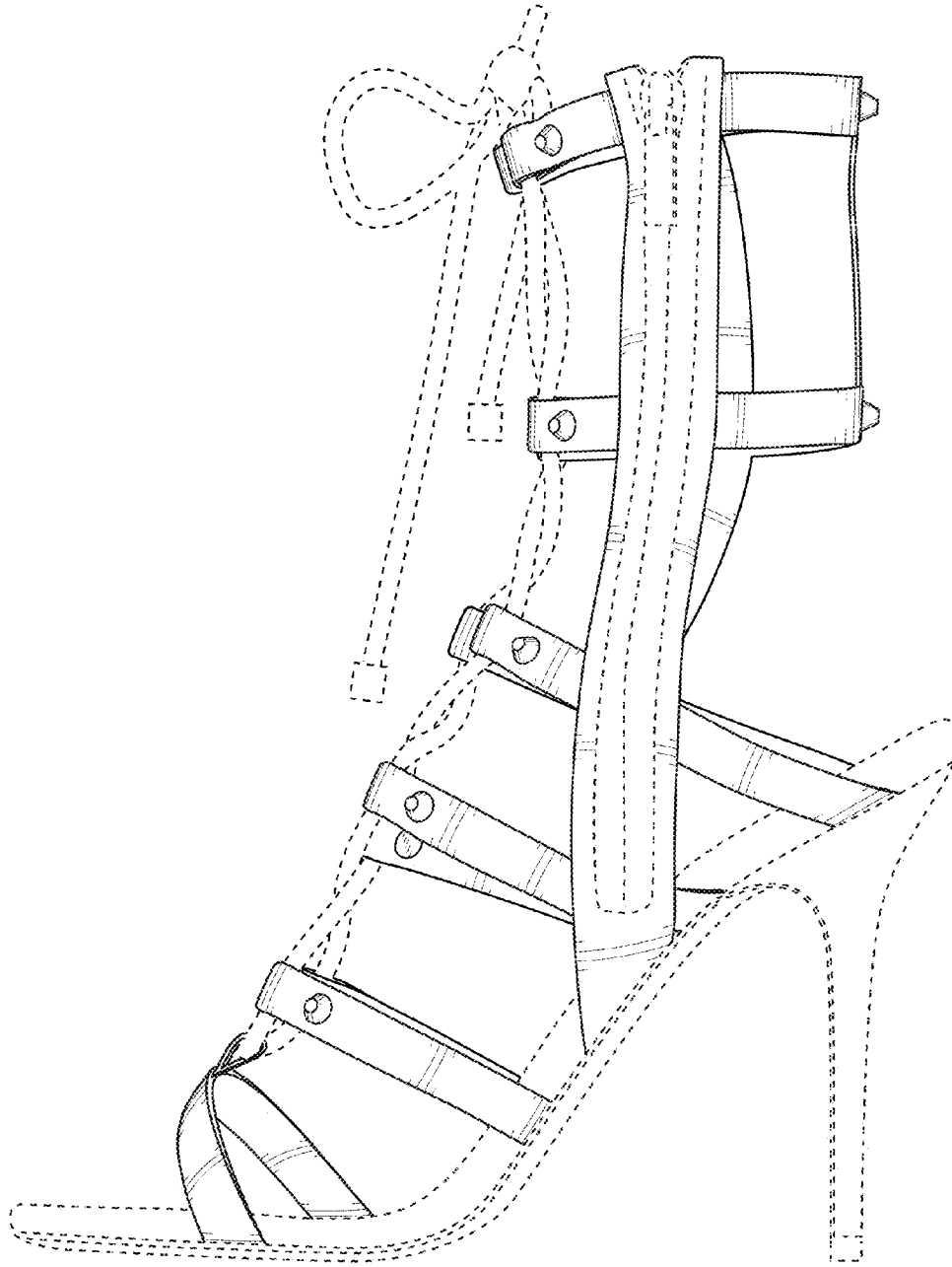

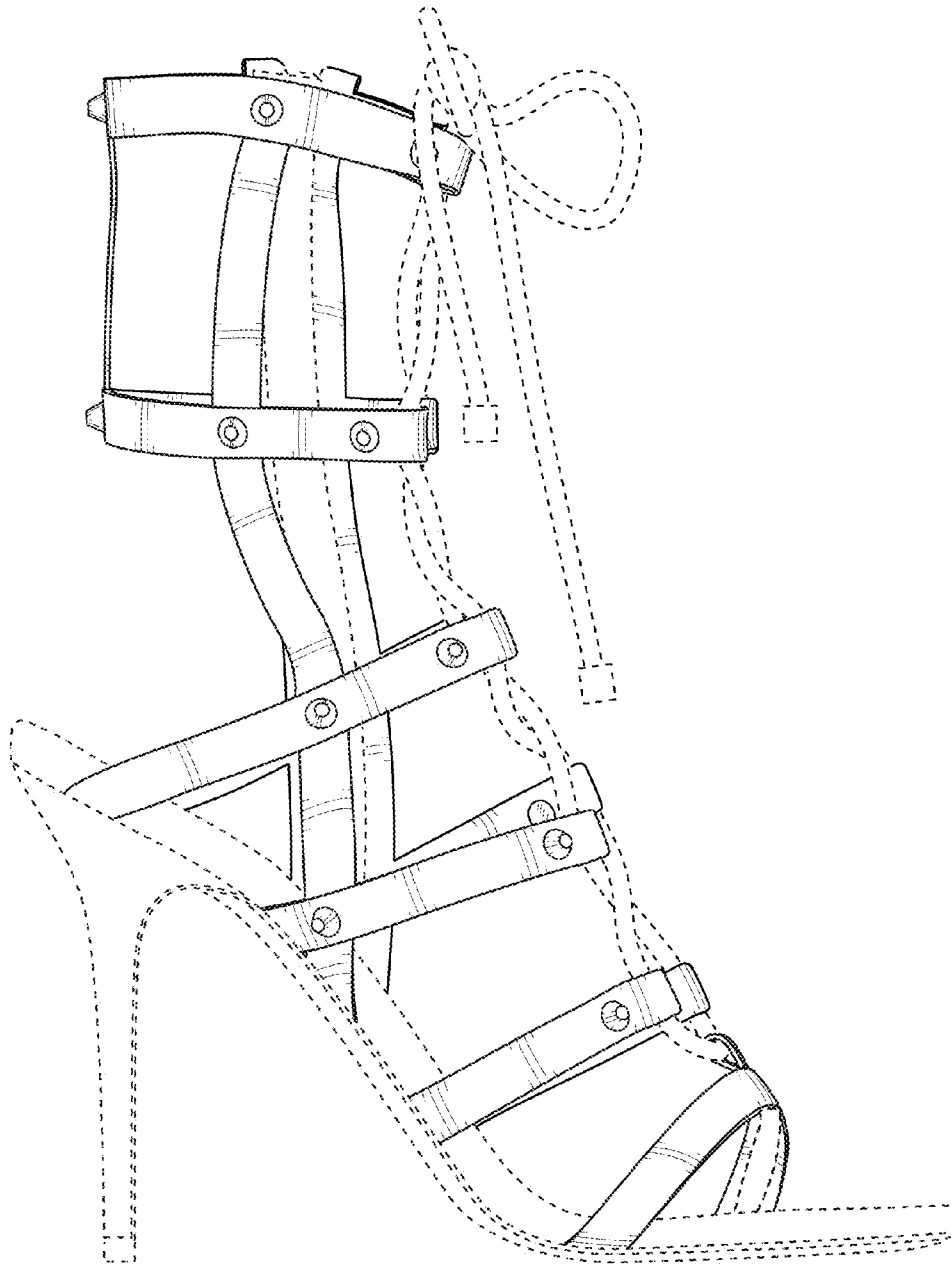

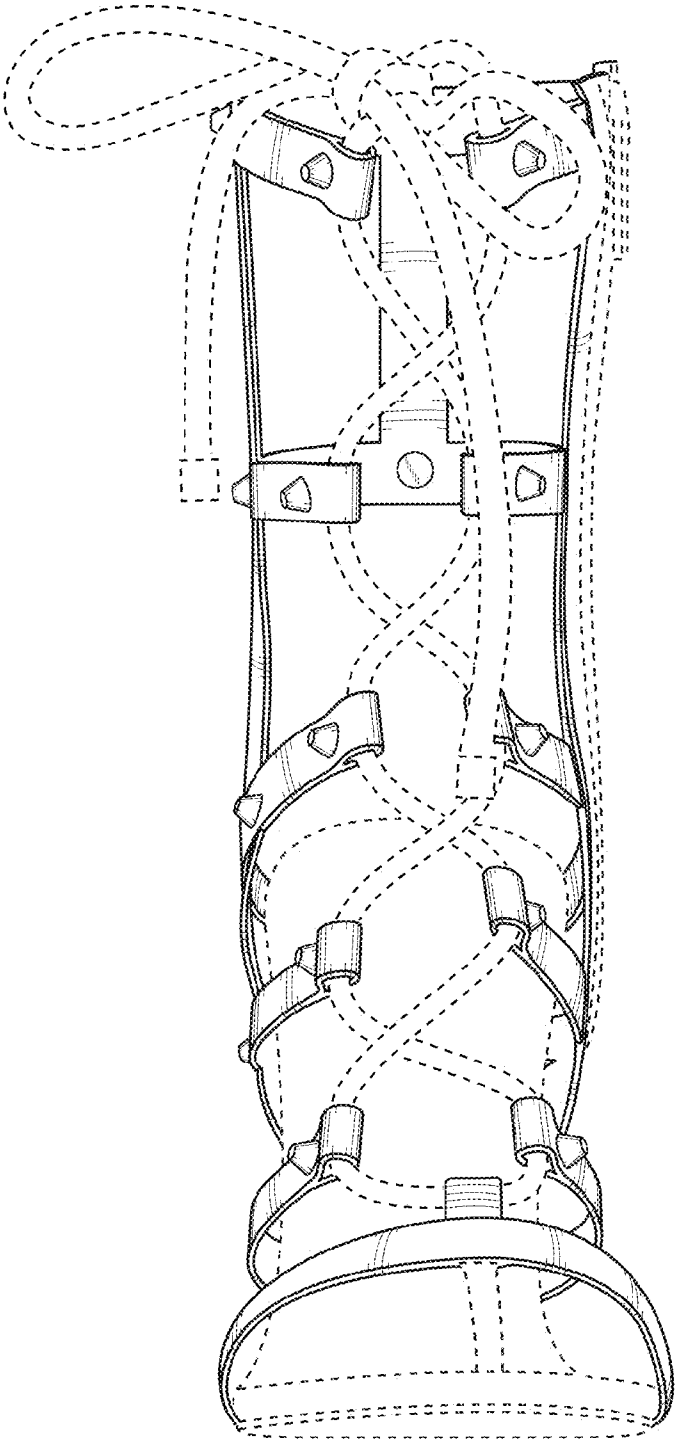

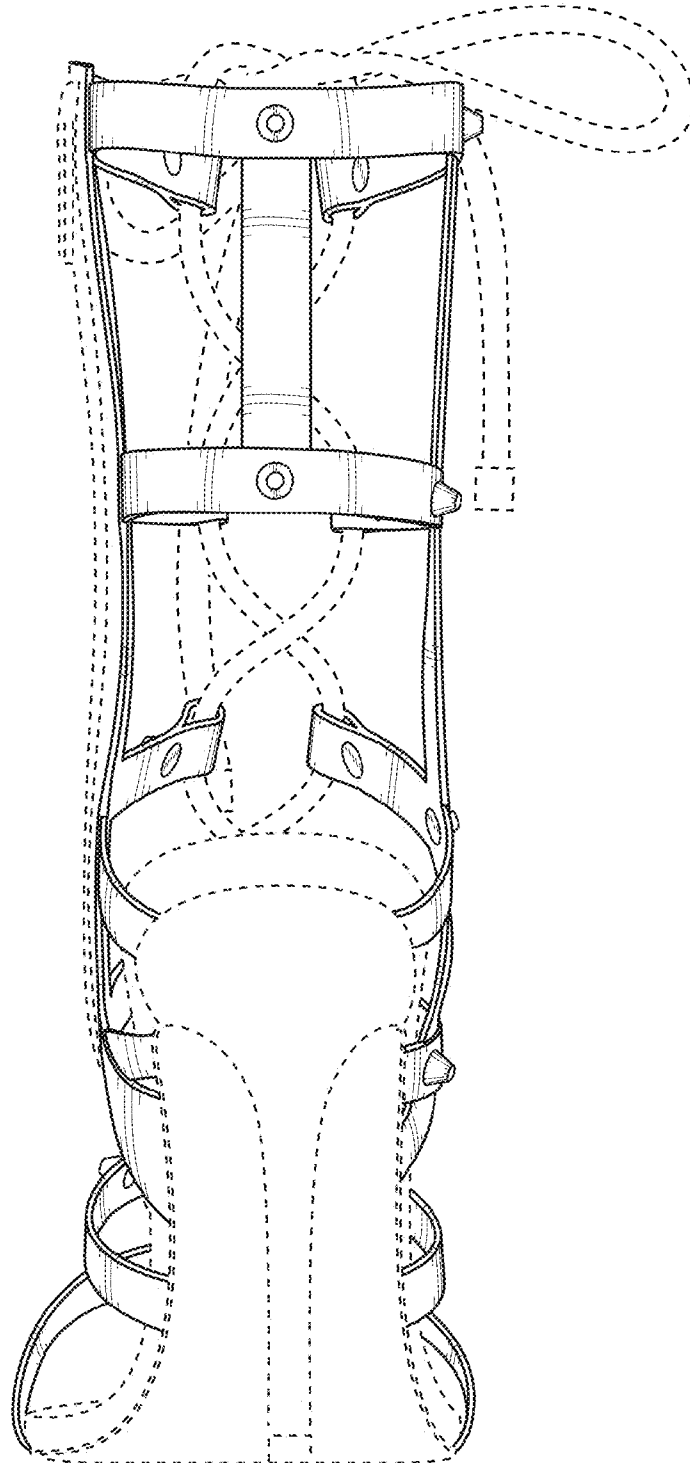

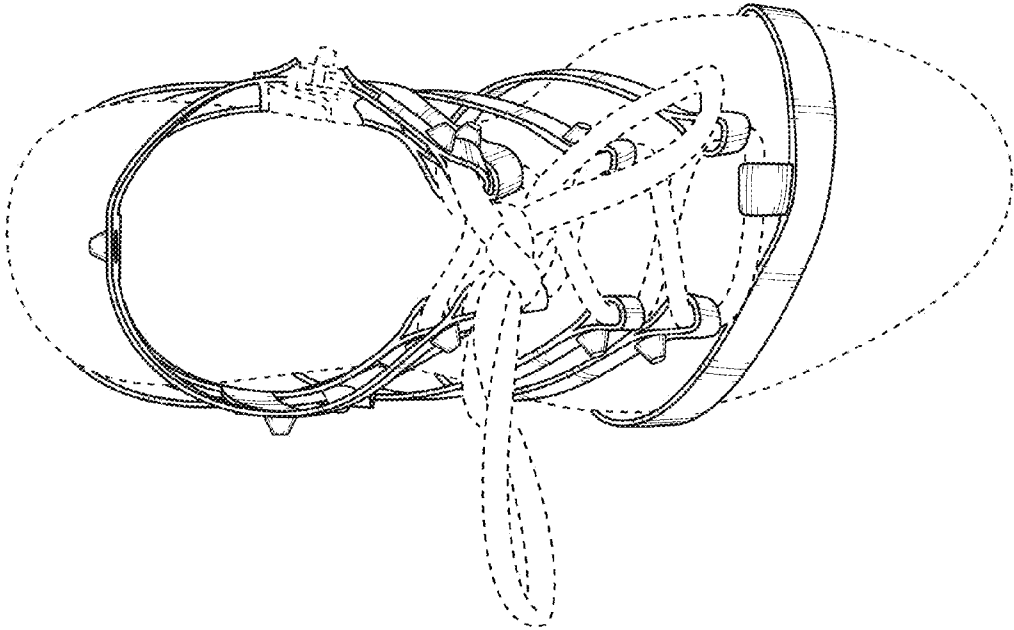

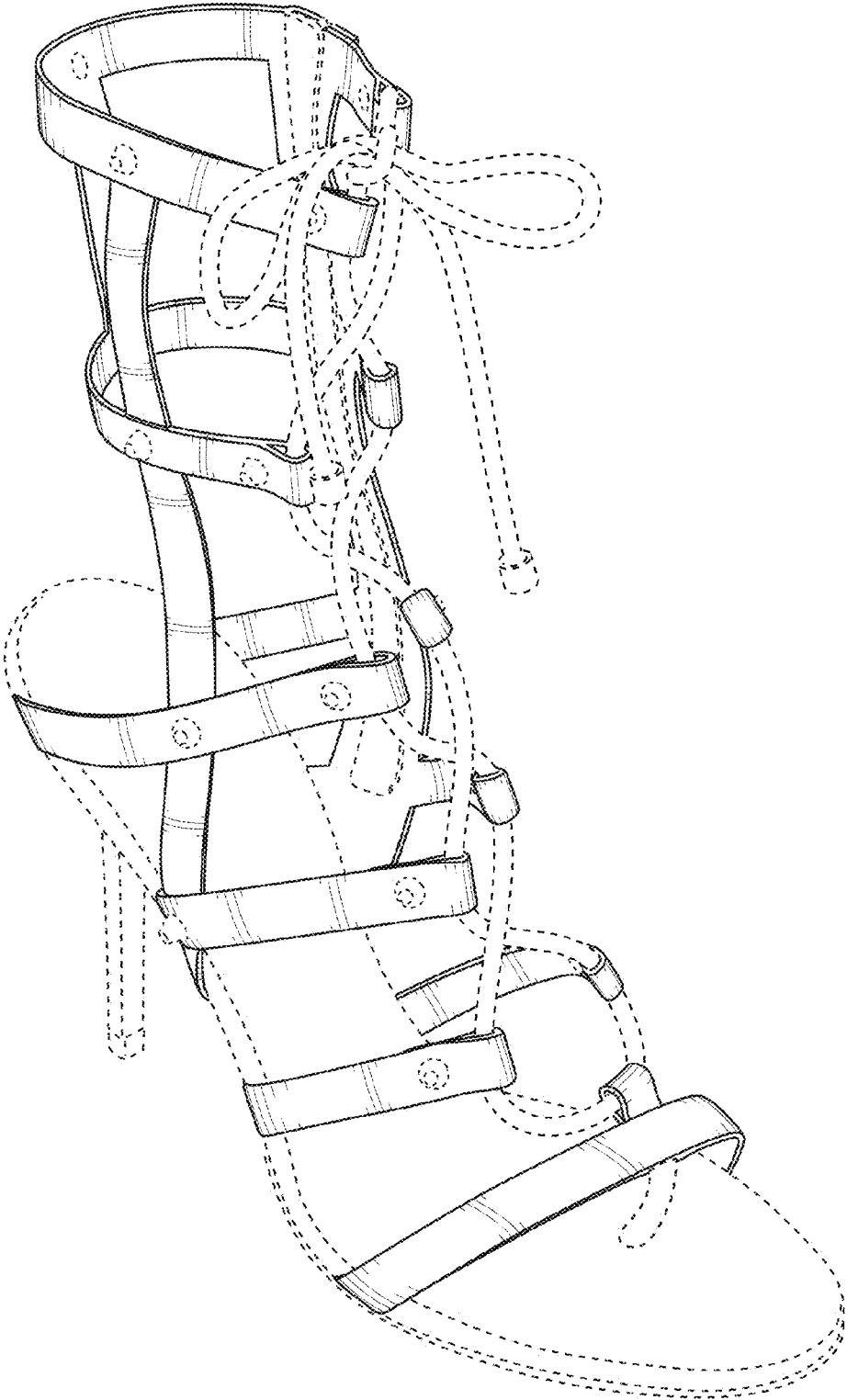

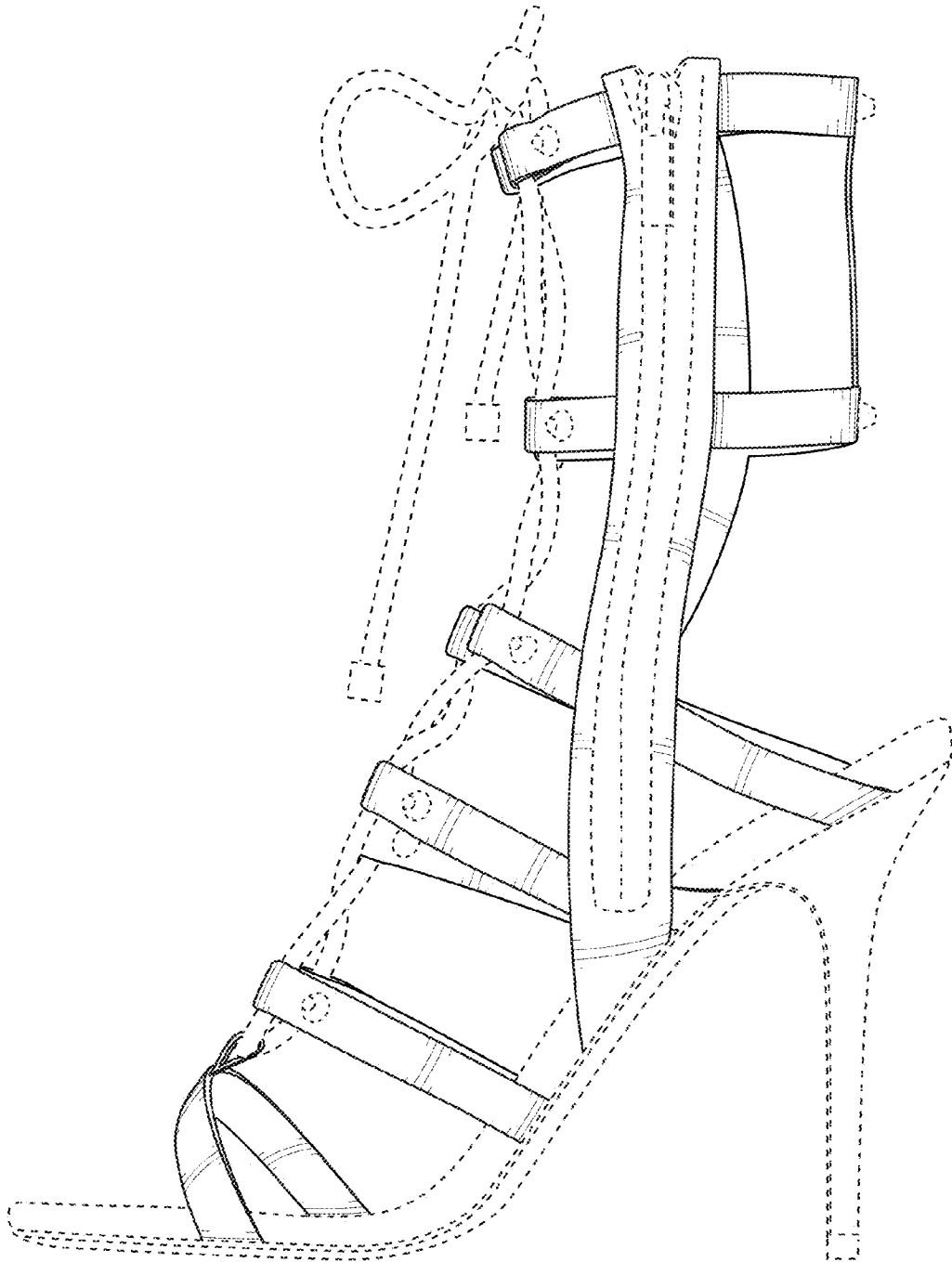

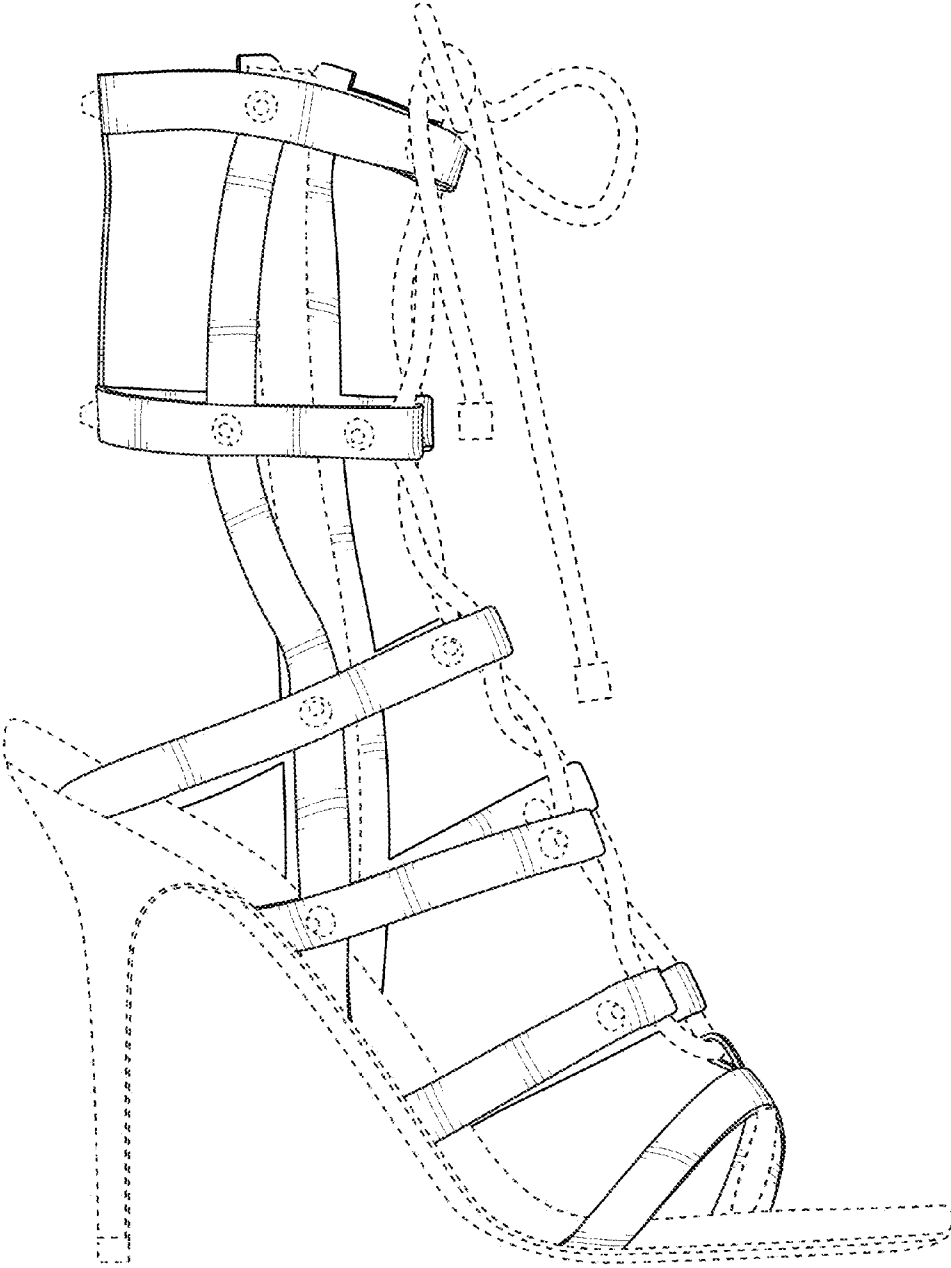

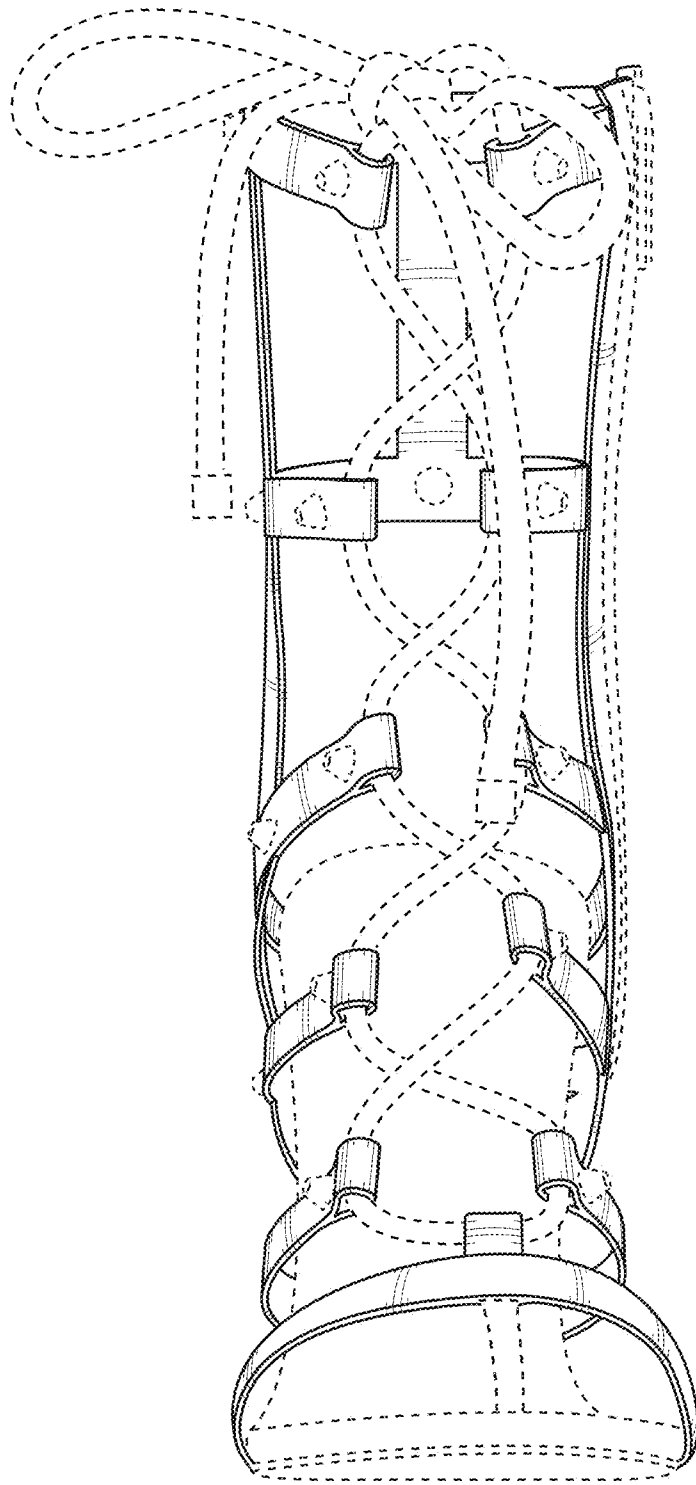

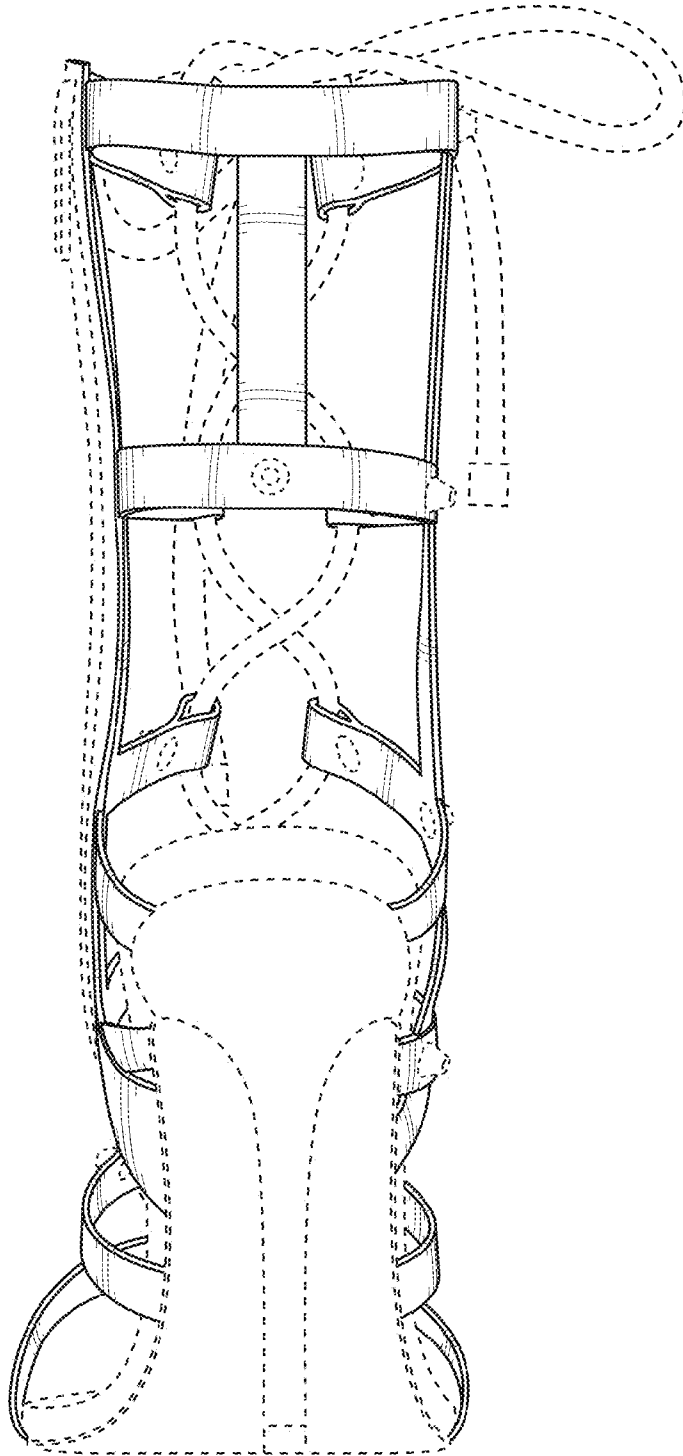

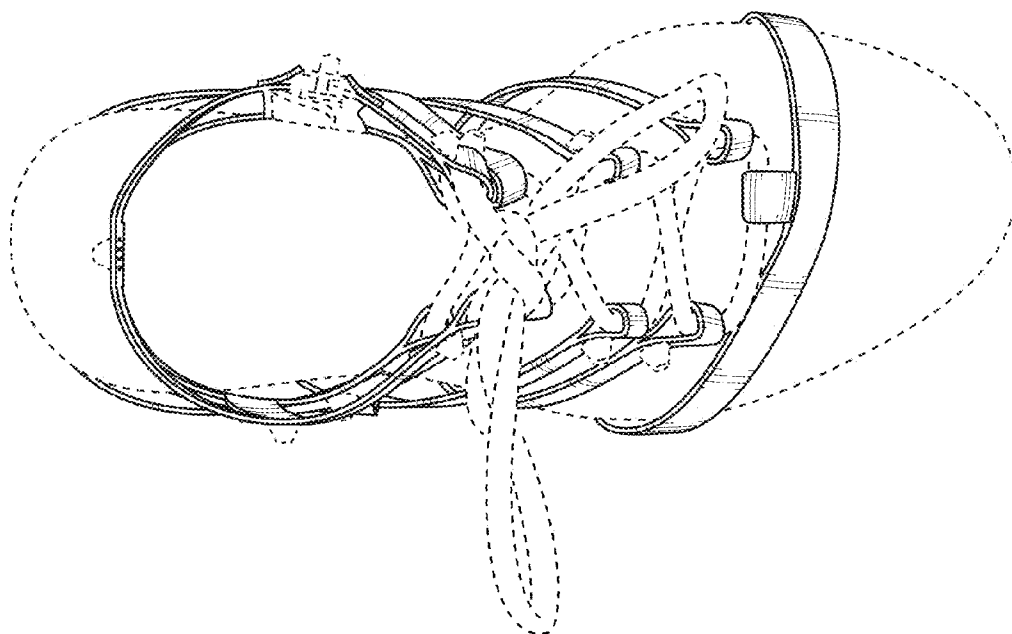
