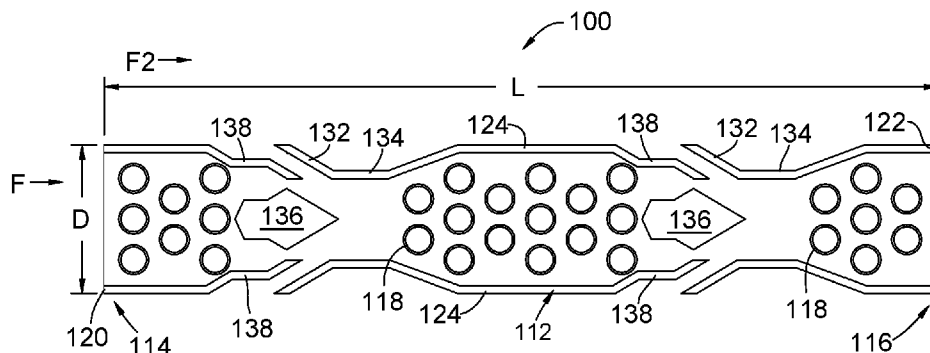

(57) Abstract: A heat exchanger apparatus includes: a shell extending over a flow length from an inlet at a upstream end to an outlet at a downstream end, and defining a first flowpath for a first fluid; a structure disposed within the shell defining a second flowpath for a second fluid; at least one secondary inlet in the shell disposed downstream from the upstream end; and a nozzle disposed downstream of the inlet.
