

ATTACHMENT FOR SIDE-WALL REGISTERS.

The Schedule referred to in these Letters Patent and making part of the same

To all whom it may concern:

Be it known that I, J. M. W. KITCHEN, of Brooklyn, in the county of Kings, and State of New York, have invented a new and improved Attachment for Side-Wall Registers; and I do hereby declare that the following is a full, clear, and exact description thereof, which will enable others skilled in the art to make and use the same, reference being had to the accompanying drawings, forming part of this specification, in which—

Figure 1 is a vertical section of a side-wall register, to which my improvement has been attached.

Figure 2 is a front view of the same.

Similar letters of reference indicate corresponding

parts.

My invention has for its object to furnish an improved attachment for side-wall registers, to enable people to conveniently warm their feet at such registers, and which shall be so constructed and arranged that when not required for use it may be closed up so as to be out of the way, and so as not to disfigure the register.

And it consists in the combination of a foot-rest with an ordinary side-wall register, as hereinafter more

fully described.

A represents the wall of a room.

B represents a side-wall register, which is set in the wall A, and through which the heat is admitted into the room in the ordinary manner.

C is a foot-rest, which in the drawings is represented as being hinged or pivoted to the frame of the regis-

ter B, so that when required for use, it may be opened or turned down, as shown in fig. 1, to support the feet while being warmed.

In this case, the body of the foot-rest C should be so formed as to correspond with the register B, so that when turned up against said register, it may correspond with it, and show no indication of its presence.

The particular manner in which the foot-rest C is connected with the register B is immaterial, as it may be pivoted to said register in very many different ways, or may slide in or into grooves or recesses in said register, or may be detachably hooked upon said register, as may be desired or convenient.

In the case of registers already placed in the wall, or ready to be so placed, the latter construction would

be preferable.

Having thus described my invention,

I claim as new, and desire to secure by Letters

The combination of a foot-rest with a side-wall register, whether said foot-rest be pivoted or sliding, or whether it be permanently or detachably connected with said register, substantially as herein shown and described and for the purpose set forth.
