(57) Abstract: A protective coating composition comprises (a) a first component comprising one or more epoxy-terminated silane compounds, (b) a second component comprising one or more fluorochemical silane compounds, and (c) cationic photoinitiator. The first component comprises at least about 50% by weight of the composition.
