The ornamental design for a bottle, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of a bottle showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a side elevational view thereof, taken from the right hand side of FIG. 4; and,

FIG. 7 is a side elevational view thereof, taken from the left hand side of FIG. 4.
