(57) **CLAIM**

The ornamental design of the combined fanciful colander and bowl, as shown and described.

FIG. 1 is a perspective view of the present invention and which shows a fanciful colander which is resting on, and within a corresponding bowl.

FIG. 2 is a side elevation view of the present invention as seen in FIG. 1.

FIG. 3 is a second side elevation view of the invention as seen in FIG. 1 and which is taken from a position which is approximately 180° offset from that seen in FIG. 2.

FIG. 4 is a top plan view of the present invention as seen in FIG. 1.

FIG. 5 is a bottom plan view of the invention as seen in FIG. 1.

FIG. 6 is a perspective, side elevation view of the fanciful colander which forms a feature of the present invention.

FIG. 7 is a perspective, bottom plan view of the fanciful colander which forms a feature of the present invention.

FIG. 8 is a side elevation view of the fanciful colander which forms a feature of the present invention.

FIG. 9 is a second side elevation view of the fanciful colander which forms a feature of the present invention, and which is taken from a position 180° offset from that seen in FIG. 8.

FIG. 10 is a top plan view of the fanciful colander which forms a feature of the present invention.

FIG. 11 is a bottom plan view of the fanciful colander which forms a feature of the present invention.


FIG. 12 is a perspective, side elevation view of the bowl which forms a feature of the present invention.

























