[57] CLAIM

The ornamental design for a shoe midsole, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of one side of a shoe midsole showing my new design;

FIG. 2 is a side elevational view of the other side of the shoe midsole shown in FIG. 1;

FIG. 3 is a front elevational view of the shoe midsole shown in FIG. 1;

FIG. 4 is a rear elevational view of the shoe midsole shown in FIG. 1;

FIG. 5 is a cross sectional view taken along line 5—5 in FIG. 1:

FIG. 6 is a partial cross section taken along line 6—6 in

FIG. 1; FIG. 7 is a partial cross section taken along line 7—7 in

FIG. 1; FIG. 8 is a partial cross section taken along line 8—8 in

FIG. 1;

FIG. 9 is a partial cross section taken along line 9—9 in FIG. 2;

FIG. 10 is a partial cross section taken along line 10—10 in FIG. 2; and,

FIG. 11 is a partial cross section taken along line 11—11 in FIG. 2.
