(57) **CLAIM**

The ornamental design for a display screen with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first image in a sequence for a display screen with an animated graphical user interface showing the claimed design.

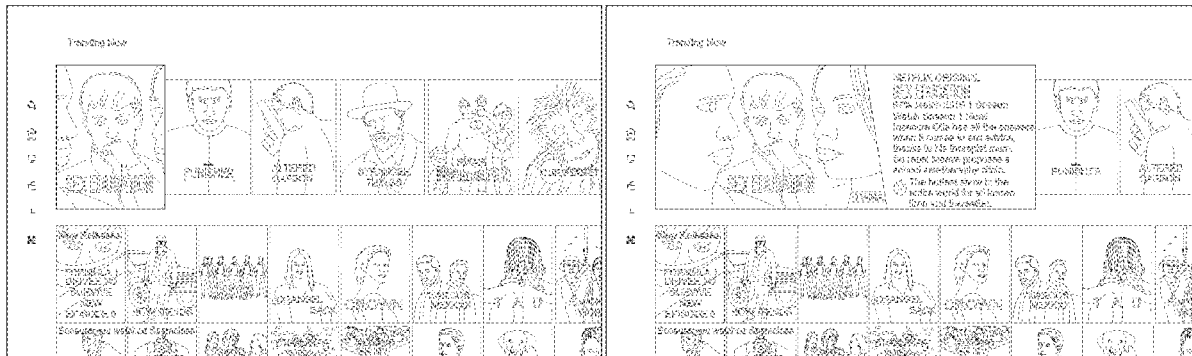
FIG. 2 is a front view of a second image thereof;

FIG. 3 is a front view of a third image thereof; and,

FIG. 4 is a front view of a fourth image thereof.

The appearance of the animated graphical user interface sequentially transitions between the images shown in FIGS. 1-4. The process or period in which an image transitions to another forms no part of the claimed design. The broken lines shown throughout the figures depict features excluded from the claim.

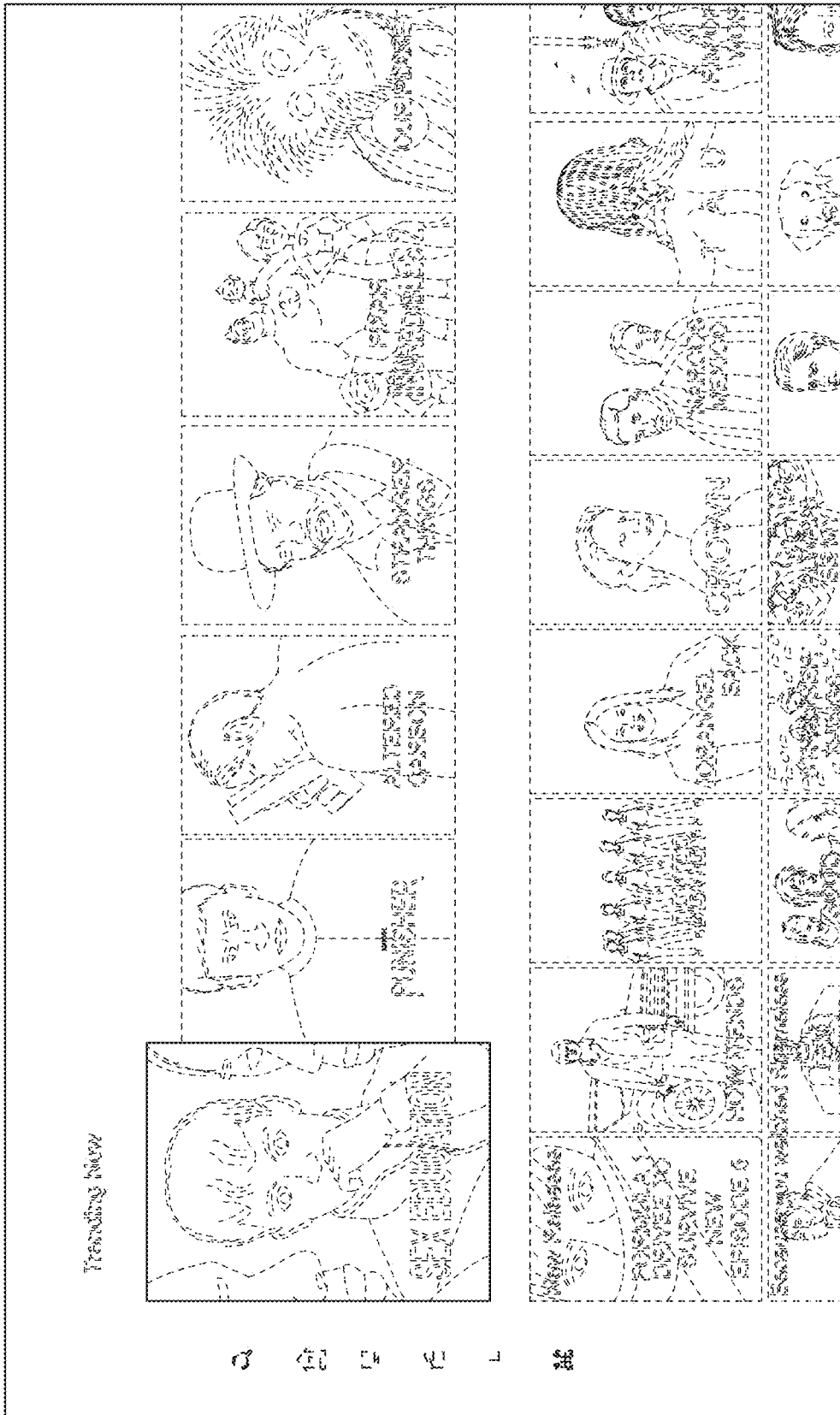

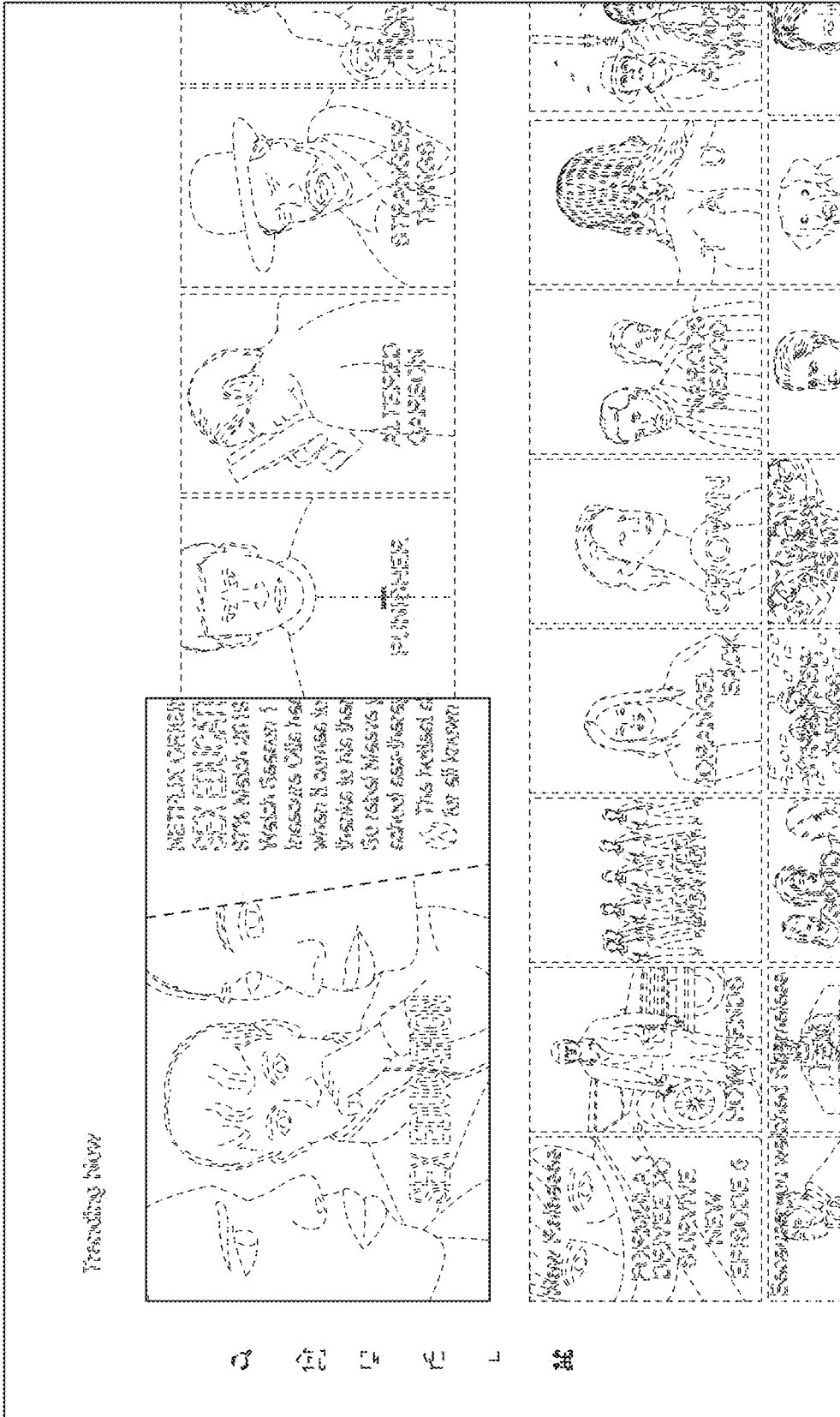
