DESCRIPTION

FIG. 1 is an enlarged perspective view of the front side of a fabric.

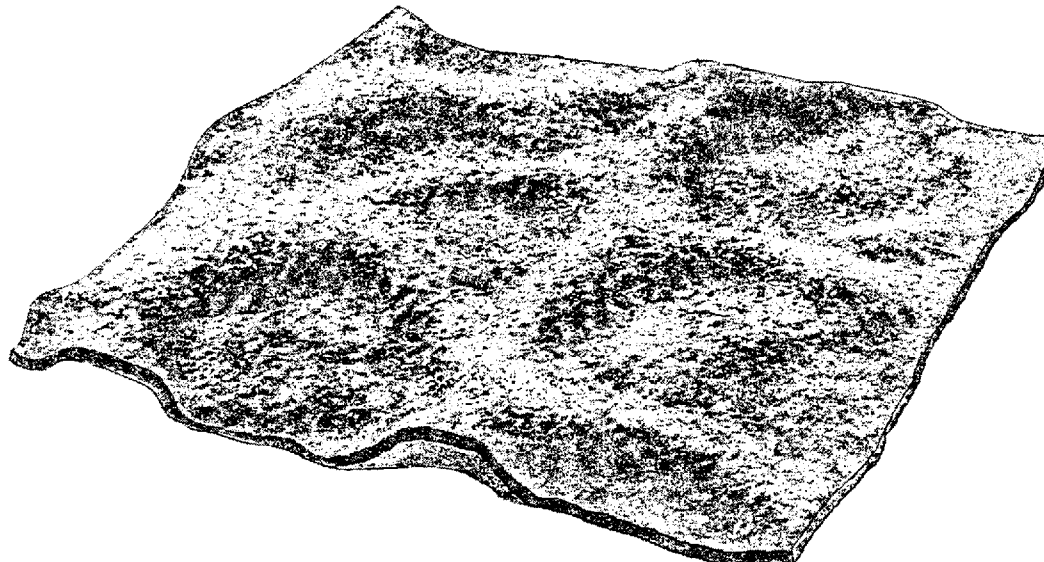
FIG. 2 is a perspective view of the front side of an actual size of fabric.

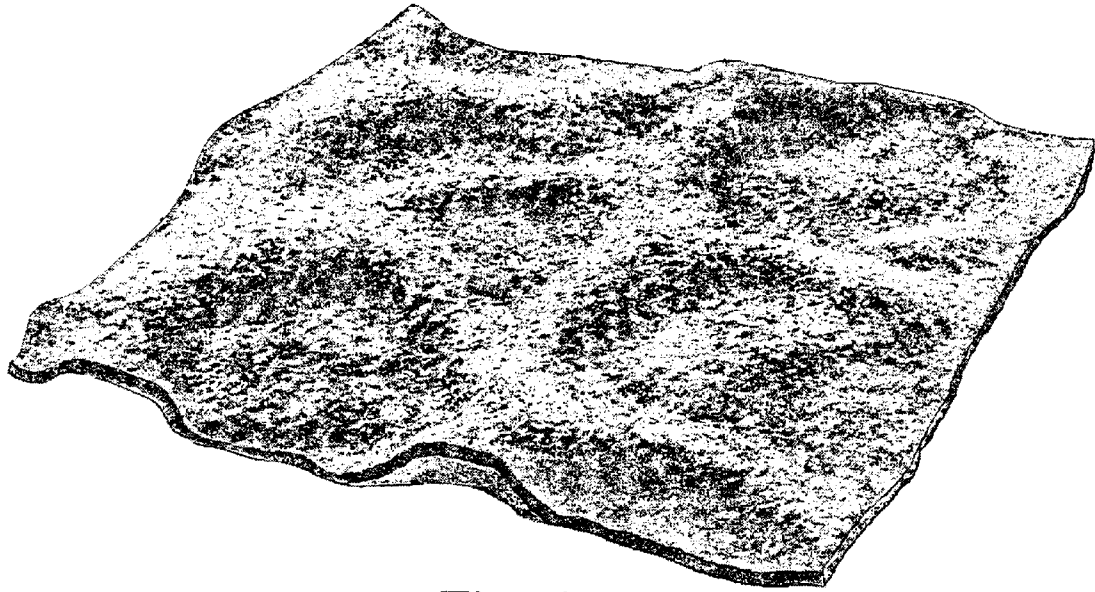

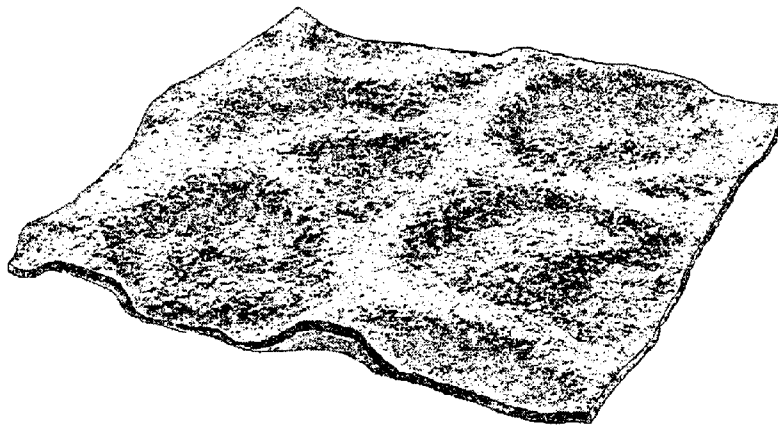
