
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the manual envelope sealer. FIG. 2 is a front view of the manual envelope sealer of FIG. 1. FIG. 3 is a rear view of the manual envelope sealer of FIG. 1. FIG. 4 is a top view of the manual envelope sealer of FIG. 1. 










