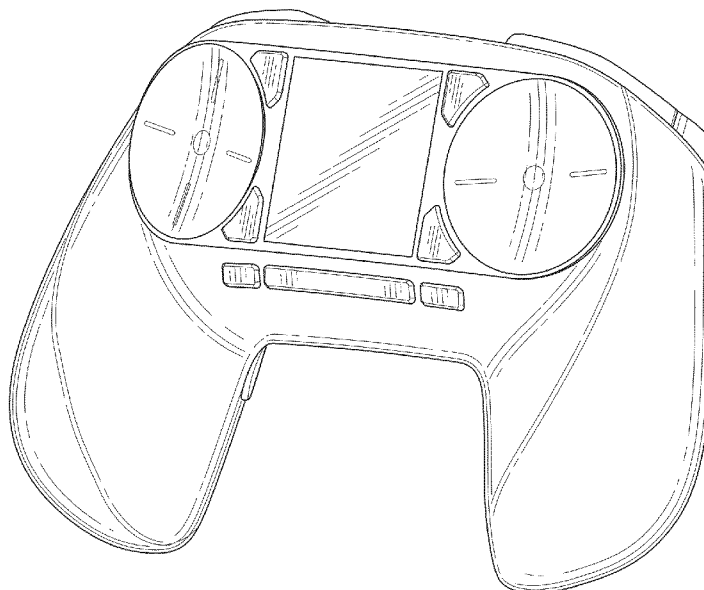
**CLAIM**

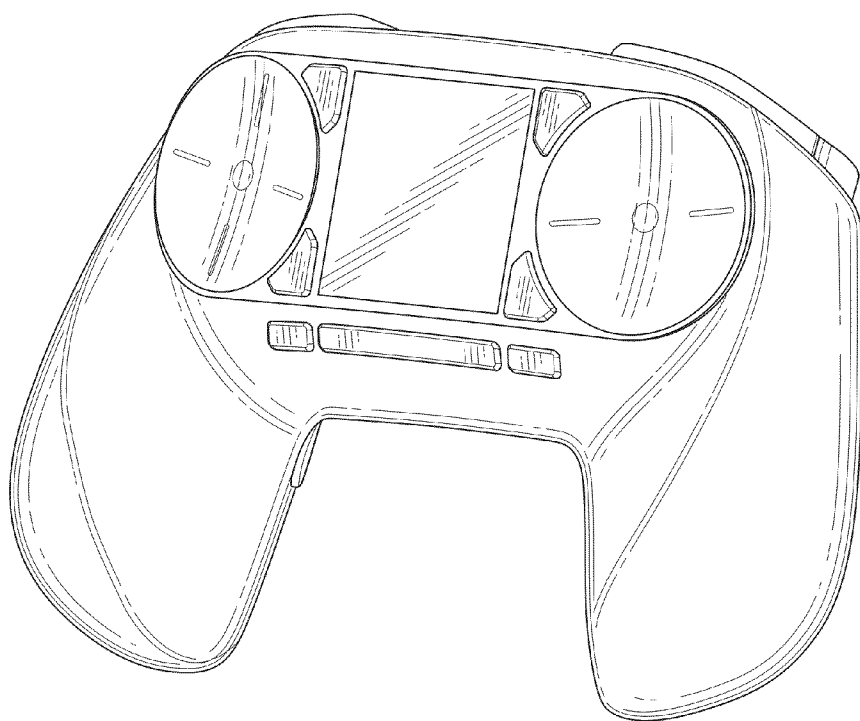

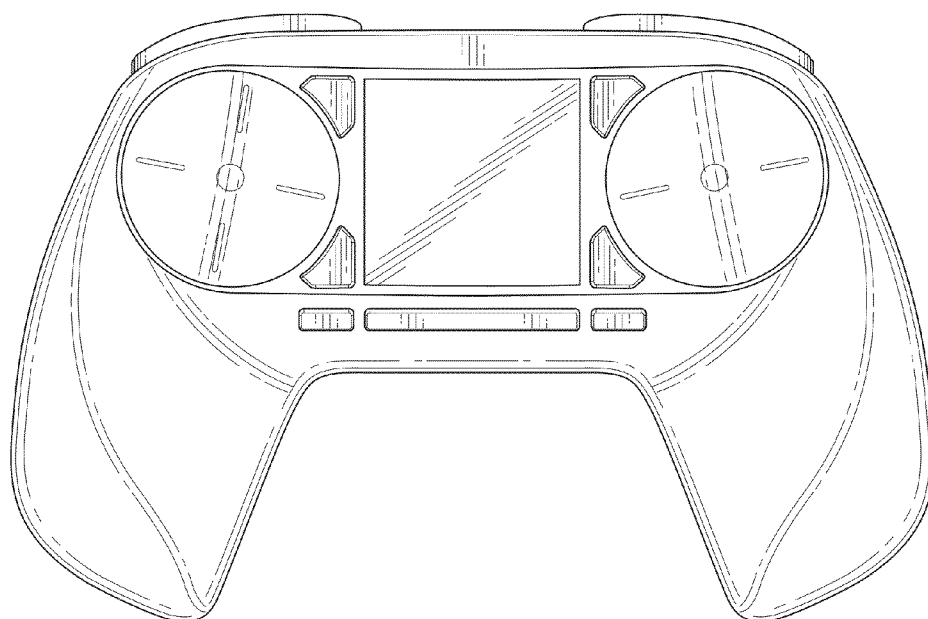

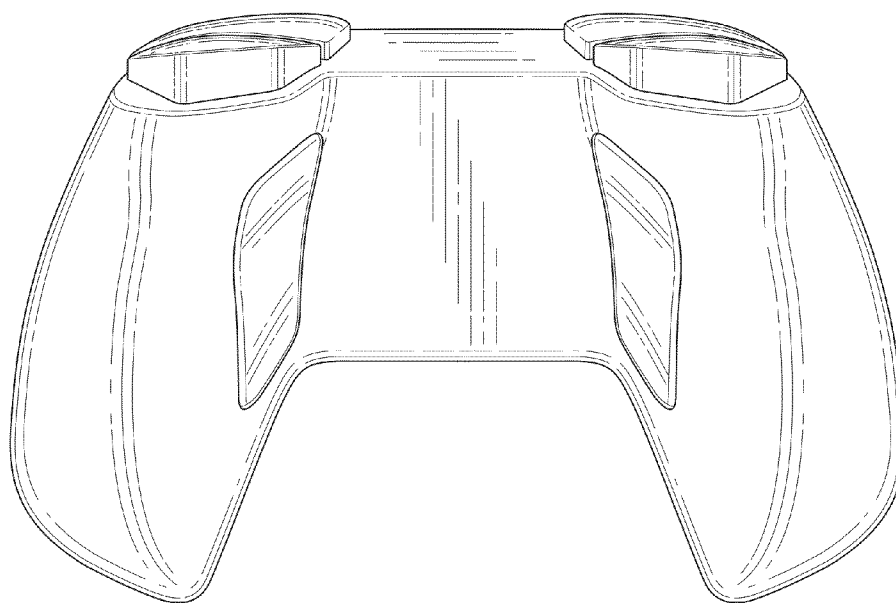

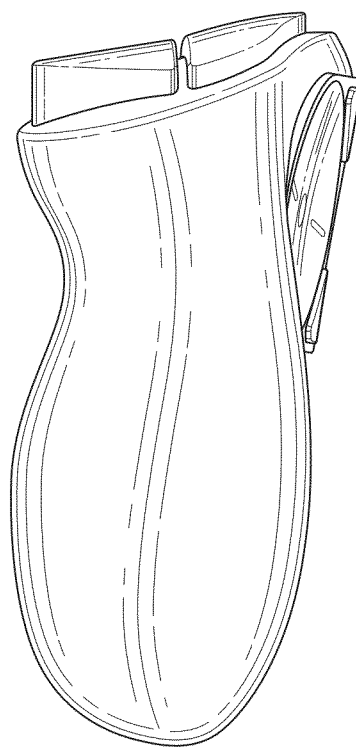

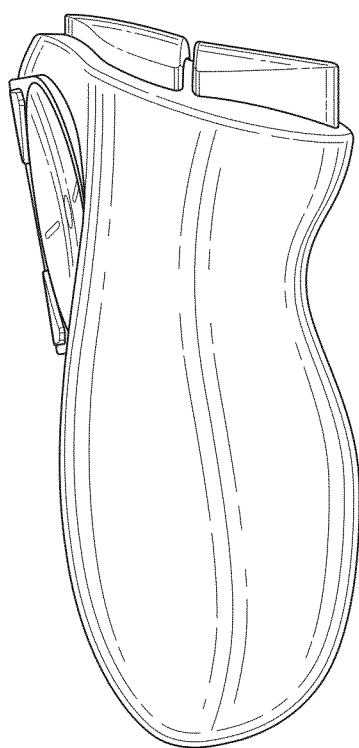

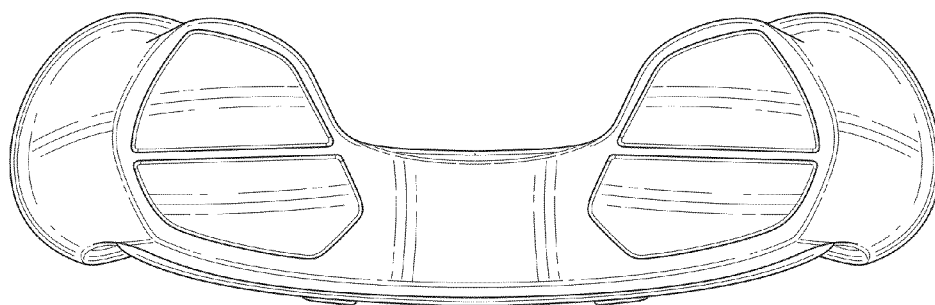

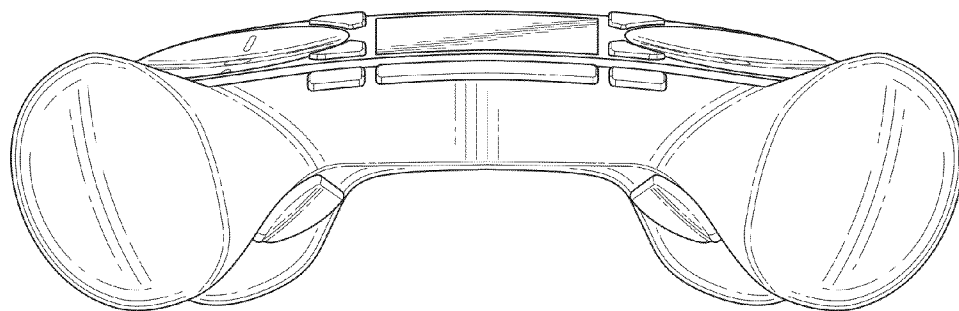
