
(57) **CLAIM**

The ornamental design for an ink cartridge, as shown and described herein.

**DESCRIPTION**

FIG. 1 is a front, top, and left side perspective view of an ink cartridge;  
FIG. 2 is a rear, top, and right side perspective view thereof;  
FIG. 3 is another rear, top, and right side perspective view thereof;  
FIG. 4 is a rear, bottom, and right side perspective view thereof;




















