(57) **CLAIM**

The ornamental design for a correction roller, as shown and described.

**DESCRIPTION**

FIG. 1 is a front left perspective view of the correction roller (shown with the front portion extended and the tip in broken lines) according to the new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a left elevation view thereof;

FIG. 7 is a right elevation view thereof;

FIG. 8 is a front left perspective view of the correction roller (shown with the front portion in an alternate folded position) according to the new design;

FIG. 9 is a front elevation view thereof;

FIG. 10 is a rear elevation view thereof;

FIG. 11 is a top plan view thereof;

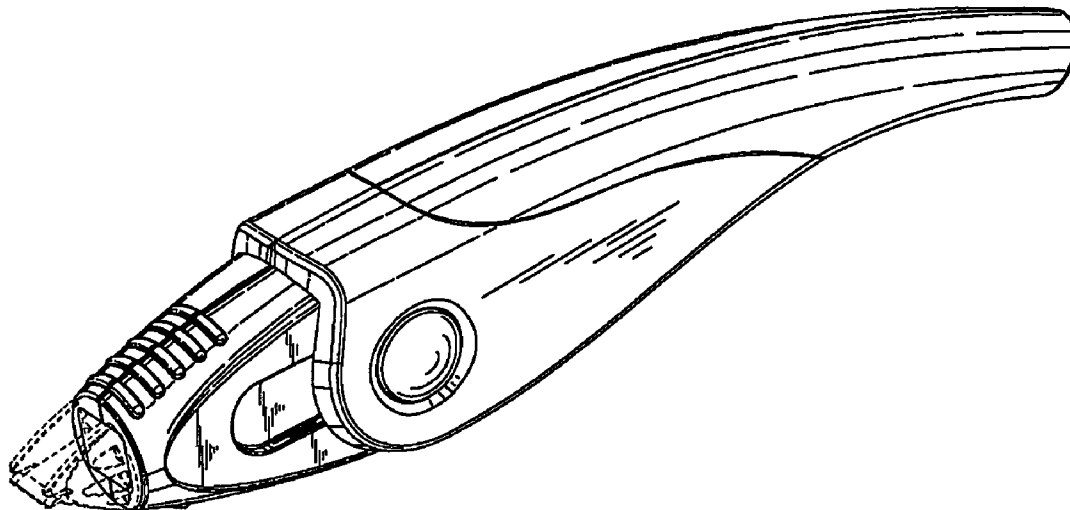
FIG. 12 is a bottom plan view thereof (shown with the tip in broken lines);

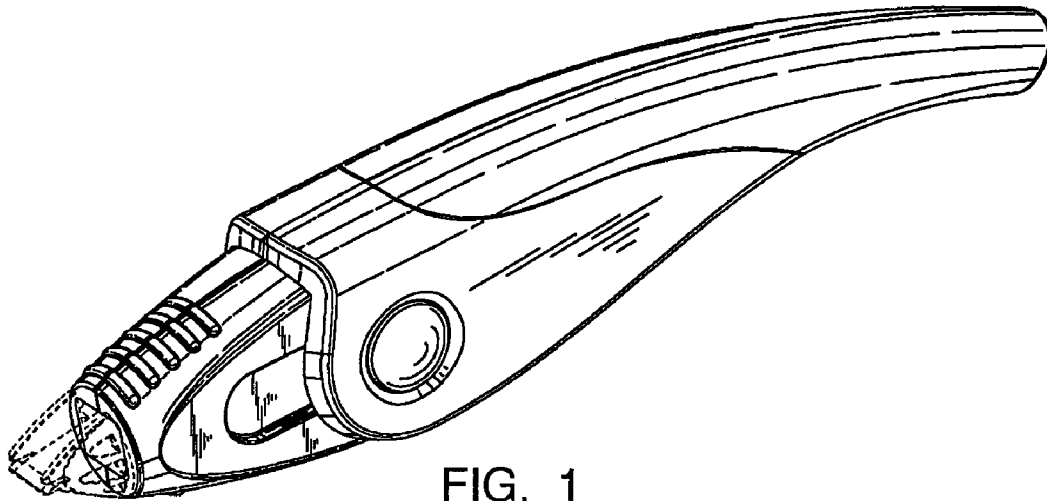

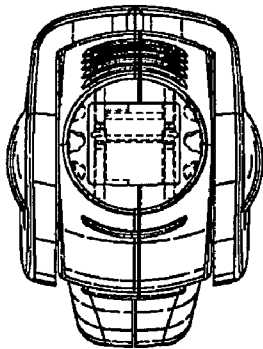

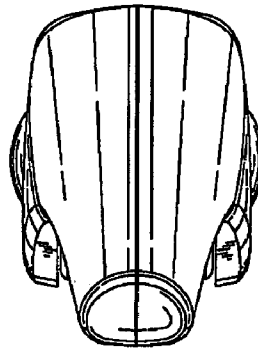

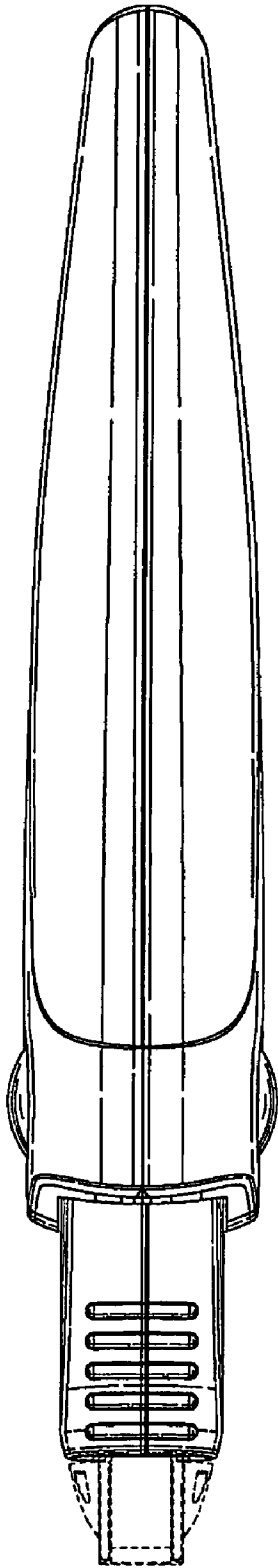

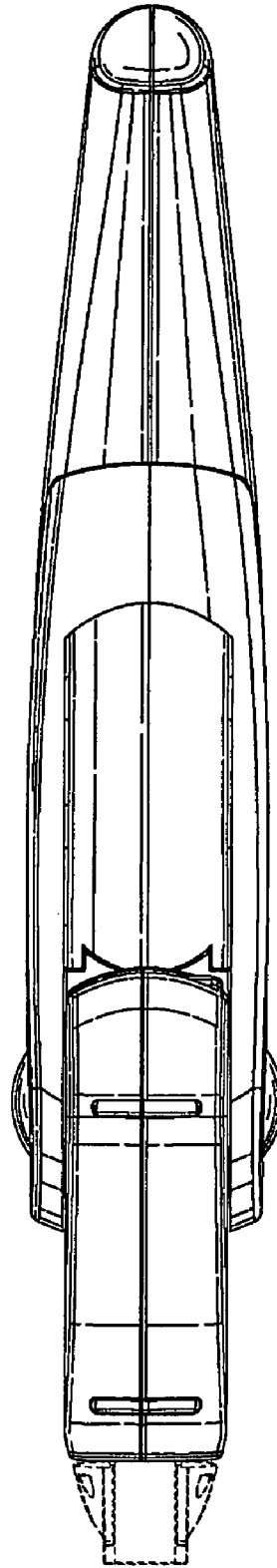

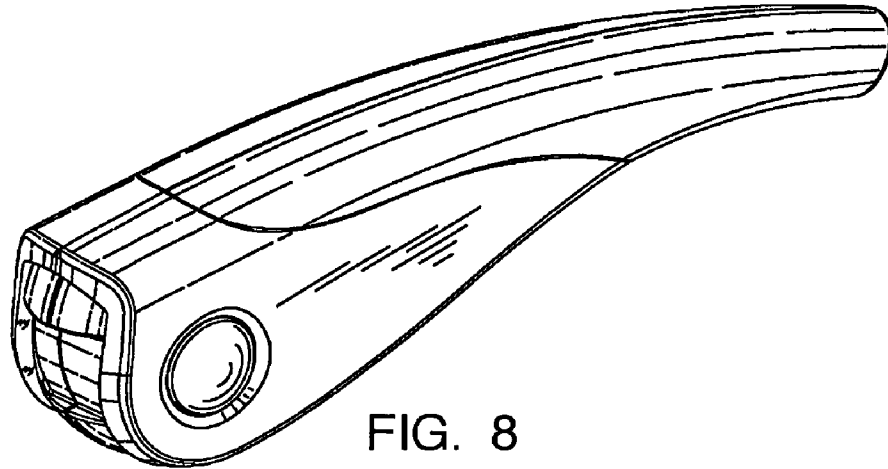

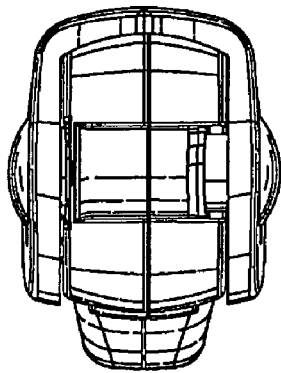

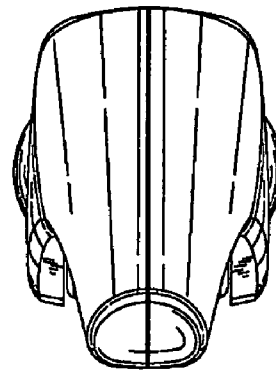

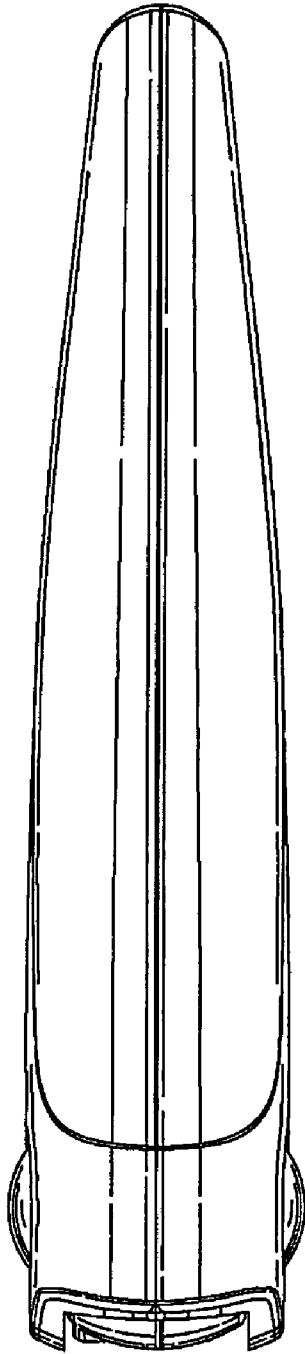

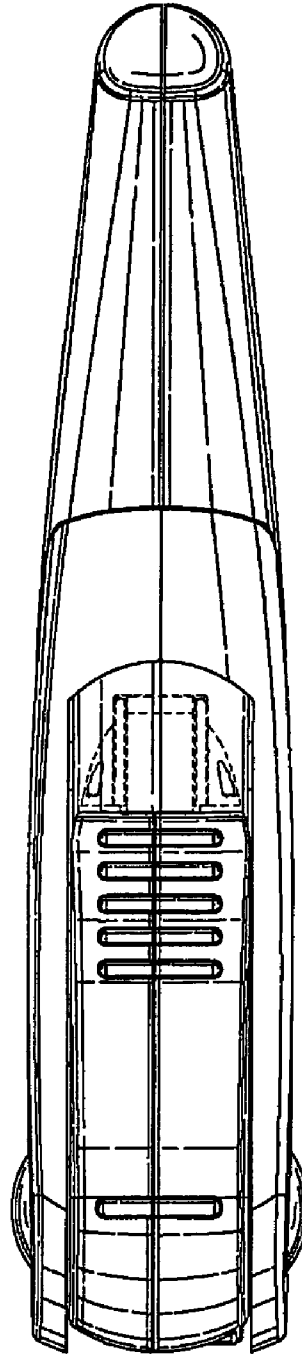

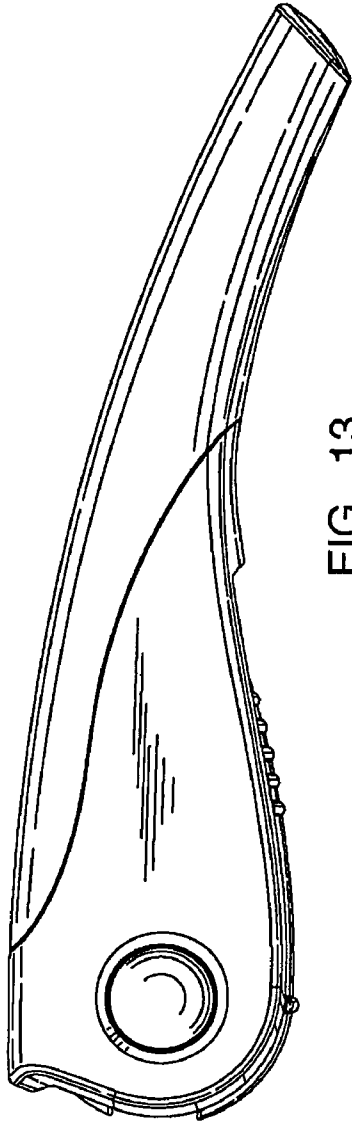

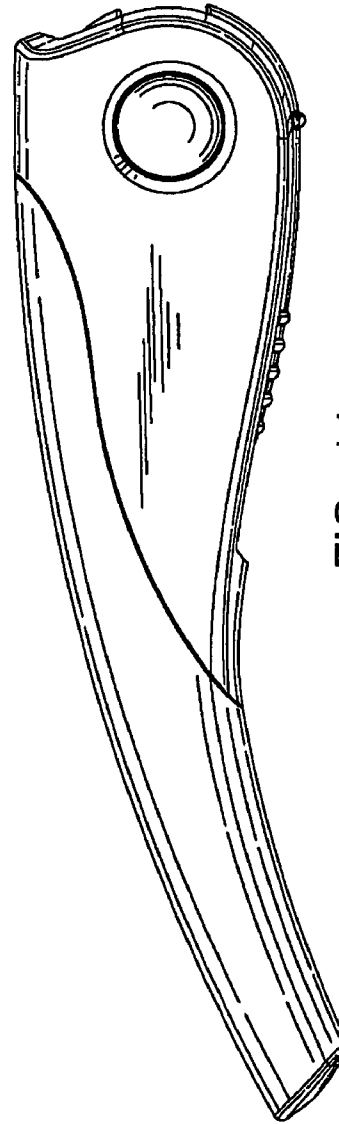
