FIG. 1 is a top view of a sewage septic tank showing our new design;

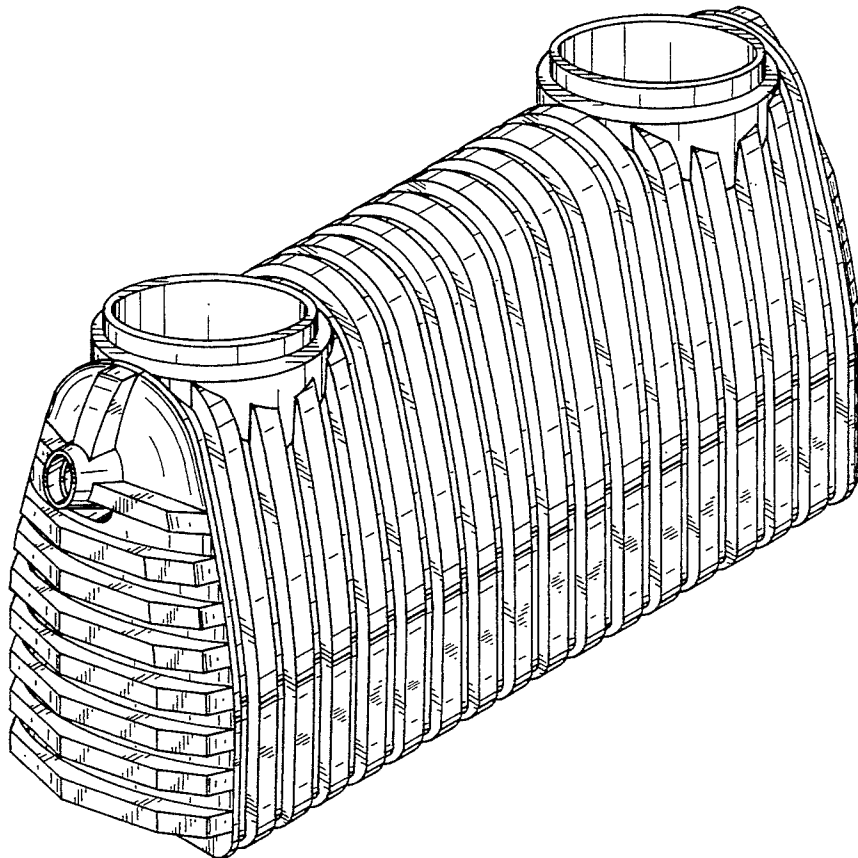
FIG. 2 is a bottom view of the tank;

FIG. 6 is a perspective view of the tank.



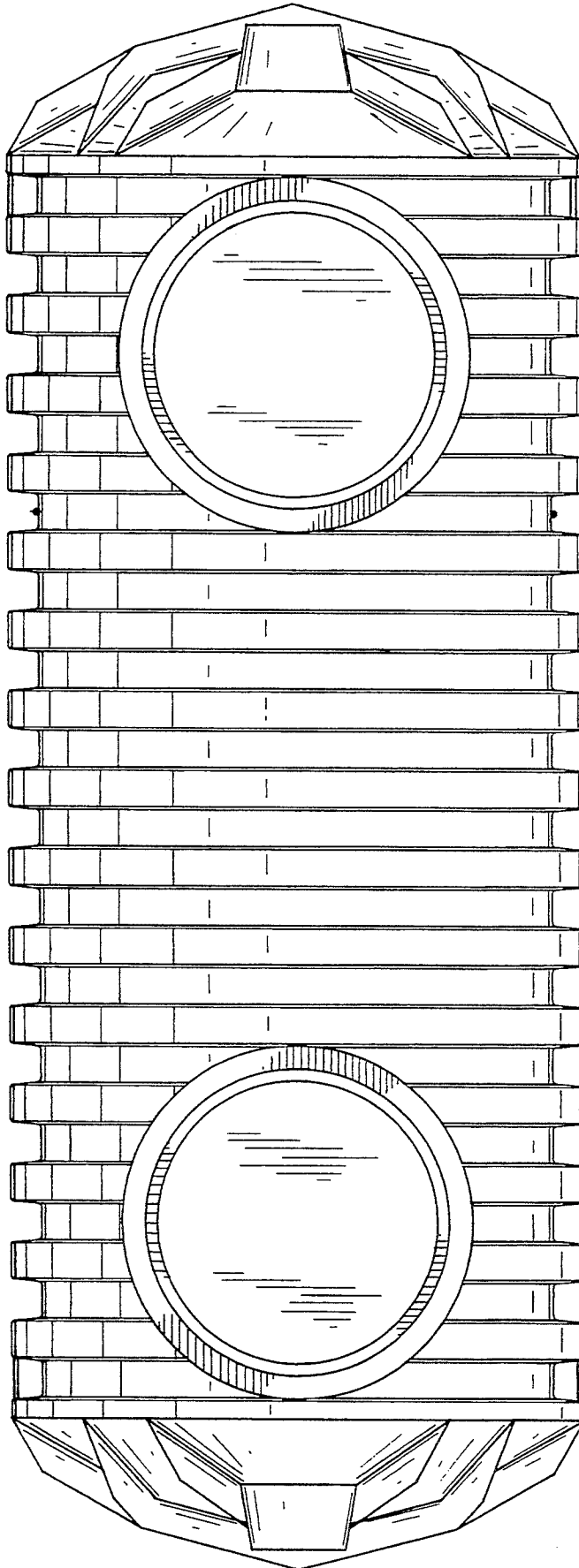

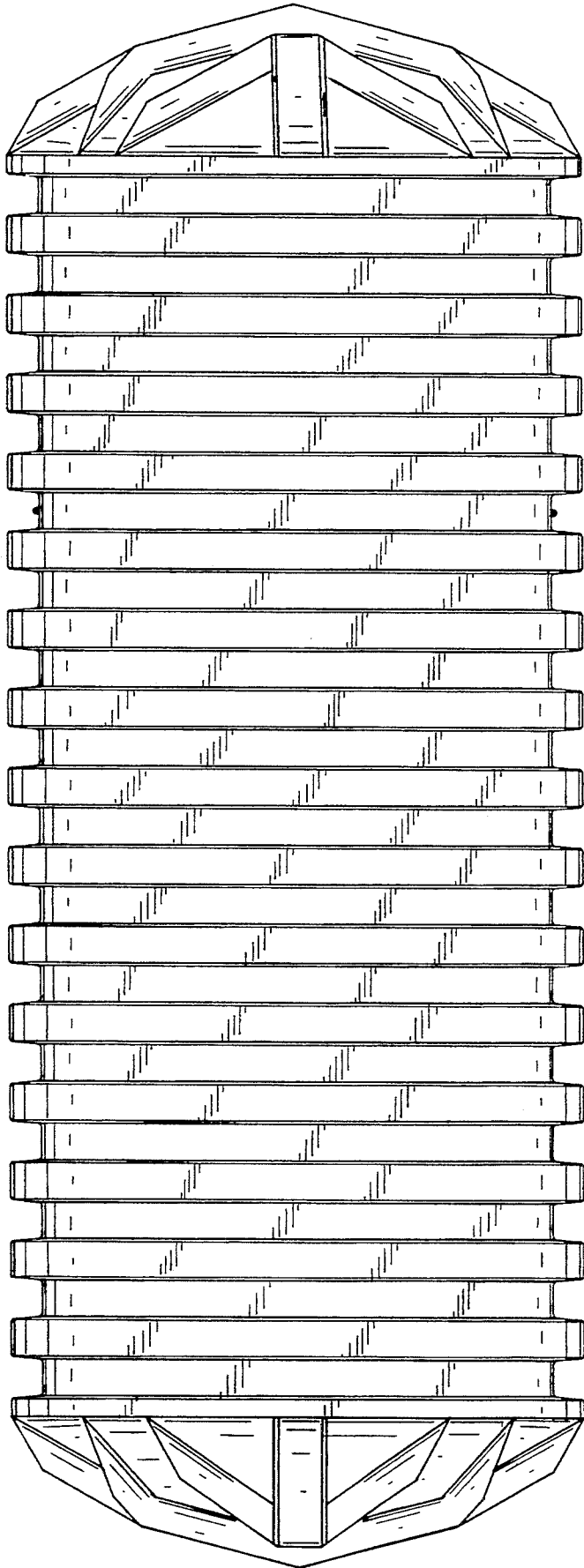

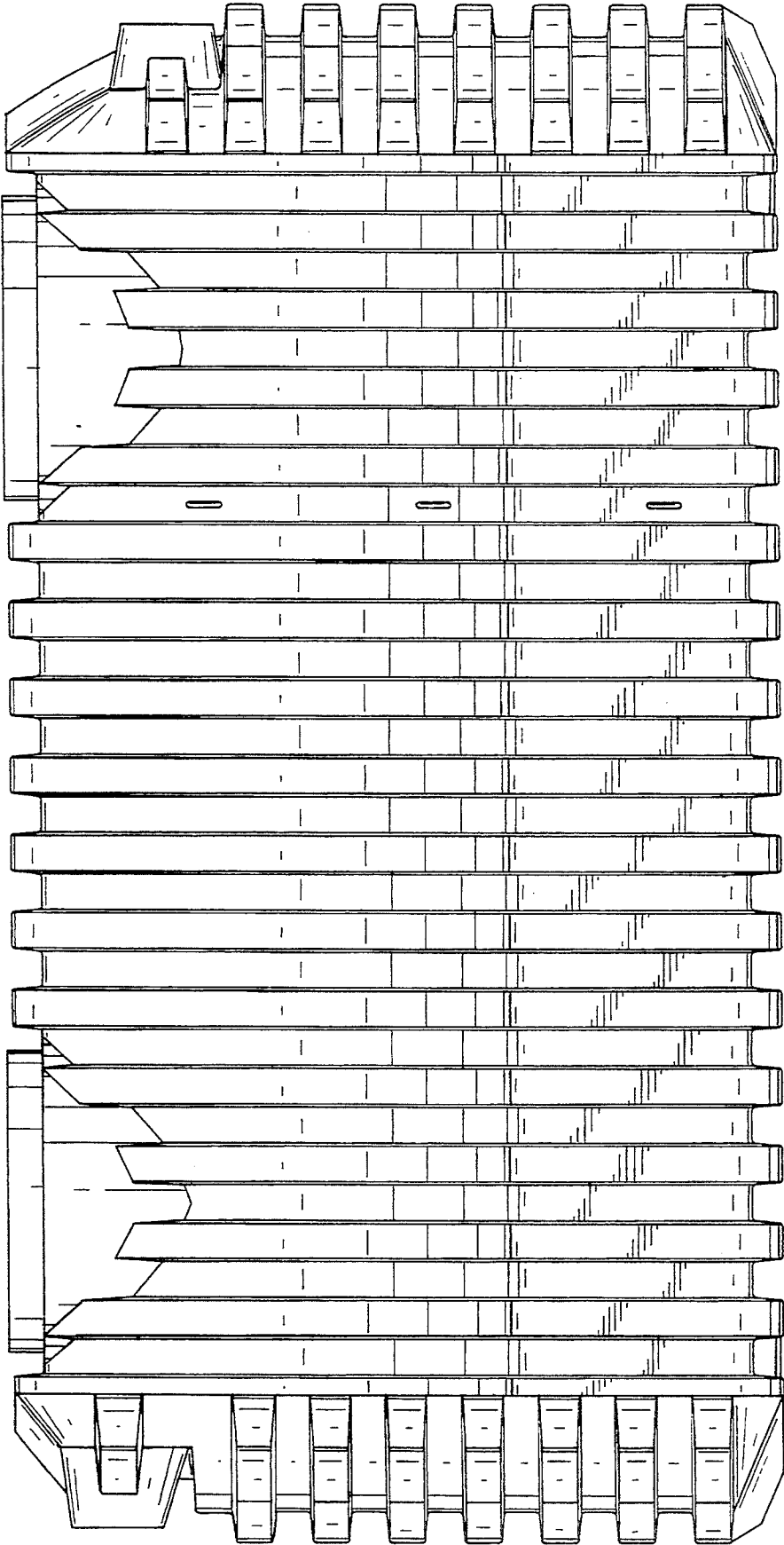

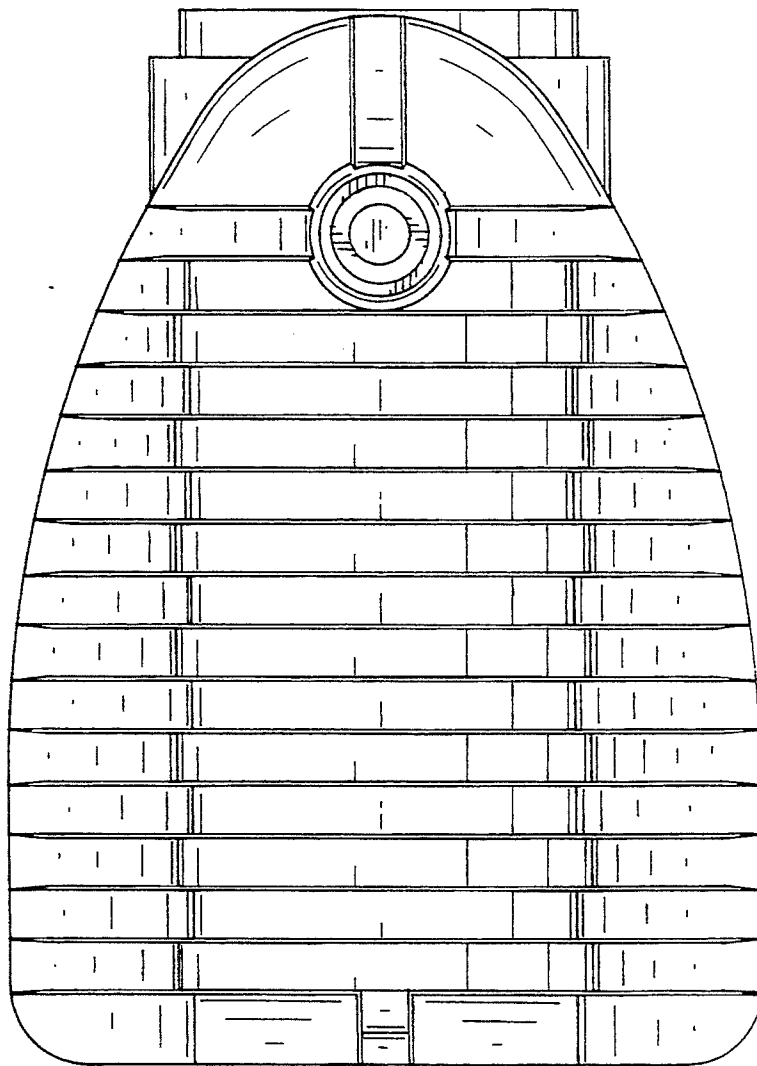

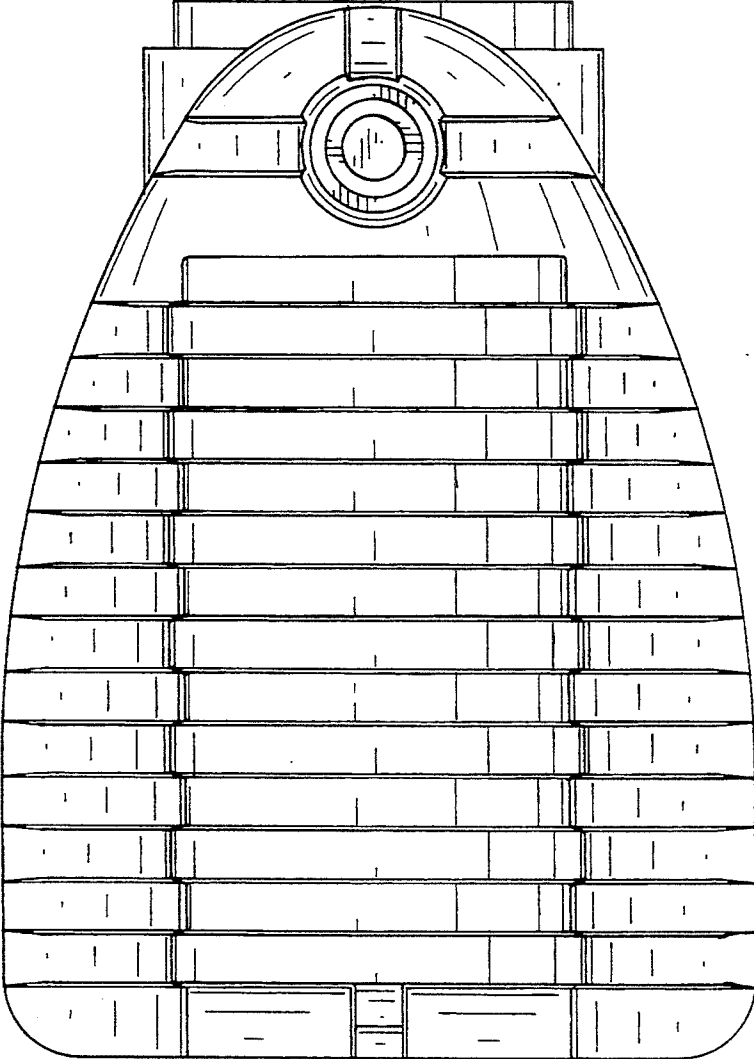

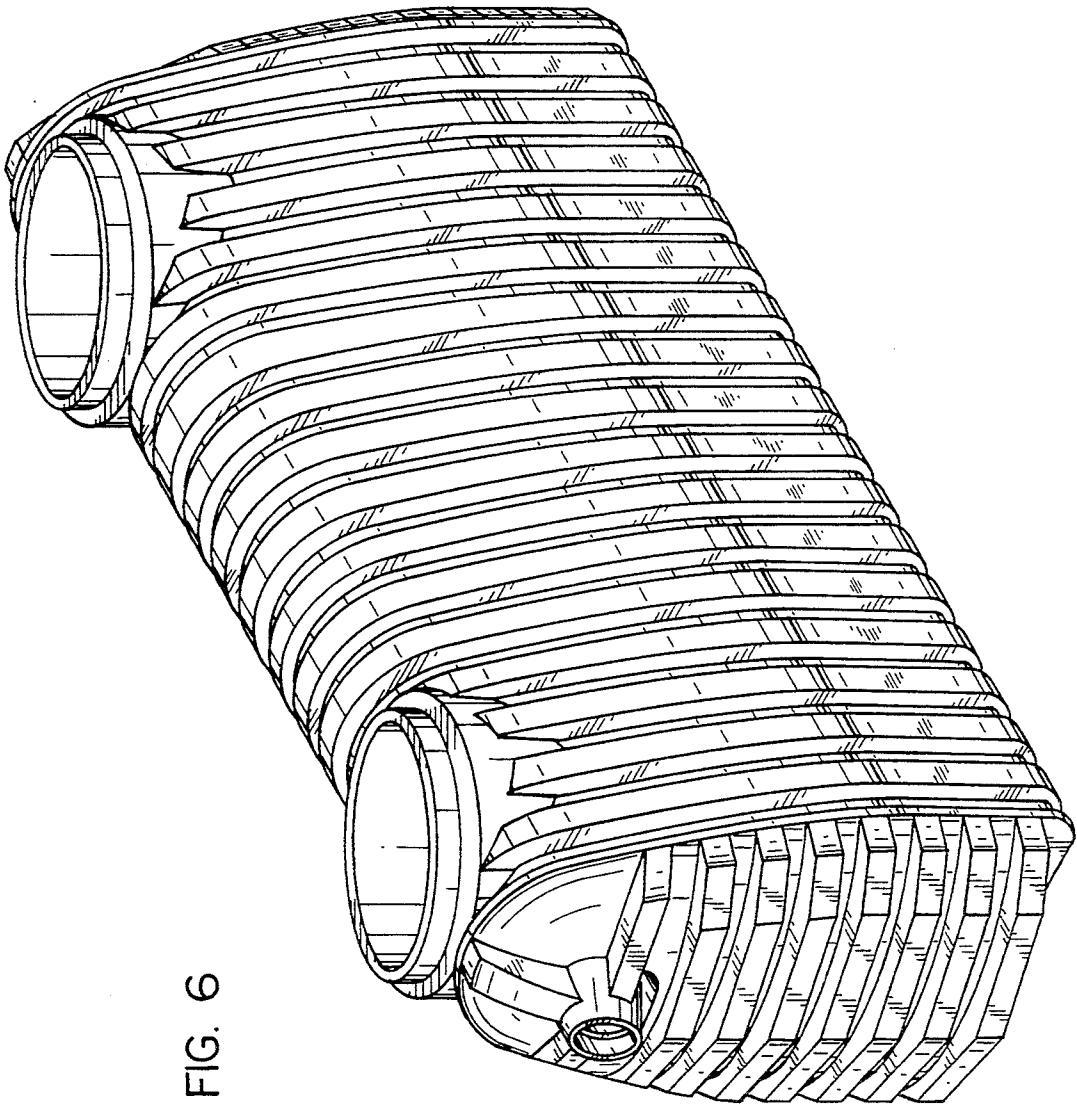
