(57) **CLAIM**

The ornamental design for a display screen or portion thereof with animated graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a first image in a sequence for a display screen or portion thereof with animated graphical user interface showing our new design; and,

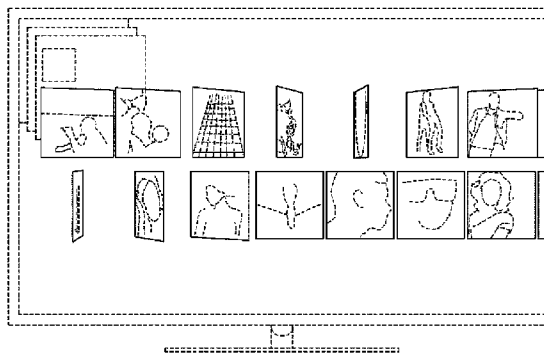
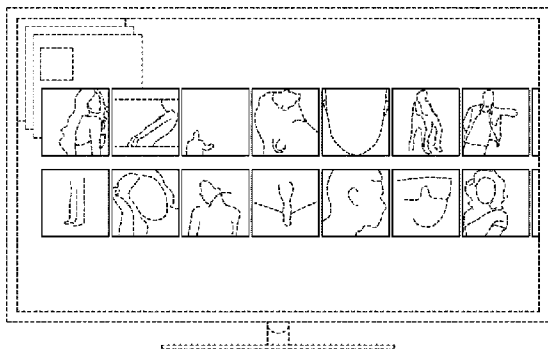

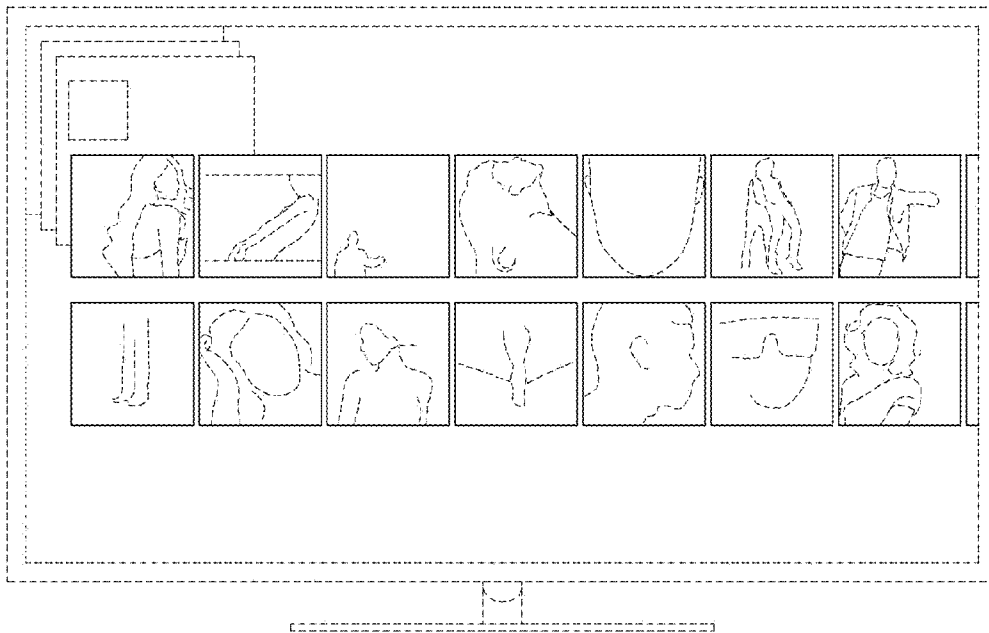
