The ornamental design for a pendant speaker, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the pendant speaker as seen from the bottom, front, and right side;
 FIG. 2 is front view thereof;
 FIG. 3 is a right side view thereof;
 FIG. 4 is a rear view thereof;
 FIG. 5 is a left side view thereof;
 FIG. 6 is a top view thereof; and,














