The ornamental design for a wristwatch, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of the front and right side of a wristwatch showing my new design;  
FIG. 2 is a front view thereof;

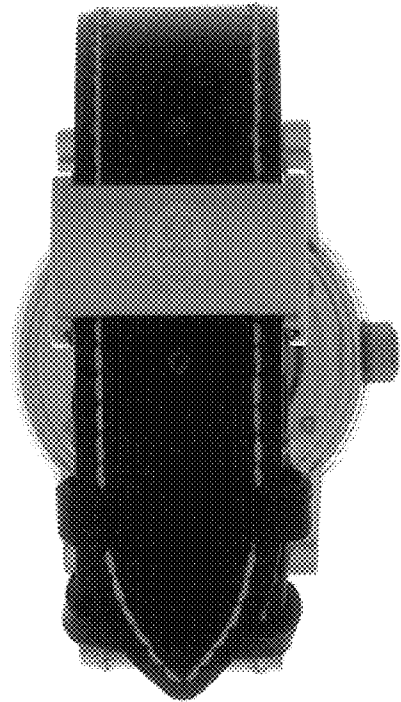

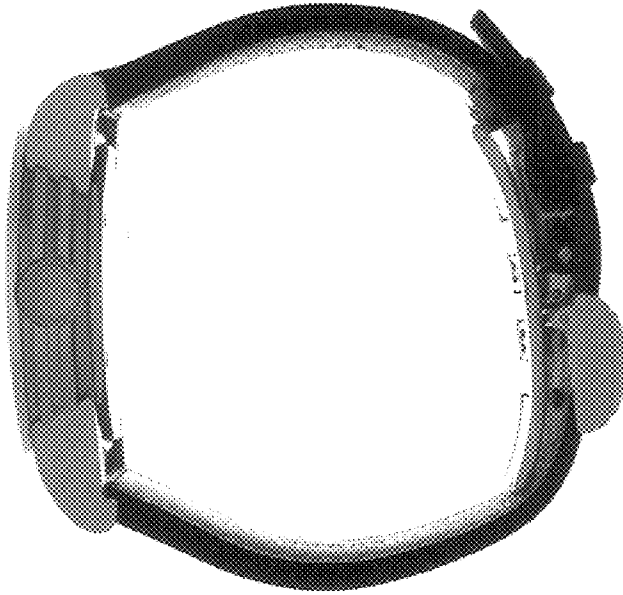

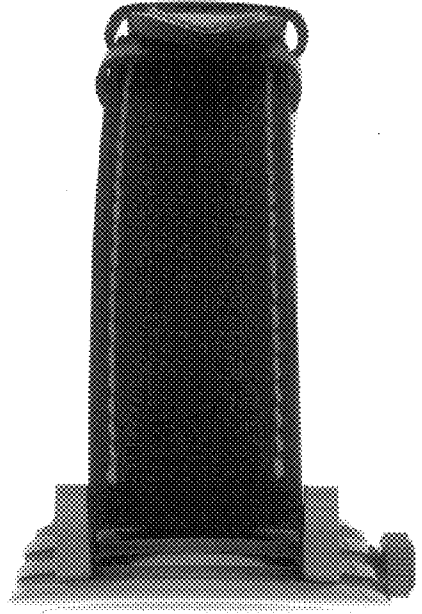

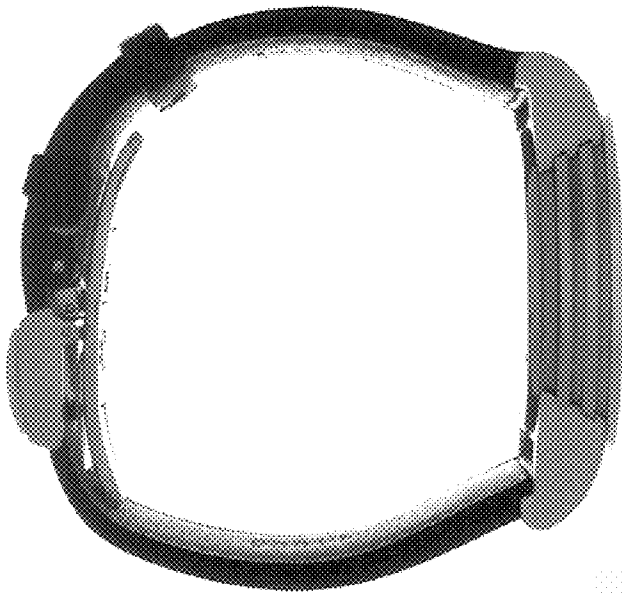
