
The ornamental design for a communication module housing, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a communication module housing showing my new design;
 FIG. 2 is a front side elevational view of the communication module housing of FIG. 1;

 FIG. 4 is a right side elevational view of the communication module housing of FIG. 1;














