FIG. 4 is an opposite side view thereof;

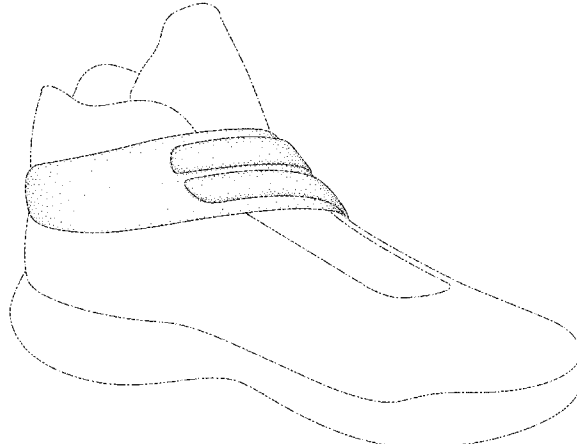
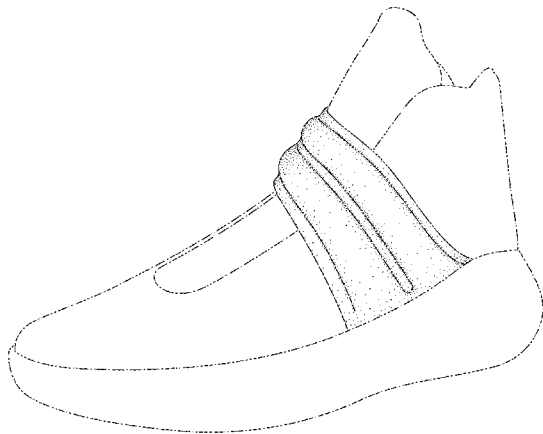
FIG. 5 is a rear view thereof;

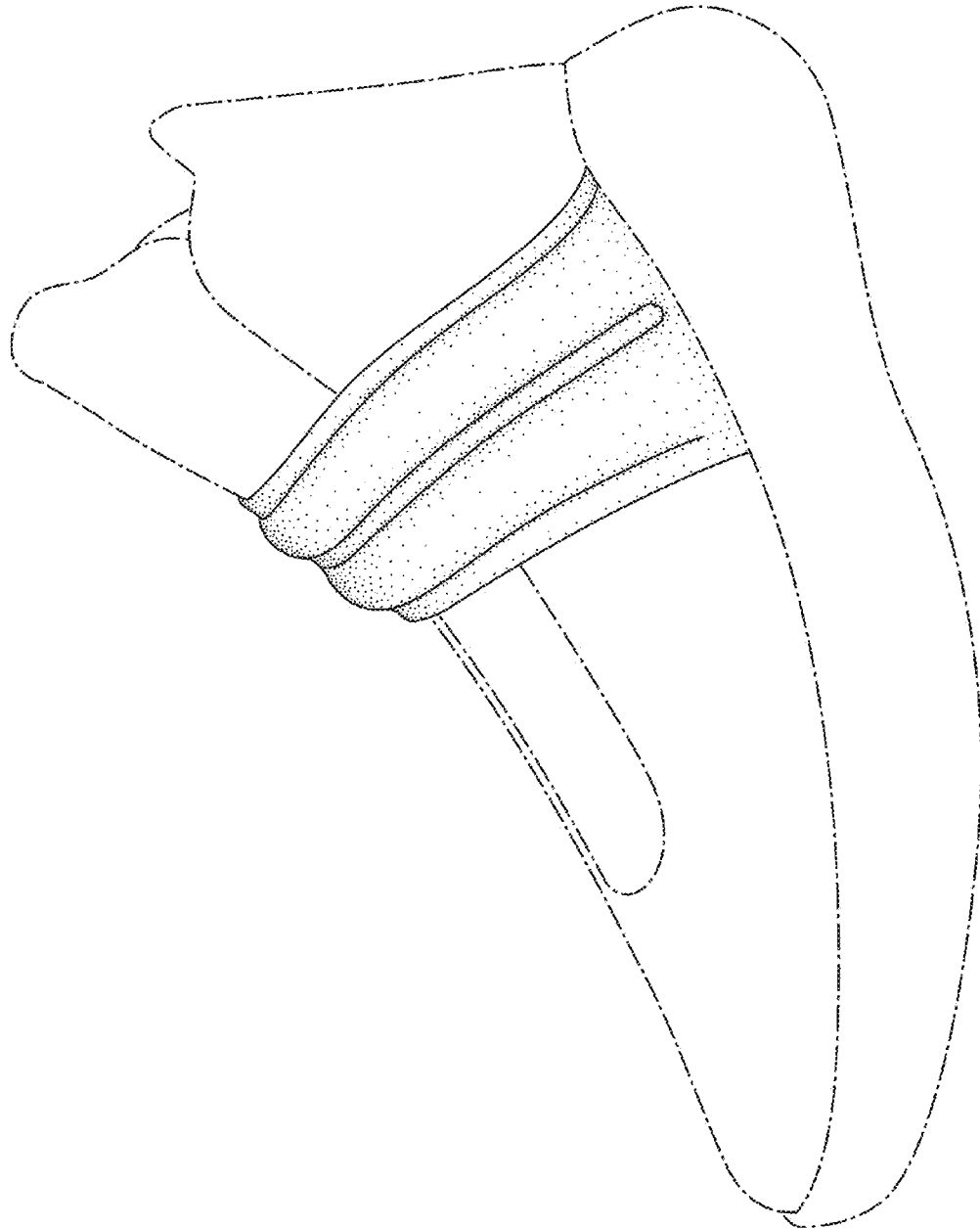

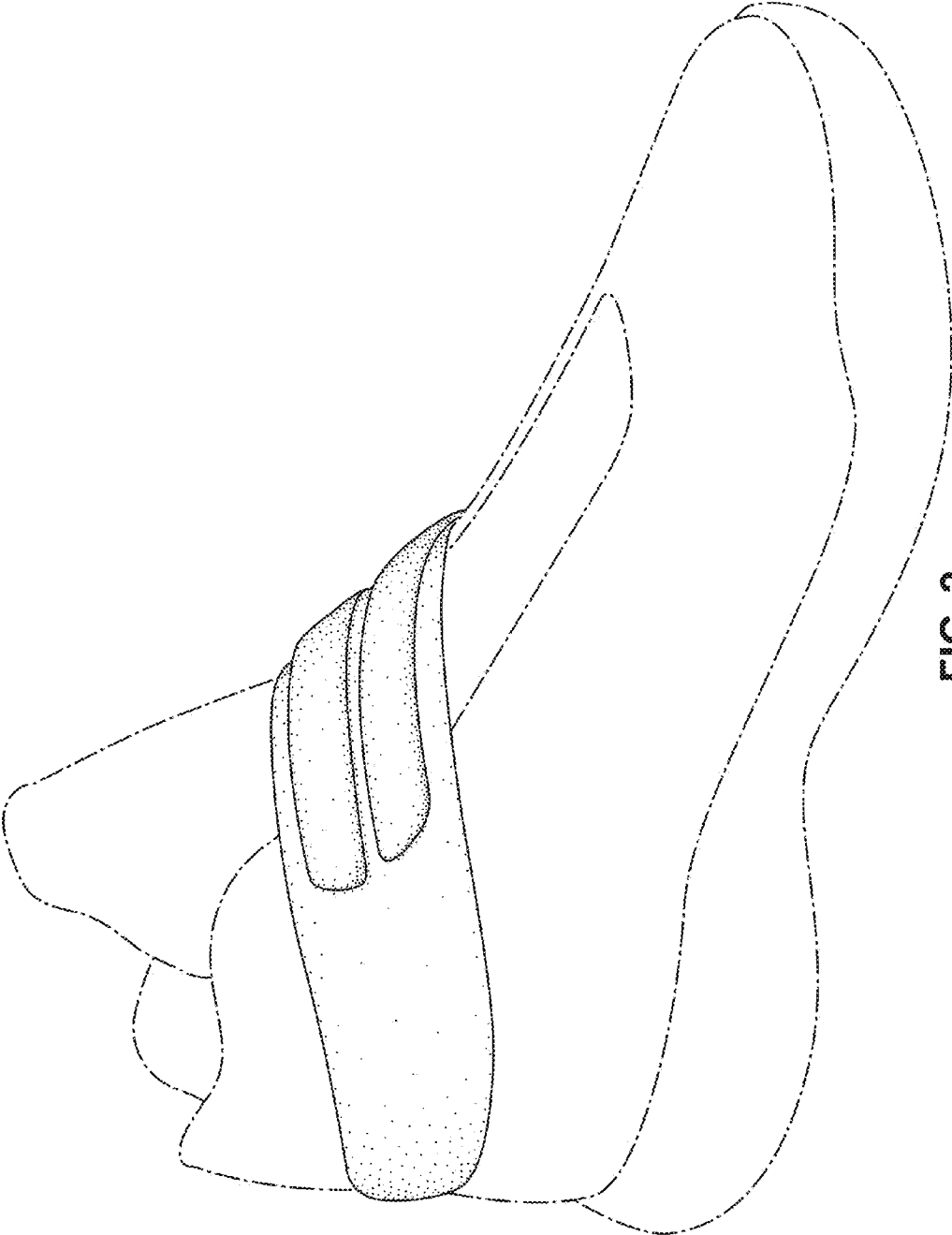

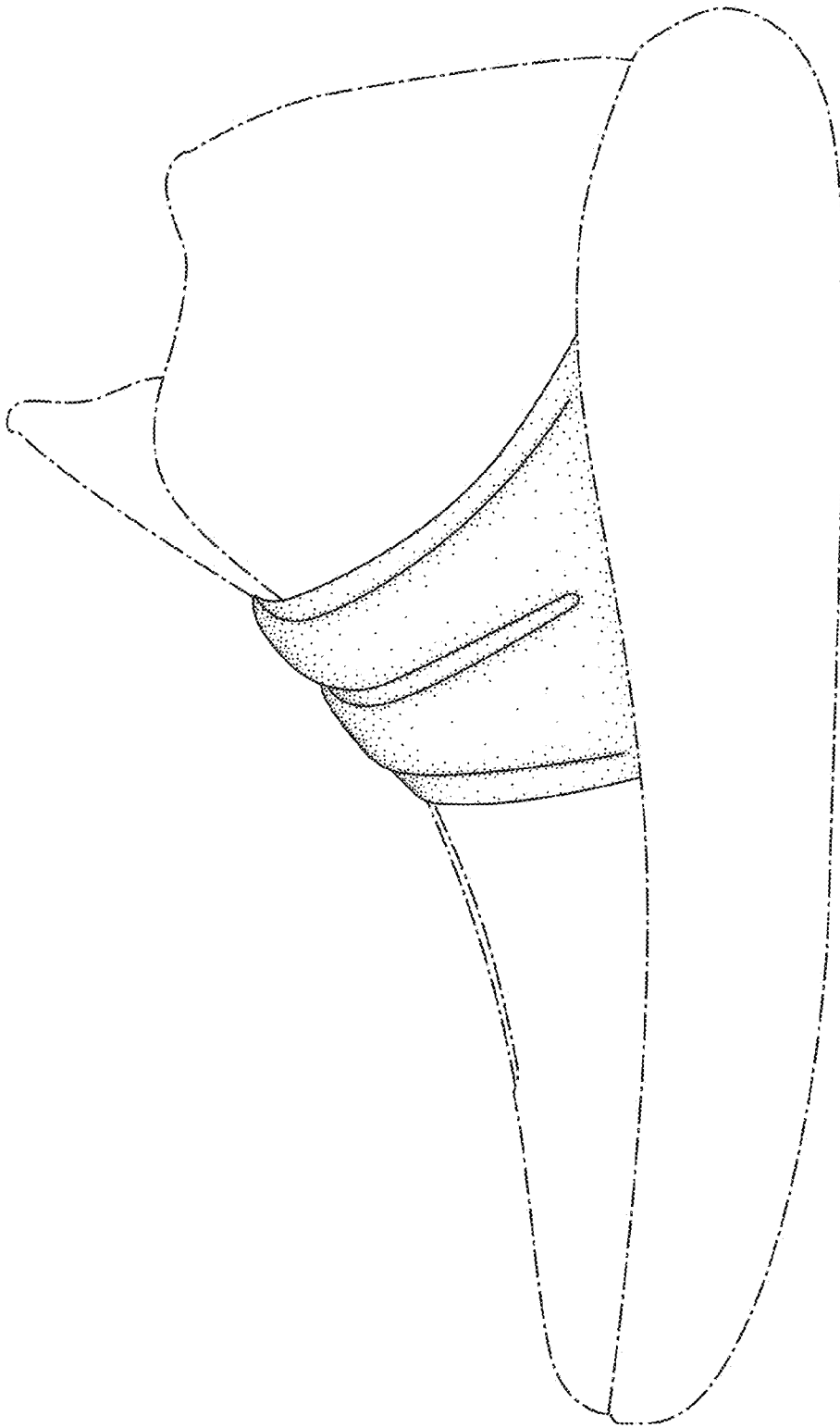

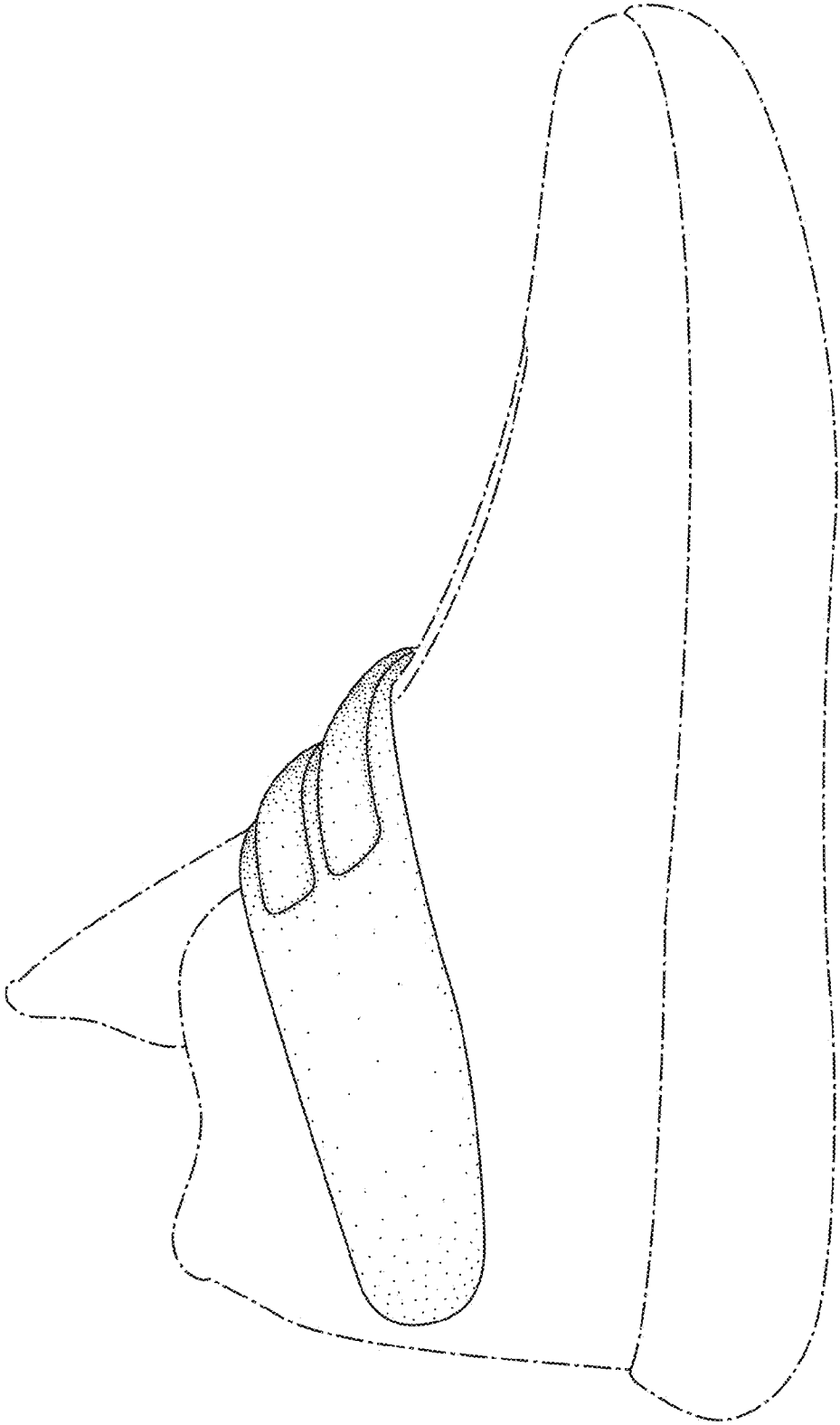

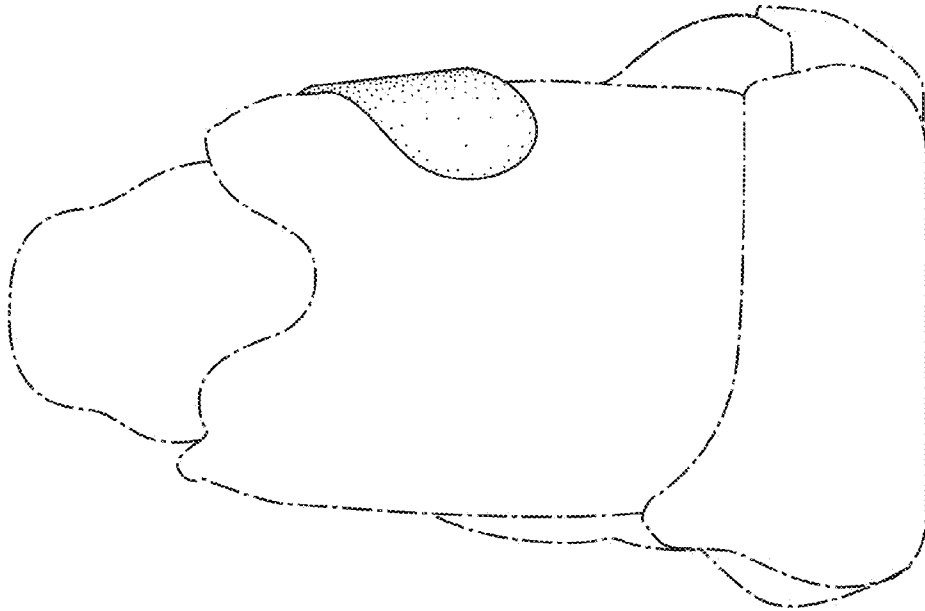

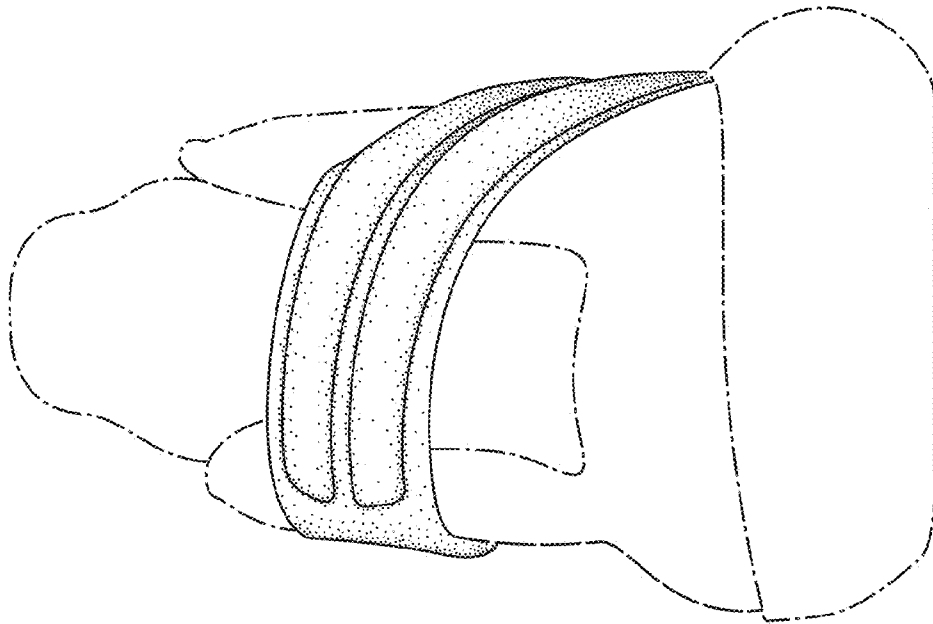

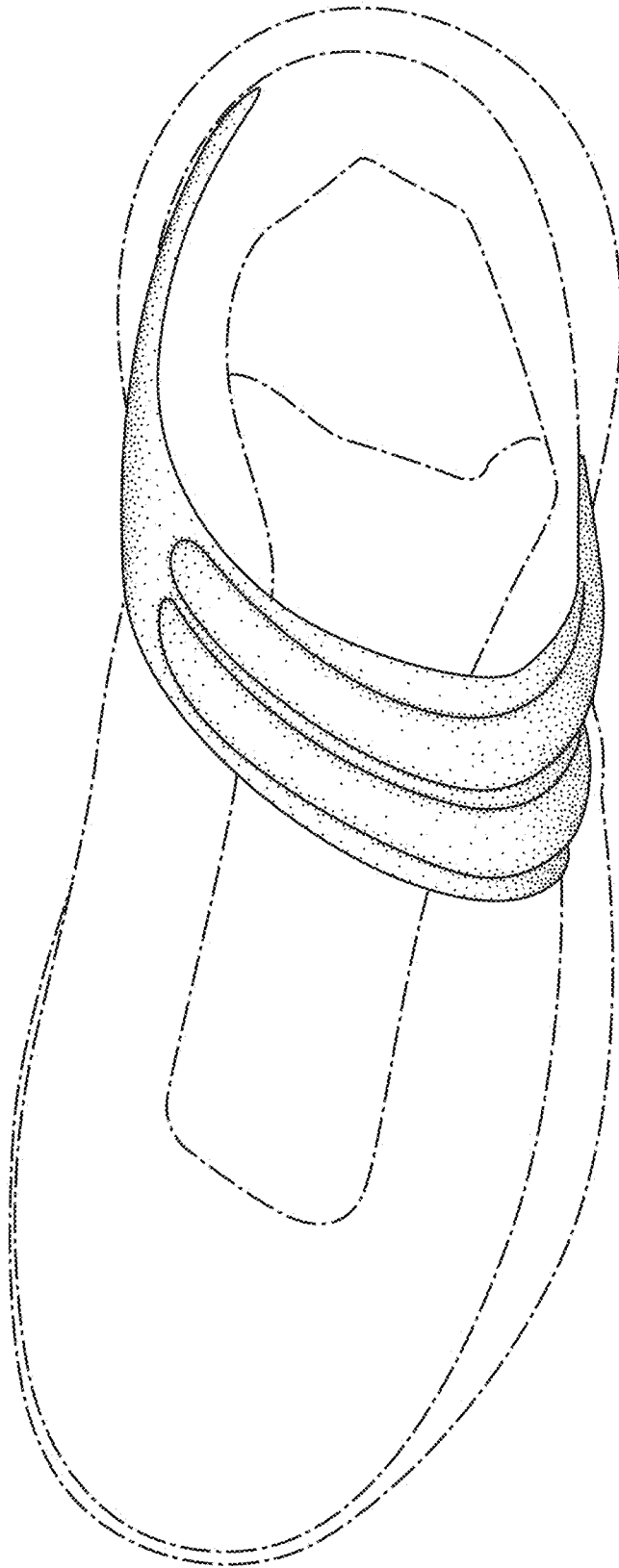
