

(57) **CLAIM**

The ornamental design for a beach chair strap, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view for a beach chair strap wrapped around the back of a beach chair.  
 FIG. 2 is a side view thereof;  
 FIG. 3 is a top view of the beach chair without environment, the bottom view being a mirror image thereof;  
 FIG. 4 is a front view thereof;  
 FIG. 5 is a rear view thereof;  
 FIG. 6 is a right side view thereof;  
 FIG. 7 is a perspective view of the beach chair strap in a wrapped position;  
 FIG. 8 is a left side view, the right side view being a mirror image thereof;  
 FIG. 9 is a front side view thereof;  
 FIG. 10 is a top view thereof;  
 FIG. 11 is a bottom view thereof; and,  
 FIG. 12 is a rear view thereof.  
 The broken lines in the figures form no part of the claimed design.























