(57) **CLAIM**

The ornamental design for a retail display indicia support with light channel, as shown and described.

DESCRIPTION

FIG. 1 is a top, right, front perspective view of a retail display indicia support with light channel showing the new design;

FIG. 2 is a front view of the invention illustrated in FIG. 1; FIG. 3 is a rear view of the invention illustrated in FIG. 1; FIG. 4 is a right side view of the invention illustrated in FIG. 1;


FIG. 5 is a left side view of the invention illustrated in FIG. 1;














