(57) **CLAIM**


The ornamental design for a light head, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a light head in accordance with a first embodiment of the present invention; FIG. 2 is a rear perspective view of the light head illustrated in FIG. 1; FIG. 3 is a top plan view of the light head illustrated in FIG. 1; FIG. 4 is a rear plan view of the light head illustrated in FIG. 1; FIG. 5 is a front plan view of the light head illustrated in FIG. 1; FIG. 6 is a side plan view of the light head illustrated in FIG. 1; FIG. 7 is a front perspective view of a light head in accordance with a second embodiment of the present invention; FIG. 8 is a rear perspective view of the light head illustrated in FIG. 7; FIG. 9 is a top plan view of the light head illustrated in FIG. 7; FIG. 10 is a rear plan view of the light head illustrated in FIG. 7; FIG. 11 is a front plan view of the light head illustrated in FIG. 7; and, FIG. 12 is a side plan view of the light head illustrated in FIG. 7.
























