(57) **CLAIM**


The ornamental design for a carrying case with integrated whiteboard, as shown and described.

DESCRIPTION

FIG. 1 is a front isometric view of a carrying case with integrated whiteboard showing a new design; FIG. 2 is a left side view of the embodiment of the carrying case with integrated whiteboard shown in FIG. 1; FIG. 3 is a front view of the embodiment of the carrying case with integrated whiteboard shown in FIG. 1; FIG. 4 is a back view of the embodiment of the carrying case with integrated whiteboard shown in FIG. 1; and, FIG. 5 is a bottom view of the embodiment of the carrying case with integrated whiteboard; shown in FIG. 1.

The broken lines immediately adjacent the solid contour lines in FIGS. 1, 3 and 4 represent the bounds of the claim. The remaining broken lines illustrate portions of the carrying case with integrated whiteboard. None of the broken lines forms part of the claimed design.










