(57) **CLAIM**

I claim the ornamental design for a packaging bag, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a packaging bag, showing my new design;

FIG. 2 is a rear elevational view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;


FIG. 5 is right side elevational view thereof, the left side elevational view being a mirror image thereof;


FIG. 6 is a sectional view thereof, taken along line 6-6 in FIG. 1; and,

FIG. 7 is a cross-sectional view thereof, showing the portion defined by line 7-7 of FIG. 6 at an enlarged scale.


The broken line showing is for illustrative purposes only and forms no part of the claimed design.








