(57) **CLAIM**


The ornamental design for a cooking appliance with grill grate assembly, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a first configuration of a grill grate assembly that is a part of a cooking appliance with grill grate assembly according to the new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a front elevation view thereof; FIG. 7 is a back elevation view thereof; FIG. 8 is a front perspective view of the cooking appliance with grill grate assembly, including the first configuration of the grill grate assembly of FIGS. 1-7; FIG. 9 is an unclaimed reference view showing the reconfiguration from the grill grate assembly from the first configuration of FIGS. 1-7 to a second configuration; FIG. 10 is a front perspective view of the cooking appliance with grill grate assembly, including the second configuration of the grill grate assembly; FIG. 11 is a front perspective view of the second configuration of the grill grate assembly that is a part of the cooking appliance with grill grate assembly; FIG. 12 is a top plan view thereof; FIG. 13 is a bottom plan view thereof; FIG. 14 is a right side elevation view thereof; FIG. 15 is a left side elevation view thereof; FIG. 16 is a front elevation view thereof; and, FIG. 17 is a back elevation view thereof.


























