DESCRIPTION

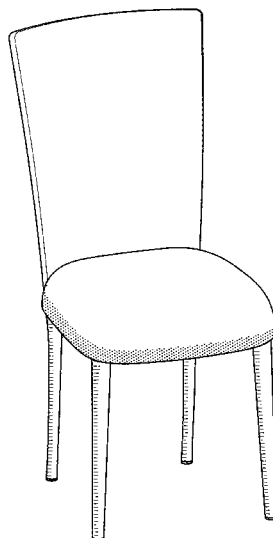
FIG. 1 is a perspective view of a wood fullback chair showing my new design;

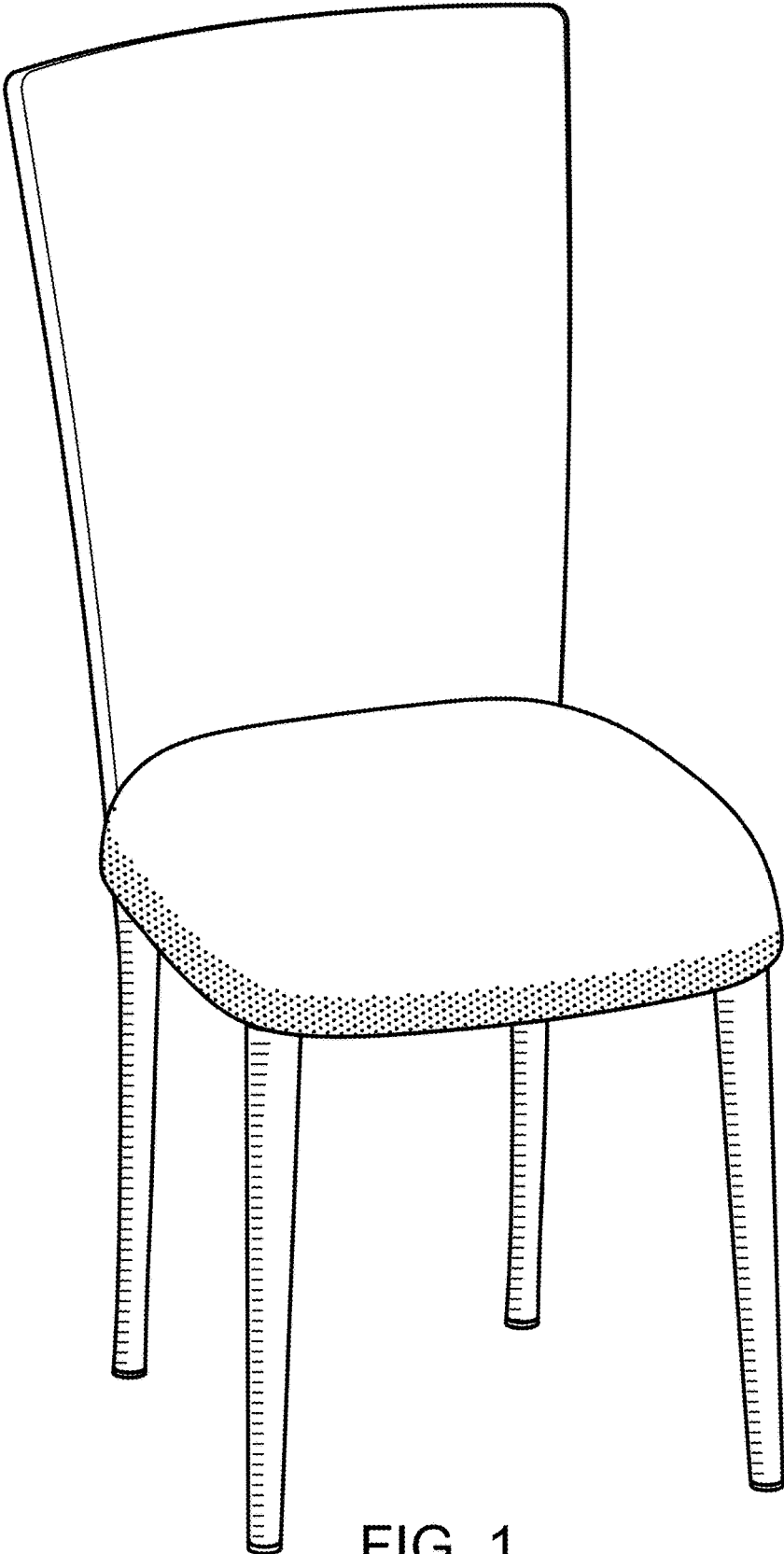

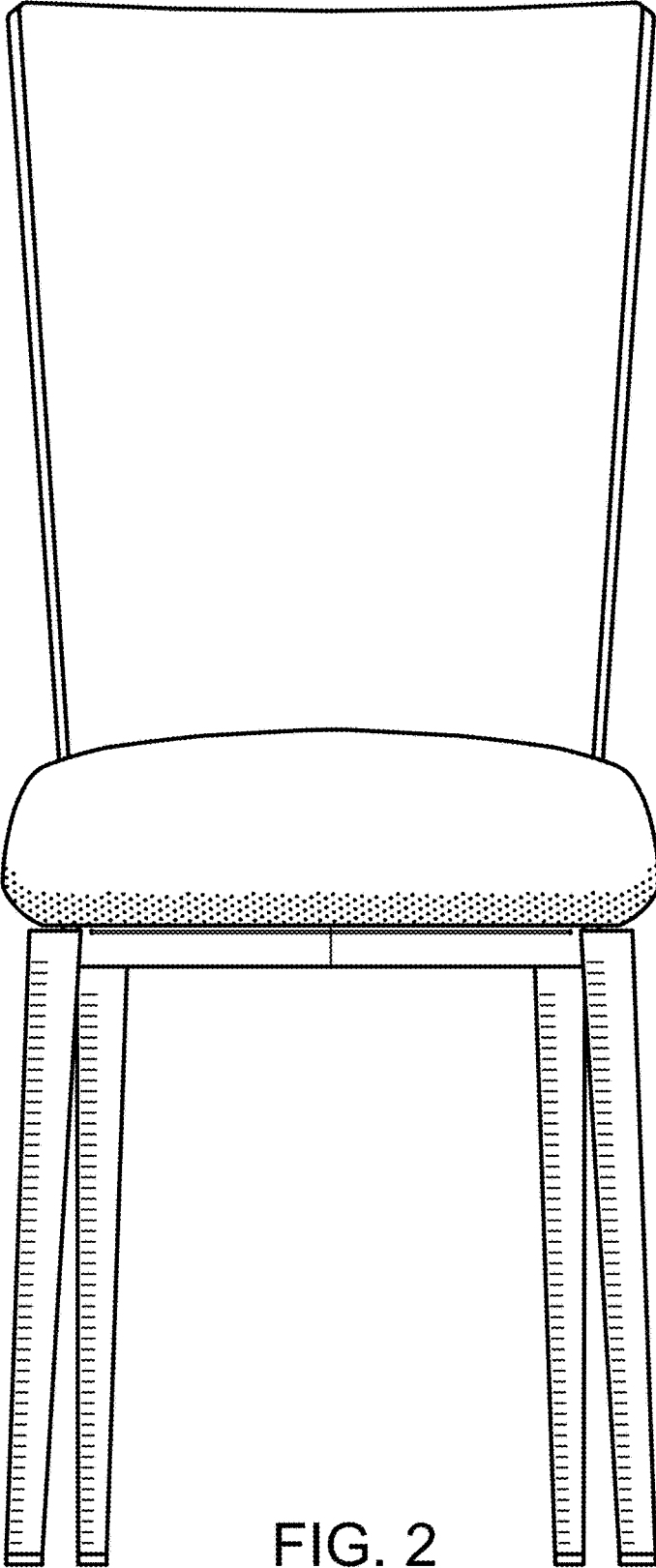

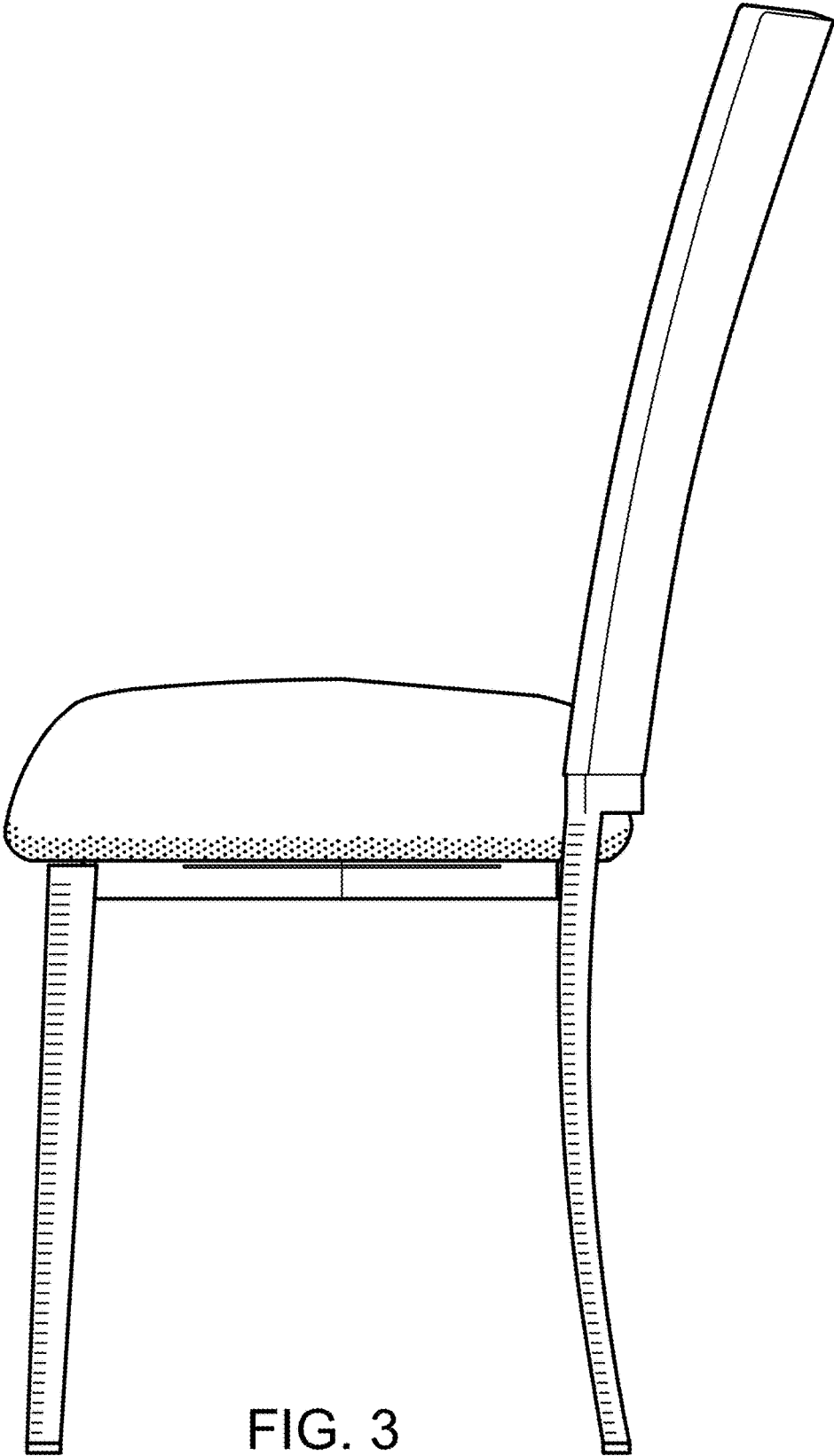

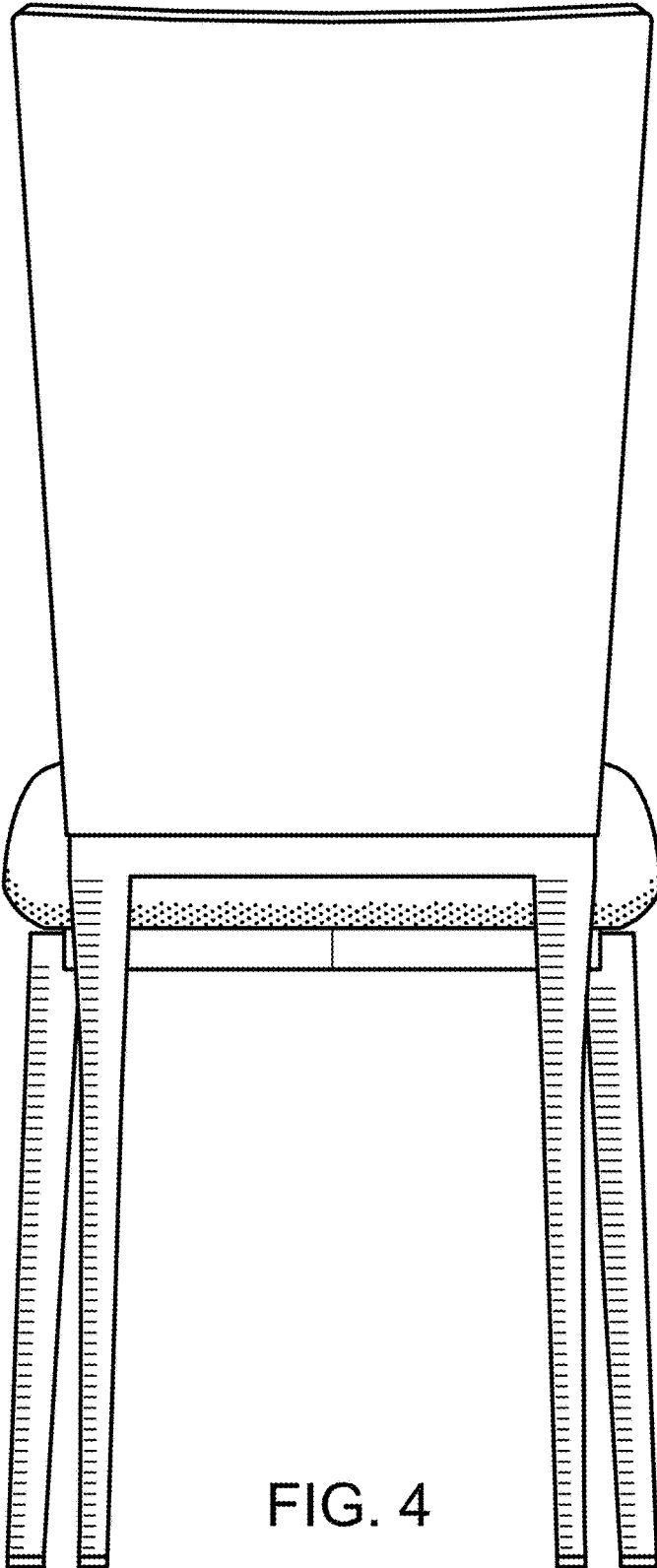

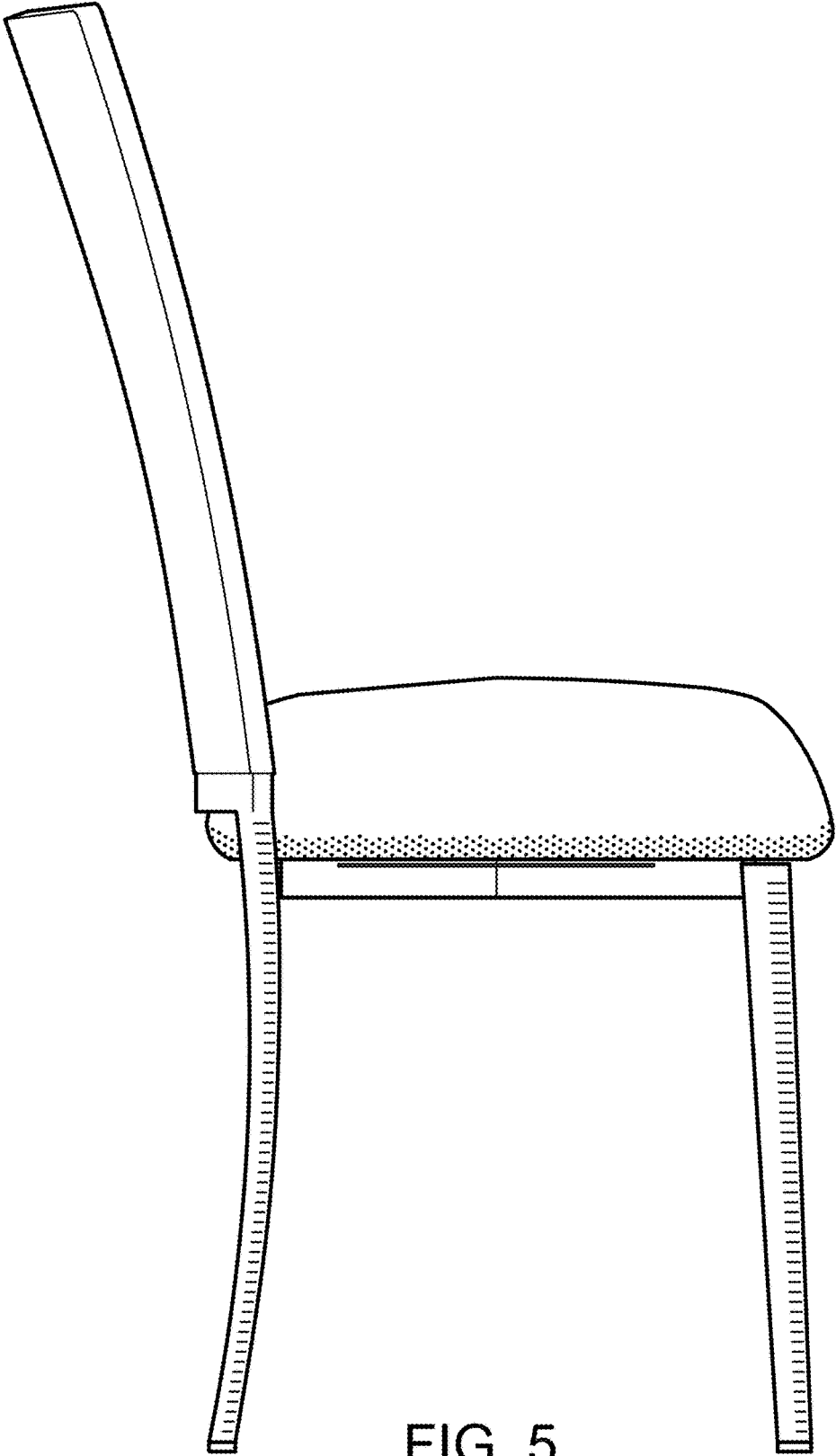

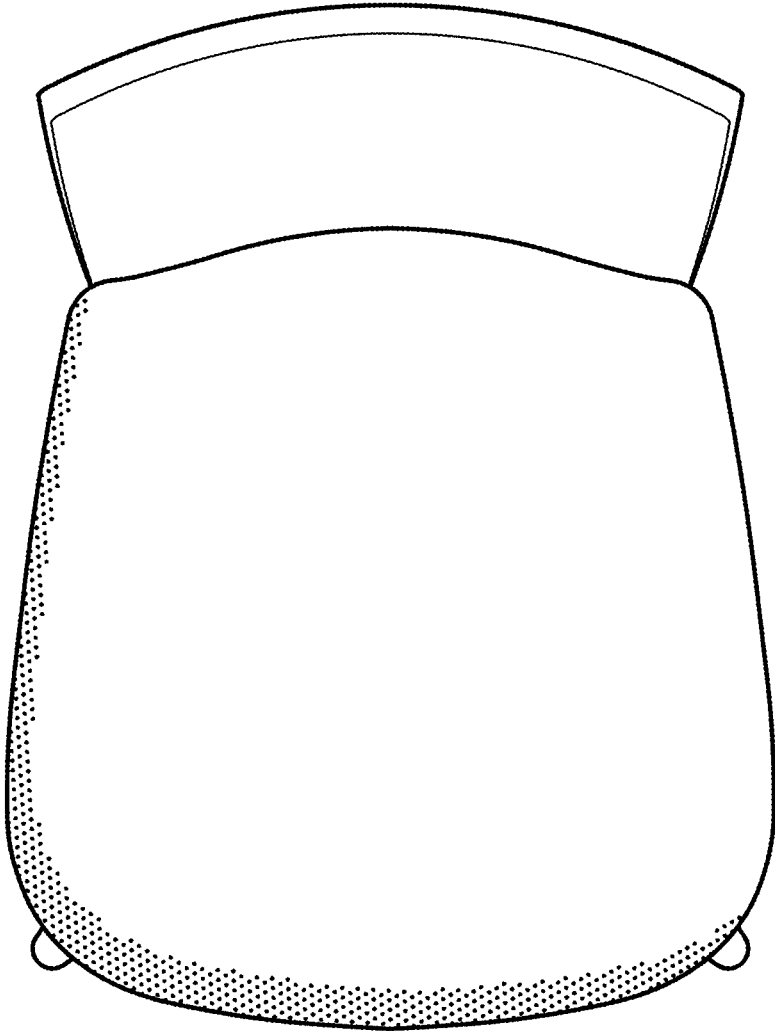

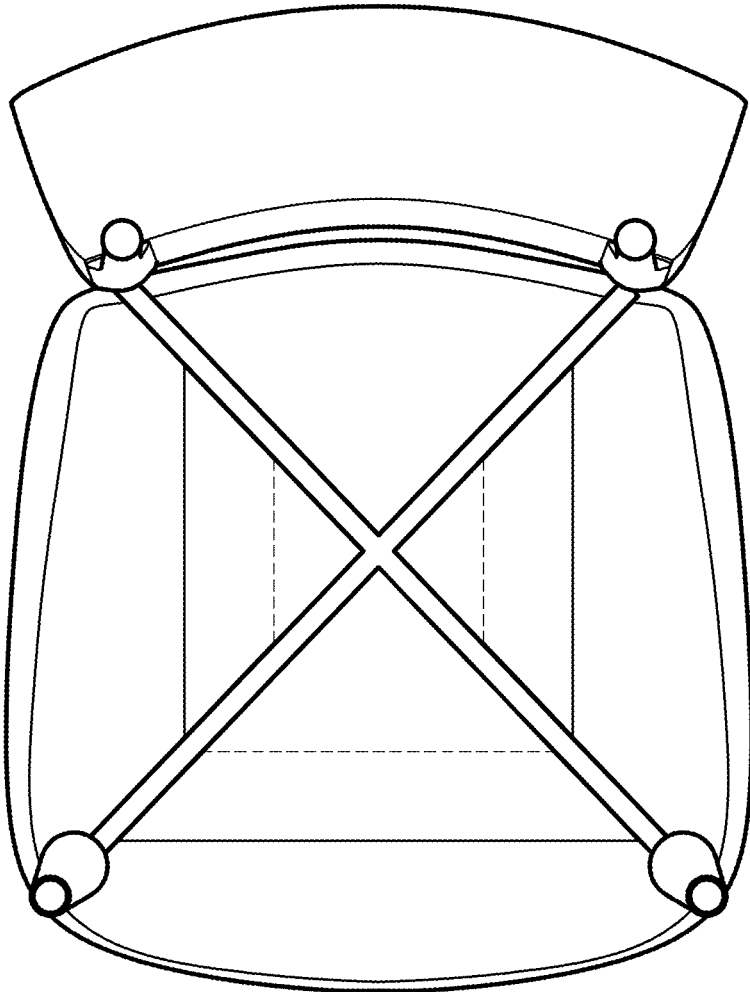
