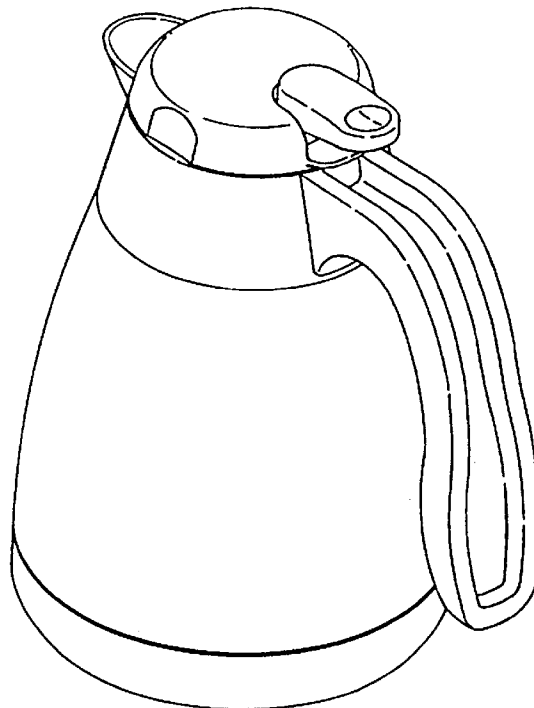
(57) **CLAIM**

The ornamental design for a thermal pot, as substantially shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a thermal pot according to the invention;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a front thermal pot view thereof;  
 FIG. 4 is a rear thermal pot view thereof;  
 FIG. 5 is a bottom plan thermal pot view thereof;  
 FIG. 6 is a right end thermal pot view thereof;  
 FIG. 7 is a left end thermal pot view thereof;  
 FIG. 8 is a sectional referential view of the thermal pot shown in FIG. 2 take along line A—A; and,  
 FIG. 9 is a sectional referential view of the thermal pot shown in FIG. 3 take along line B—B.

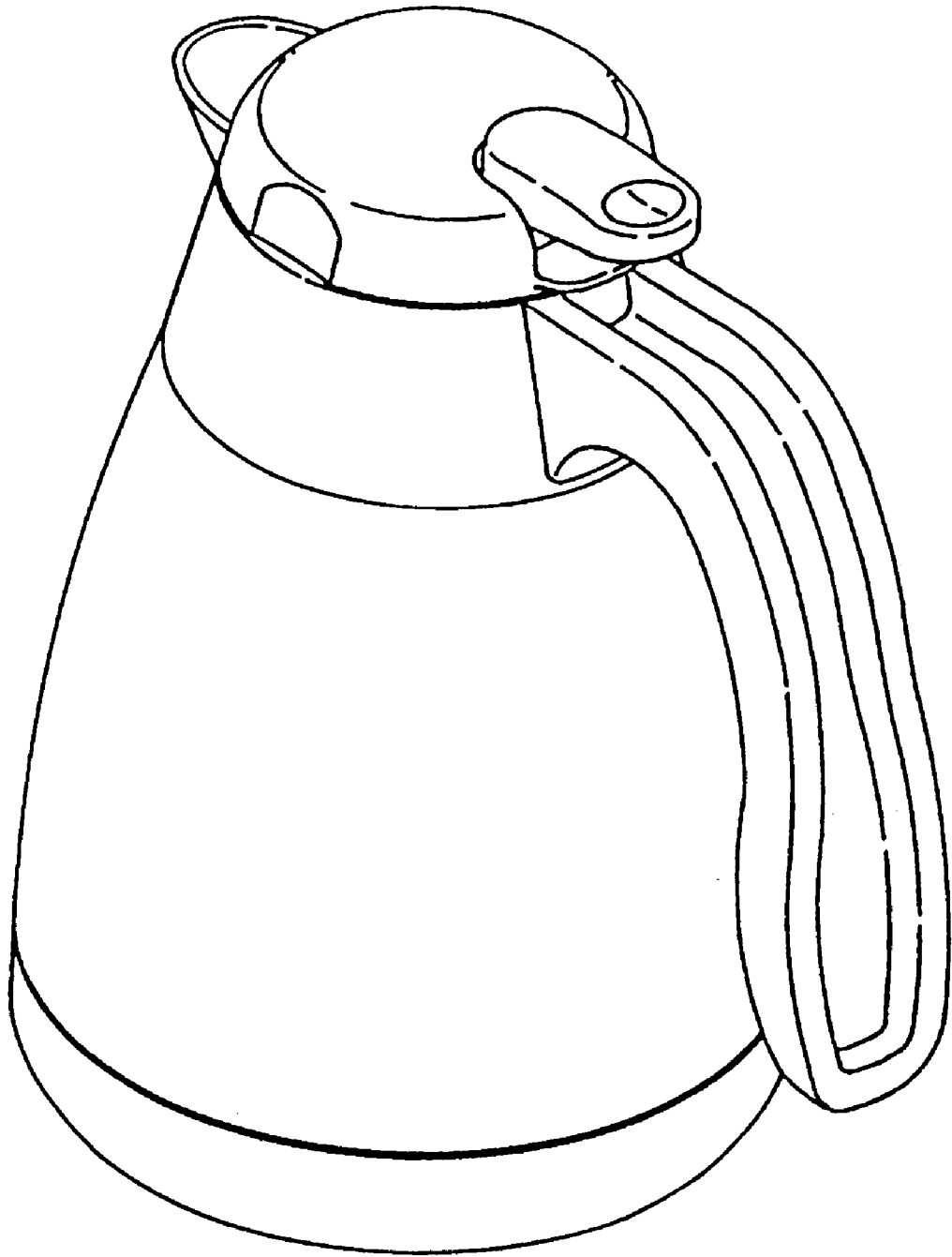

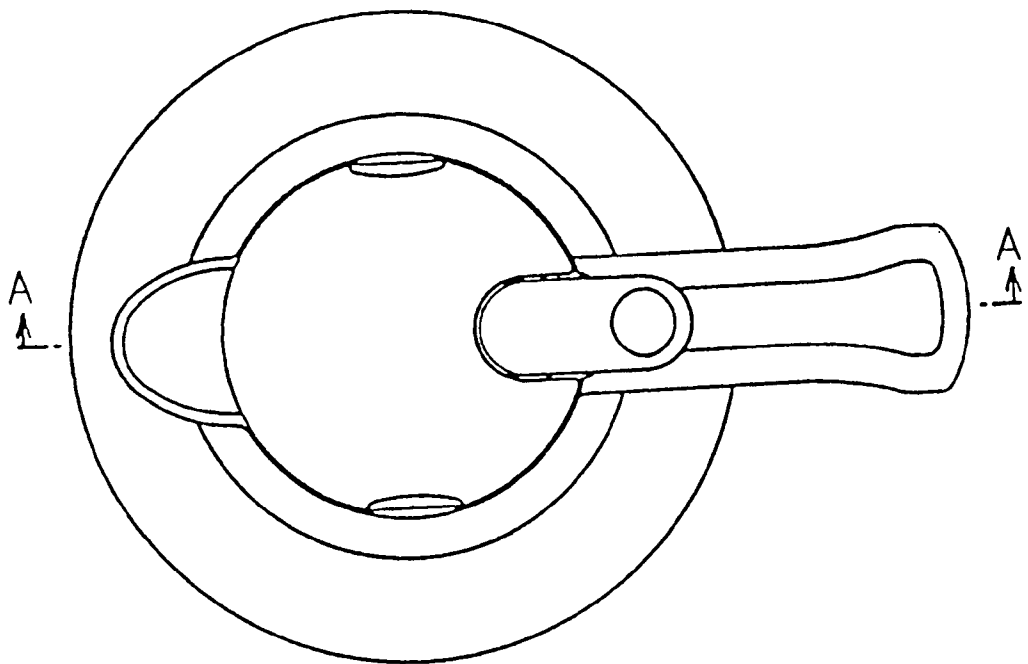

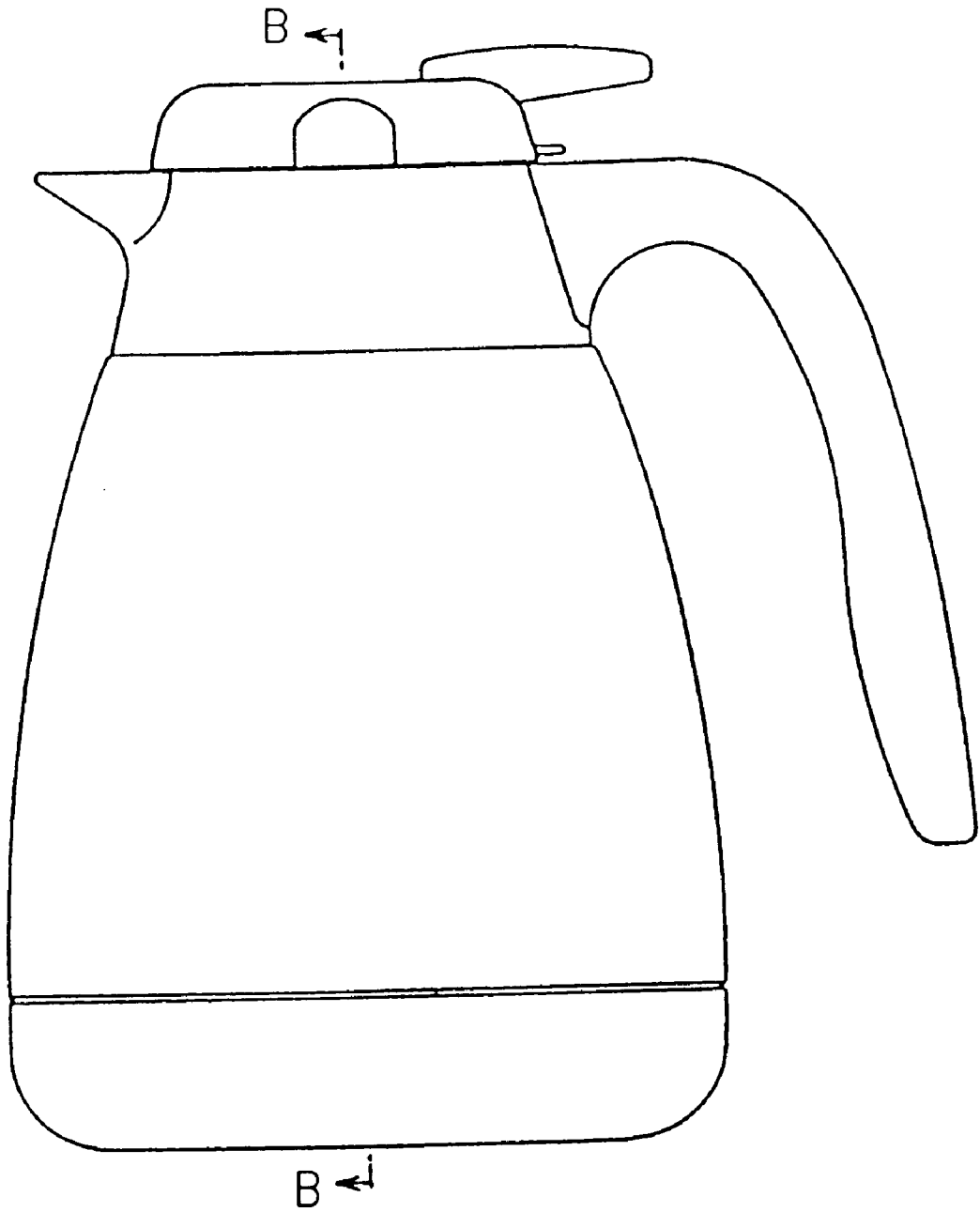

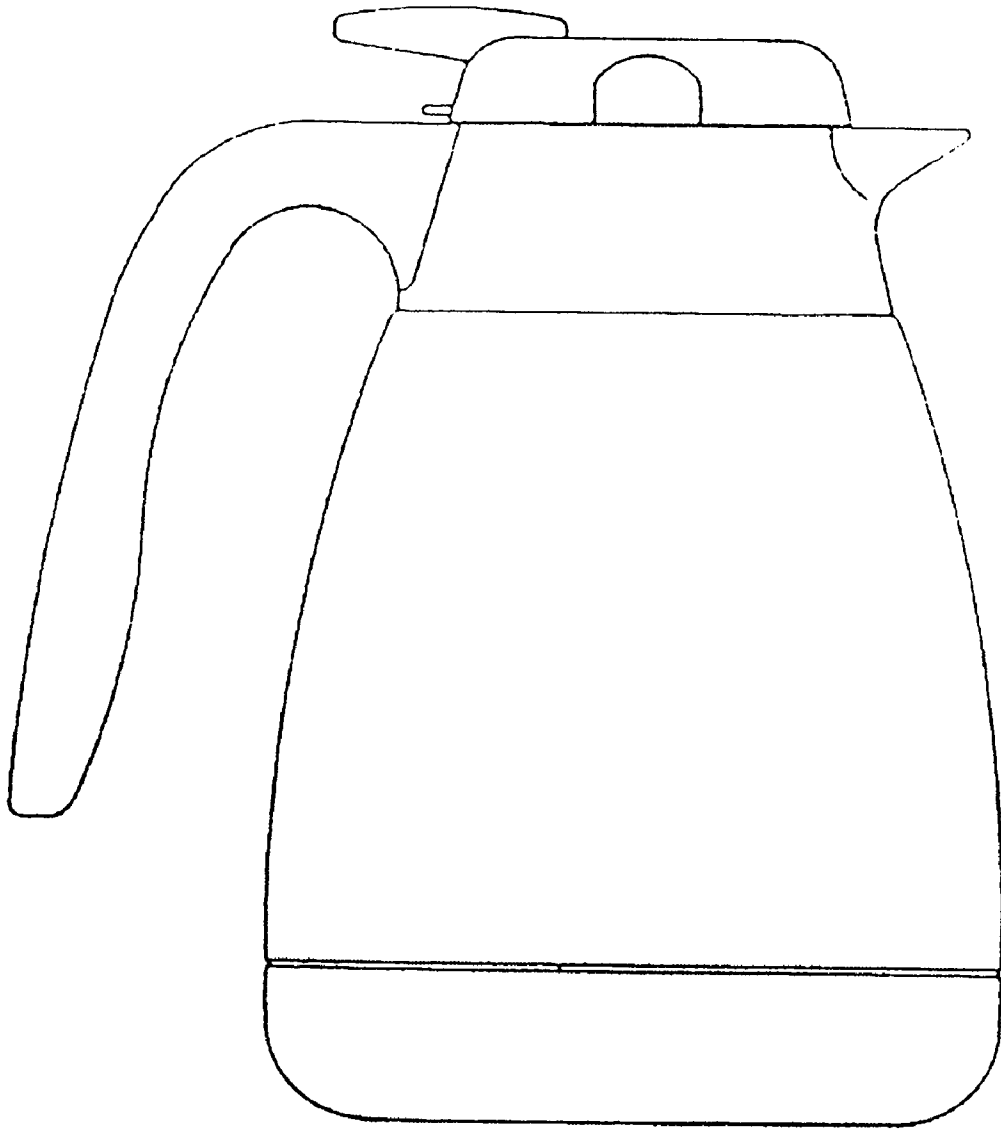

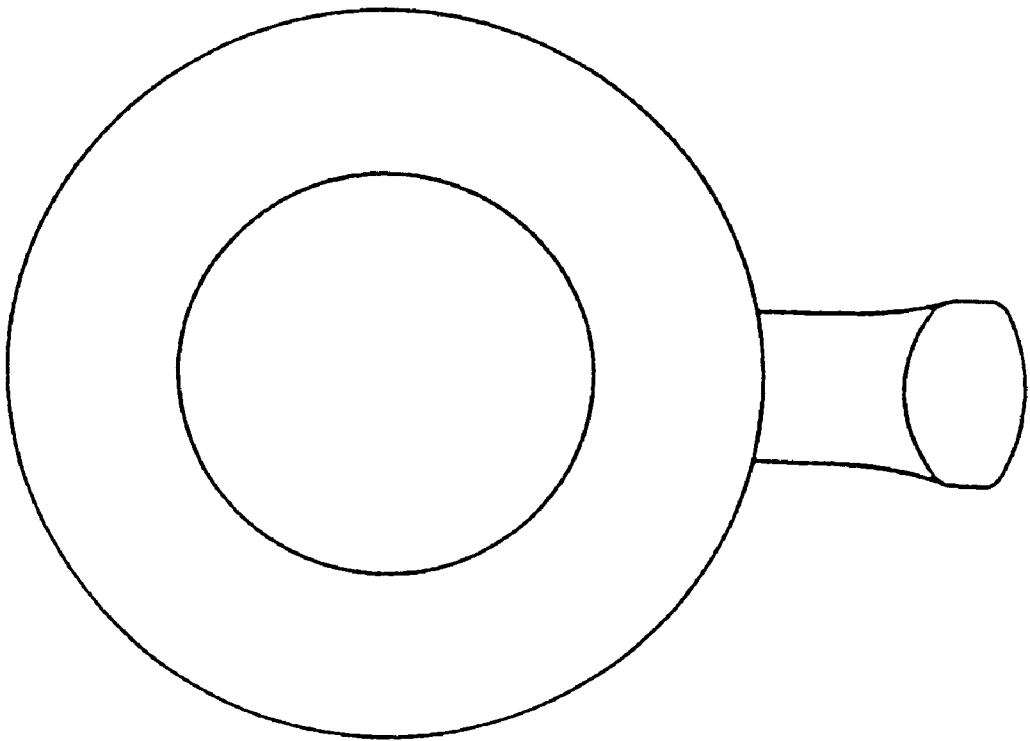

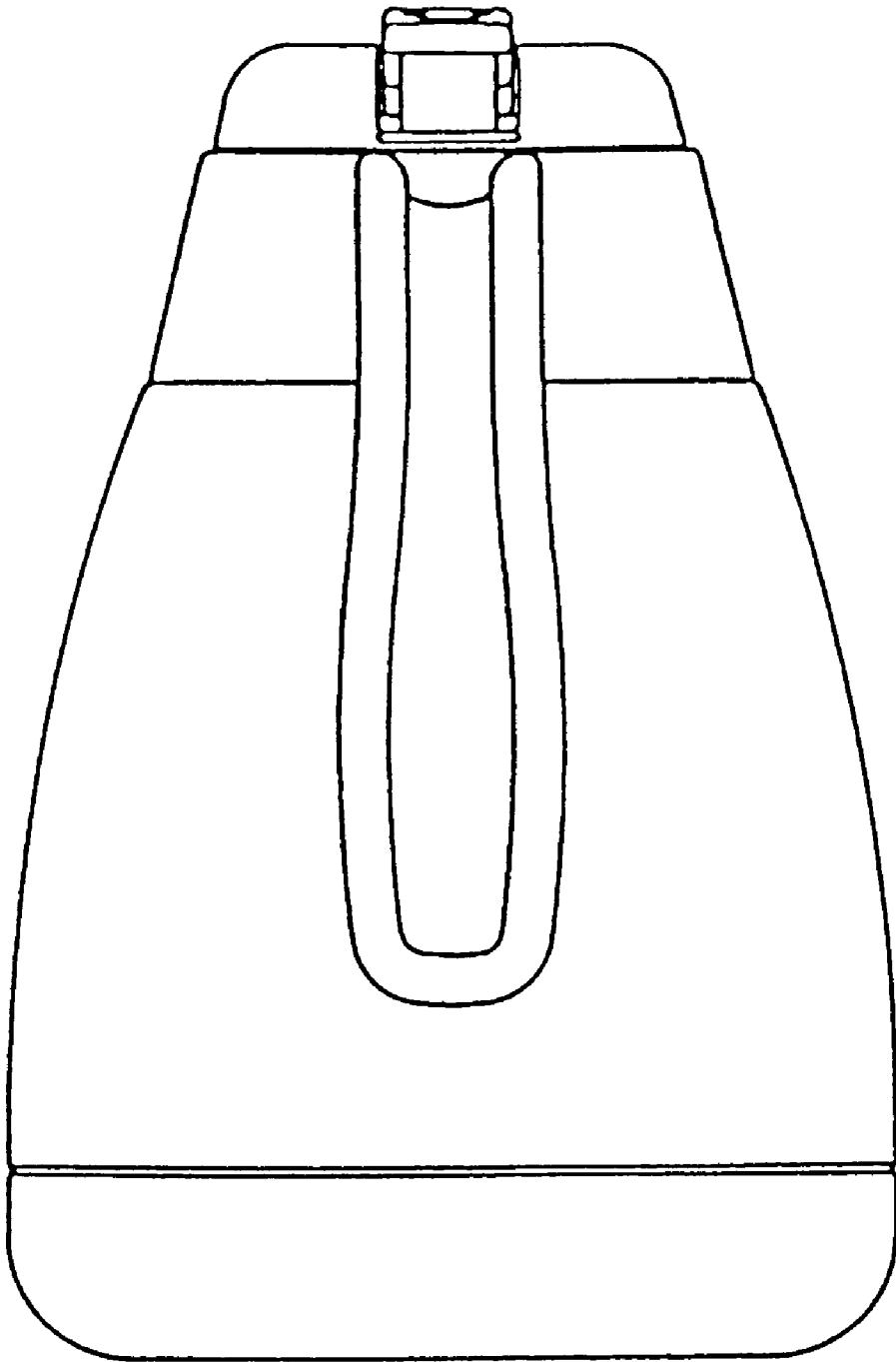

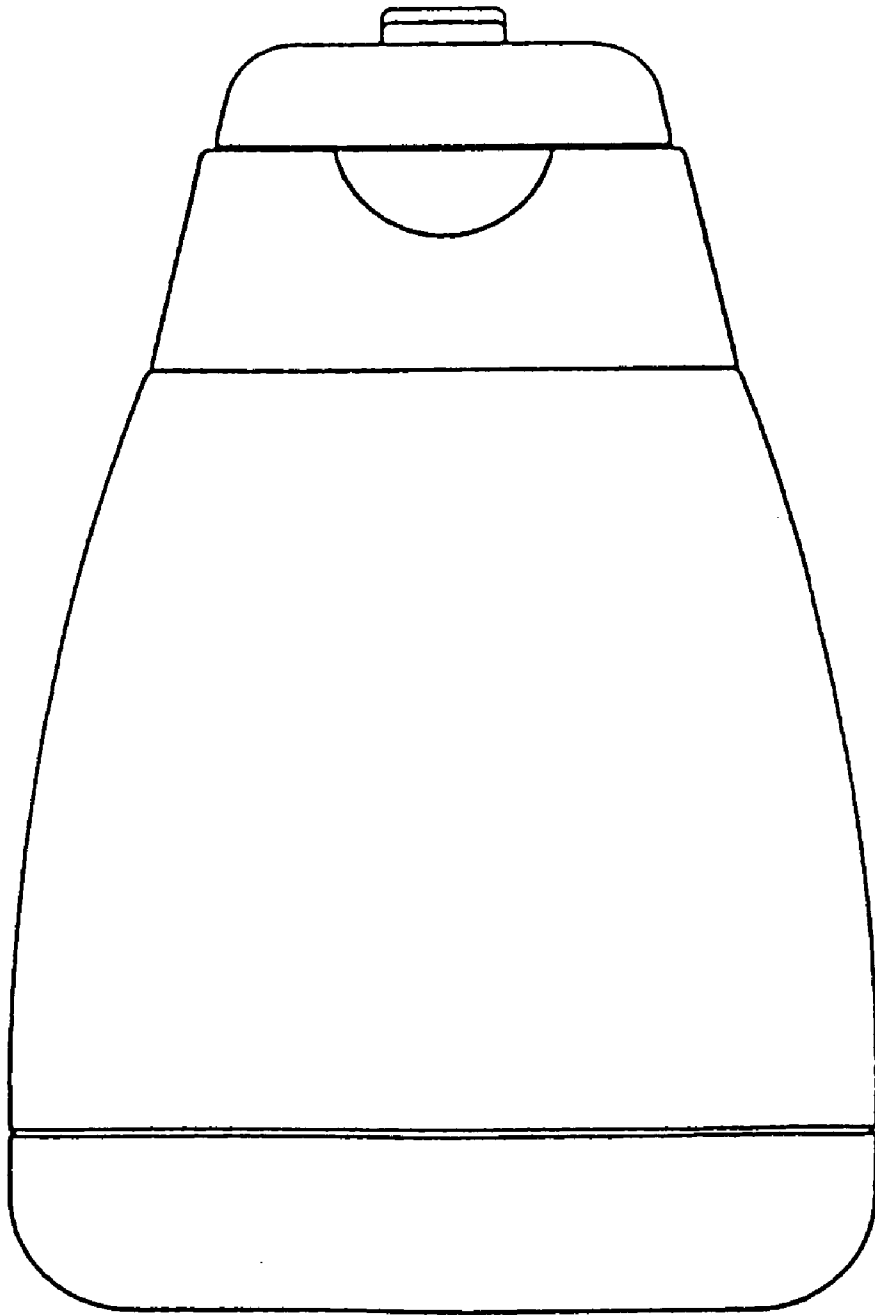

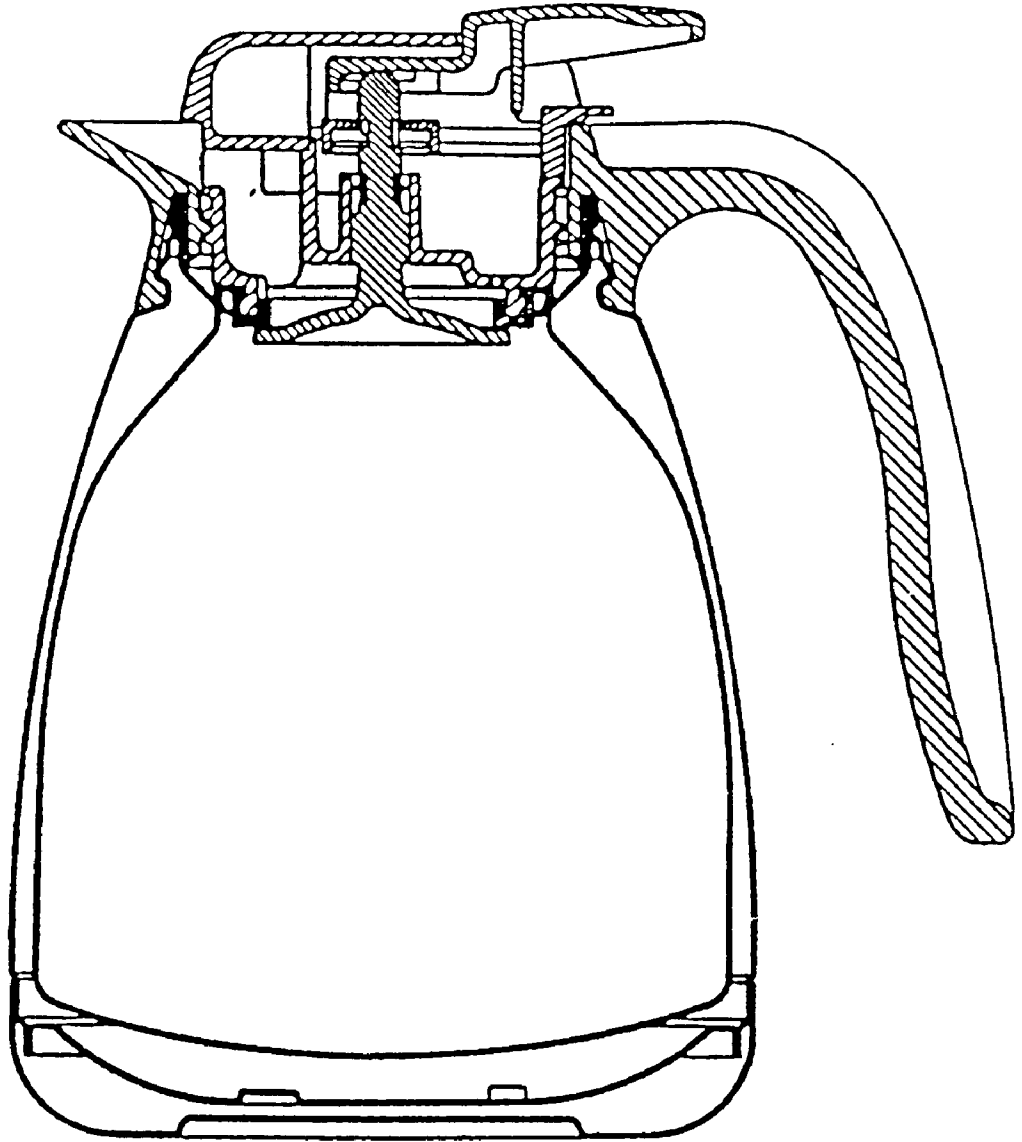

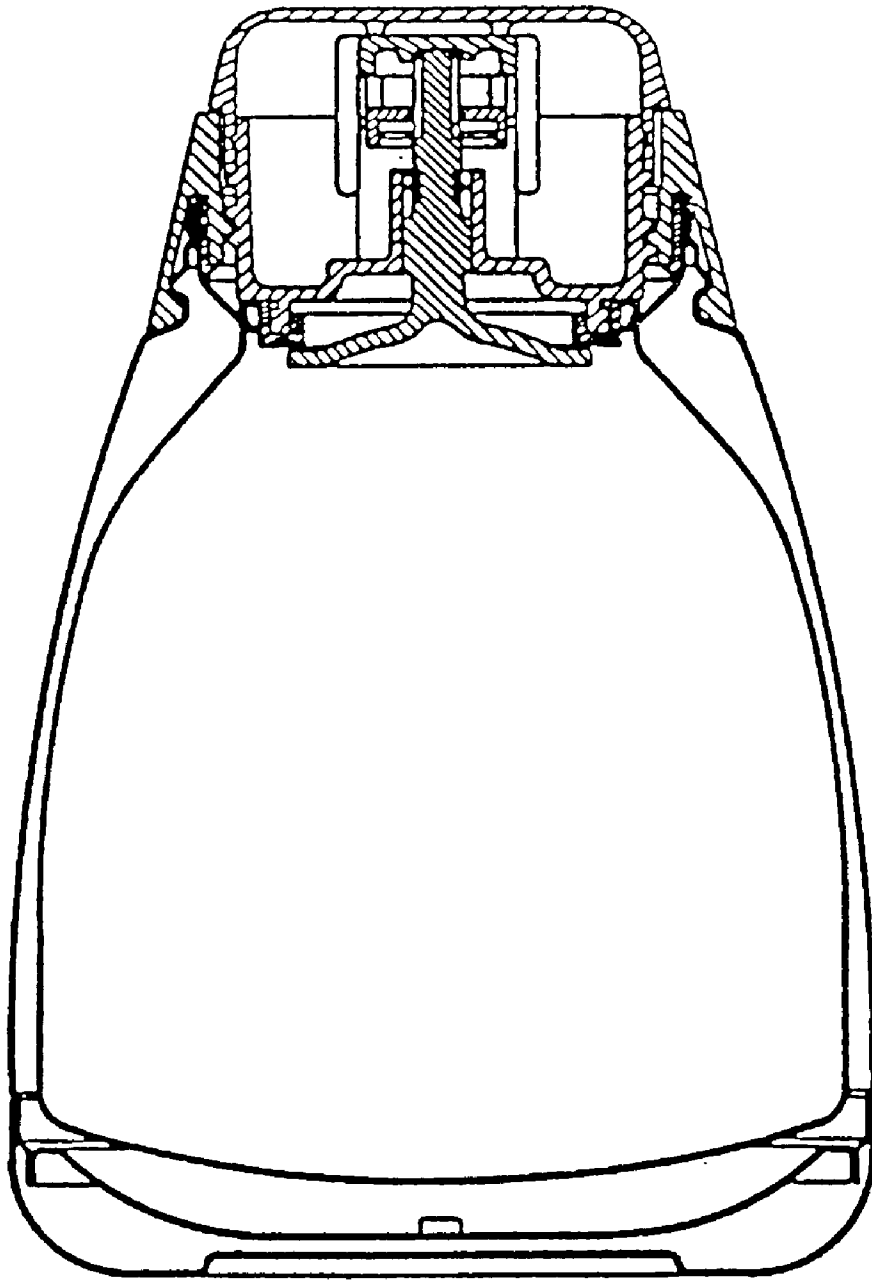
