(57) **CLAIM**
The ornamental design for a dress with twisted neckline, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the embodiment of the dress and showing a side pocket;
FIG. 2 is a rear view of the dress and showing the side pocket;
FIG. 3 is a left side view of the dress showing the side pocket;
FIG. 4 is a right side view of the dress;
FIG. 5 is a left perspective view of the dress showing the side pocket;
FIG. 6 is a front view of the dress's side pocket turned inside-out and with the remainder of the dress fabric folded up inside the pocket;
FIG. 7 is a rear view of the dress's side pocket turned inside-out and with the remainder of the dress folded up inside the pocket; and,
FIG. 8 is a rear perspective view of the dress's side pocket turned inside-out and with the majority of the dress fabric folded up inside the pocket, but with some of the dress fabric spilling out.

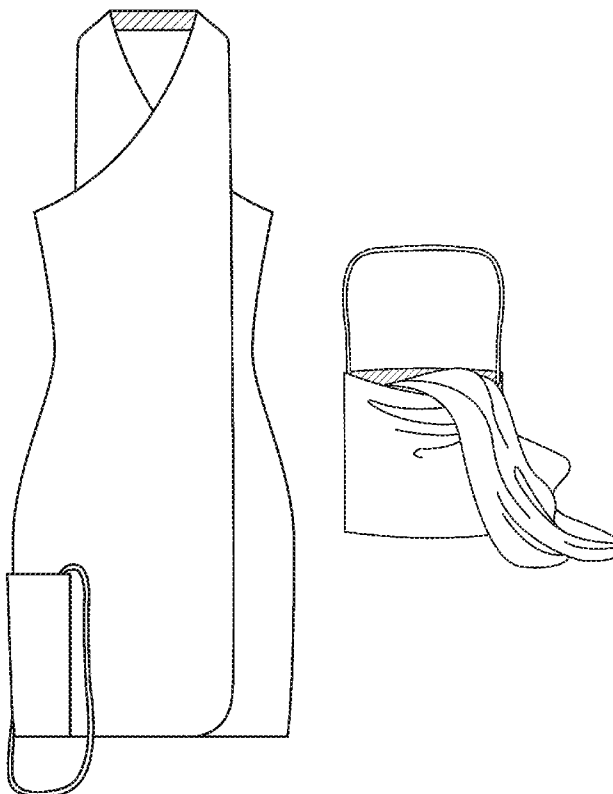

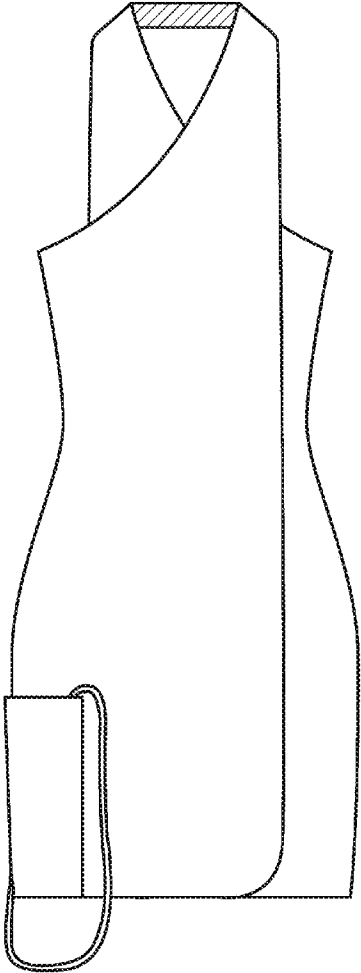

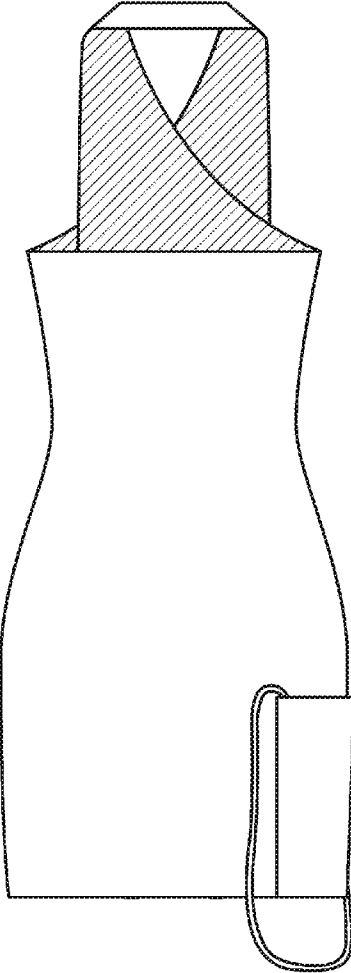

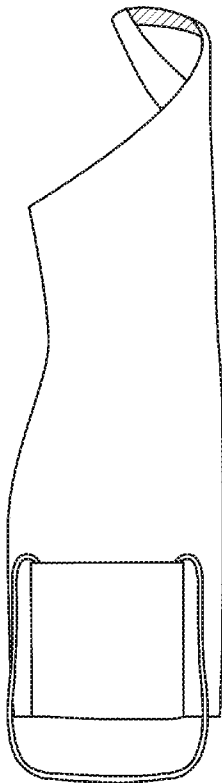

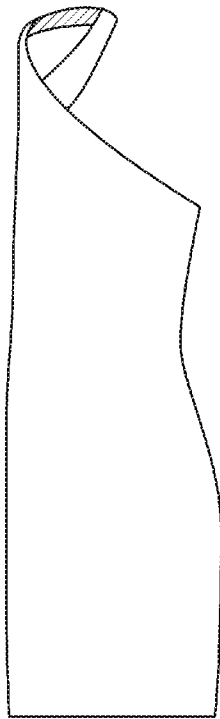

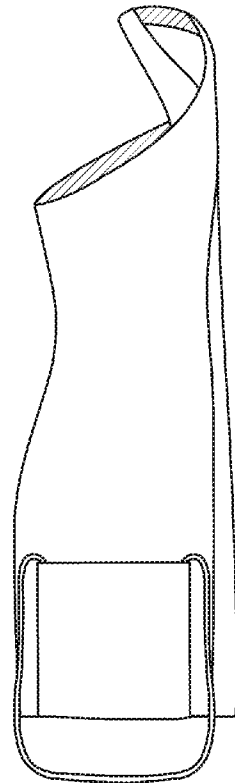

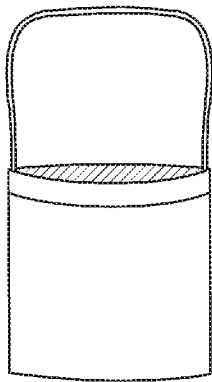

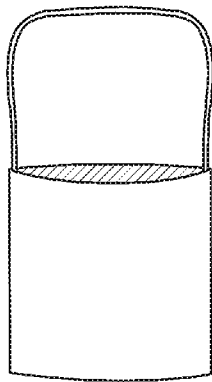
