DESCRIPTION

FIG. 13 is a top view of the golf club head of FIG. 9;

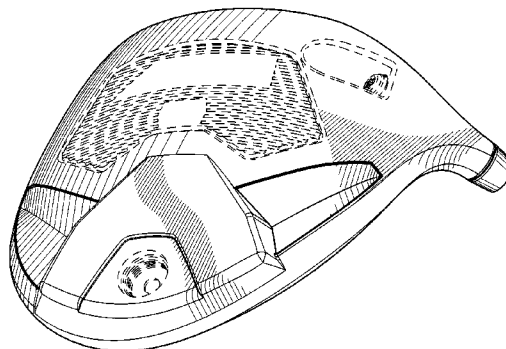
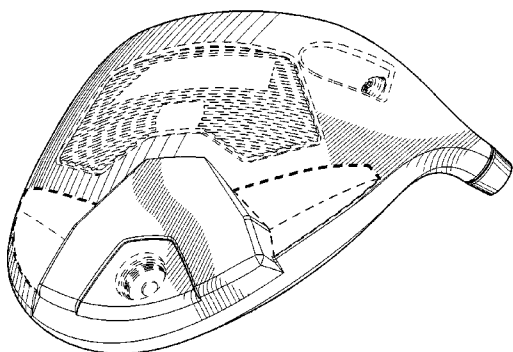
FIG. 14 is a bottom view of the golf club head of FIG. 9;

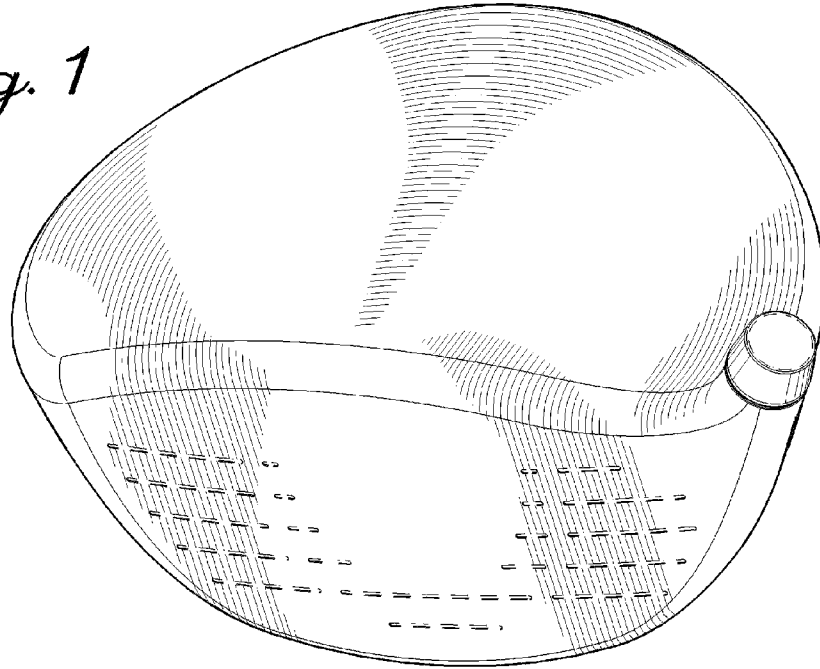

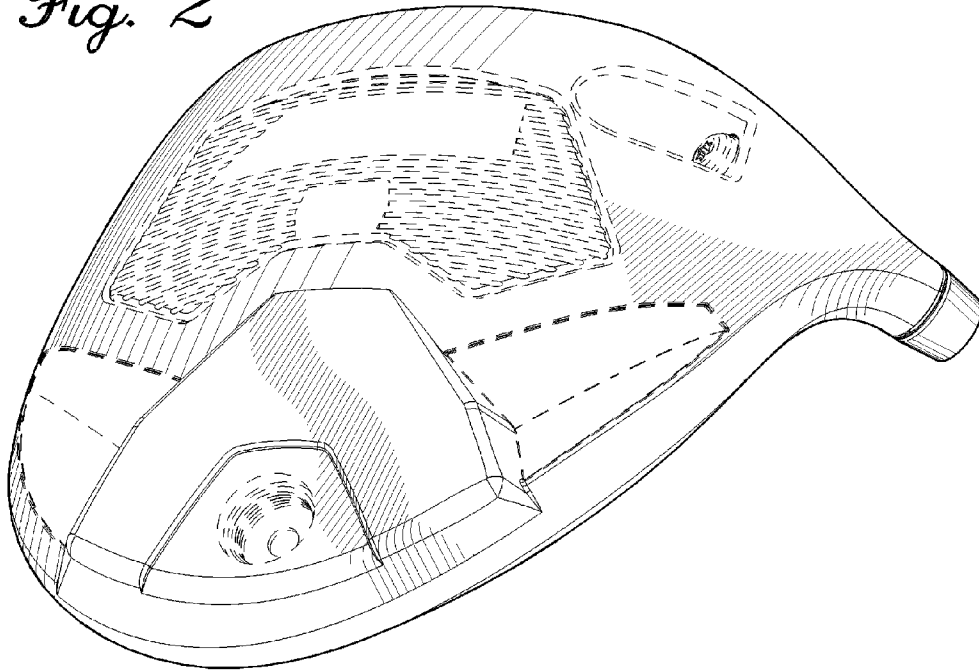

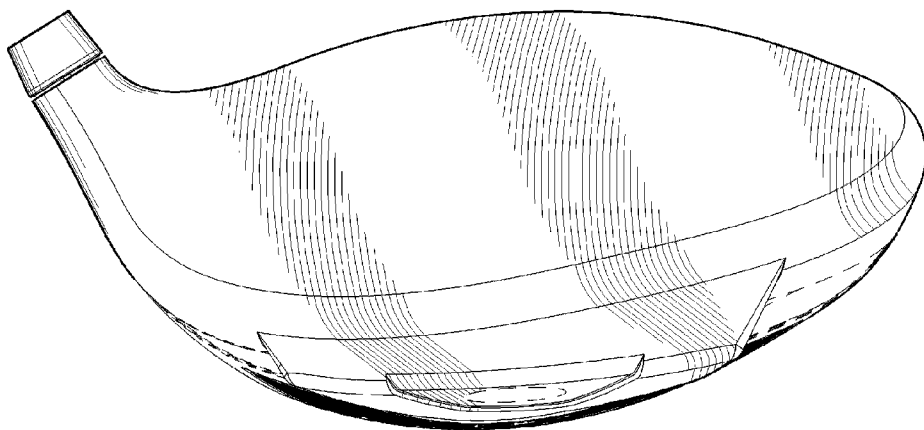
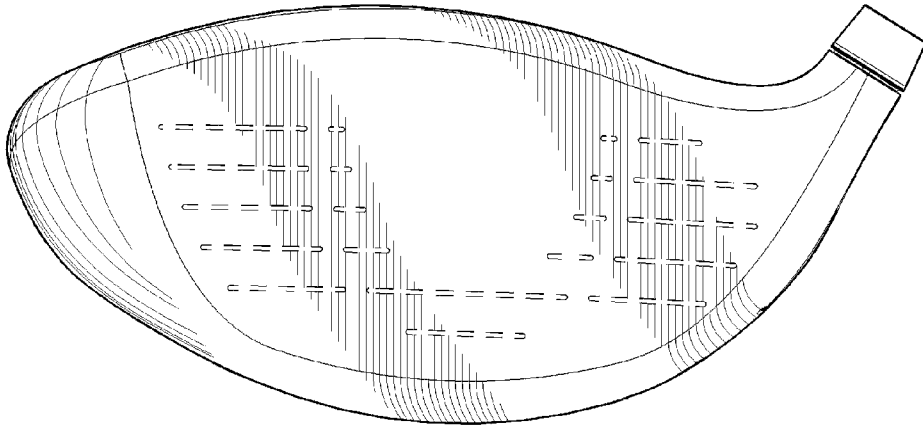

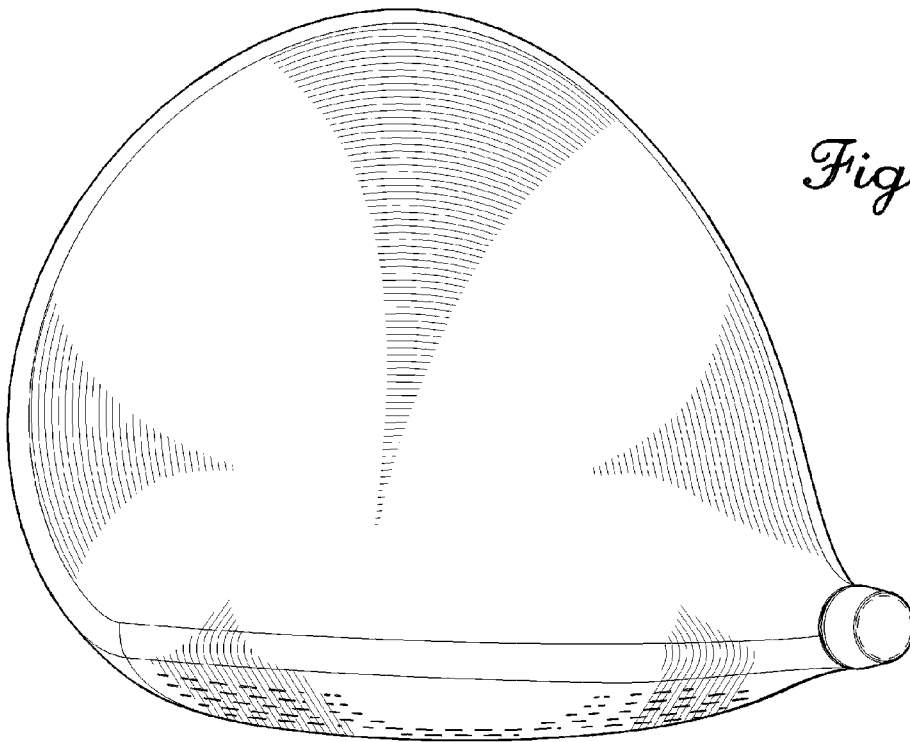

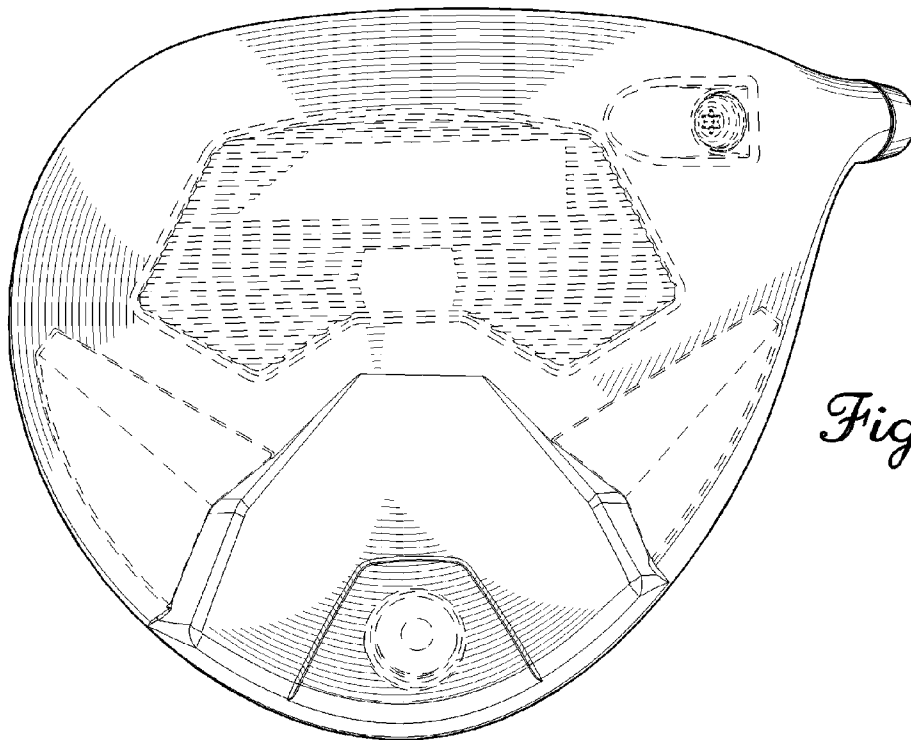

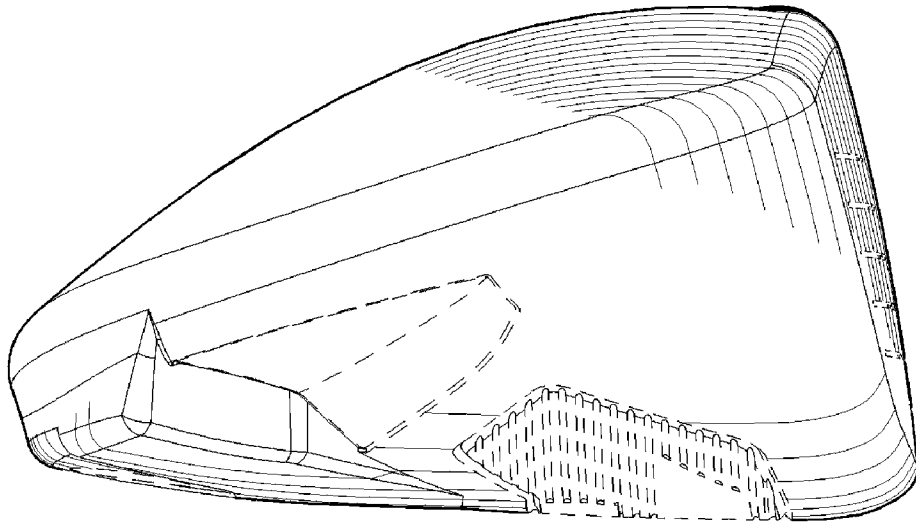

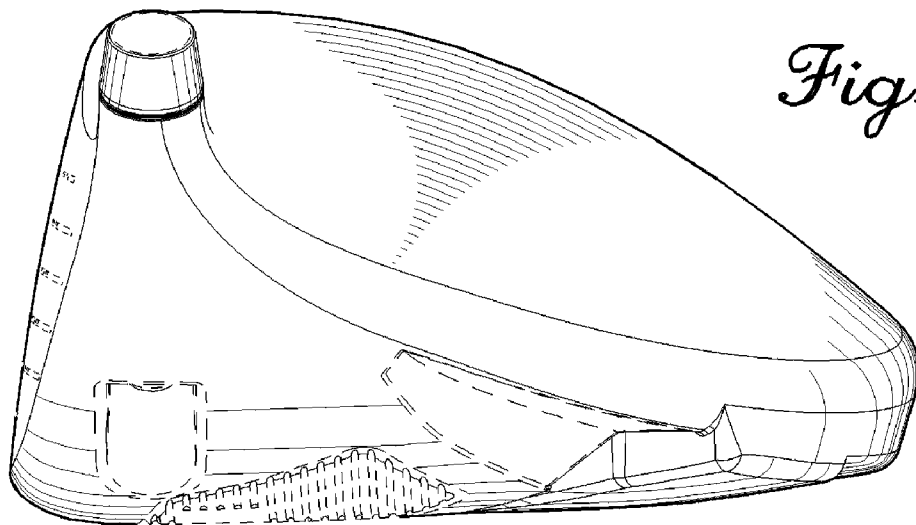

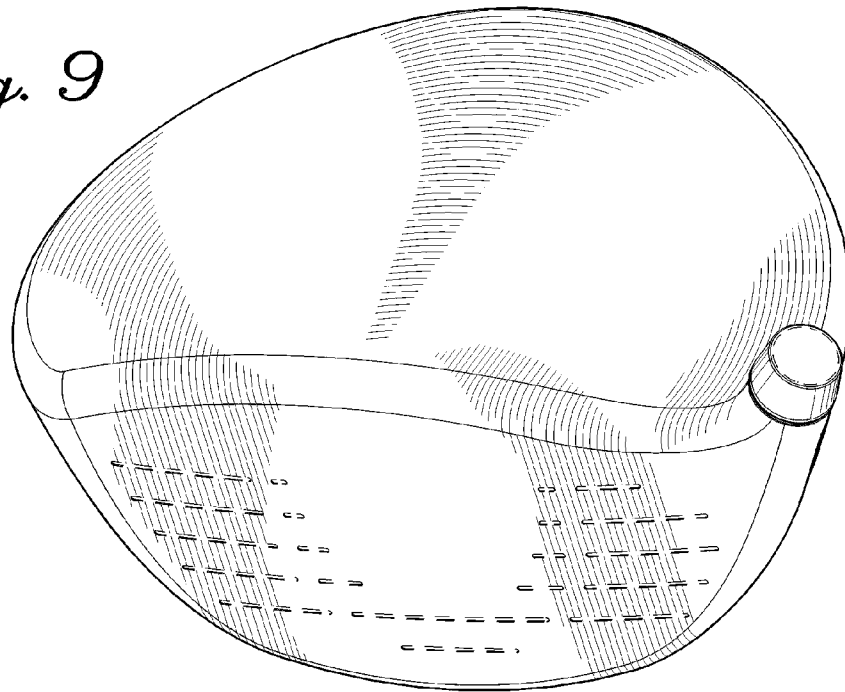
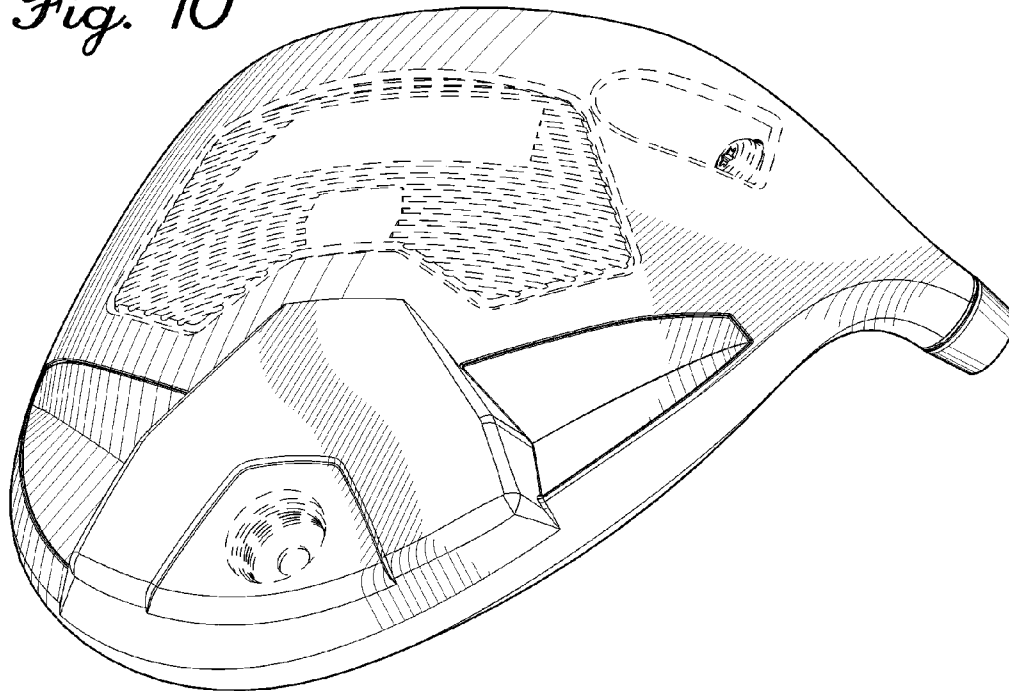

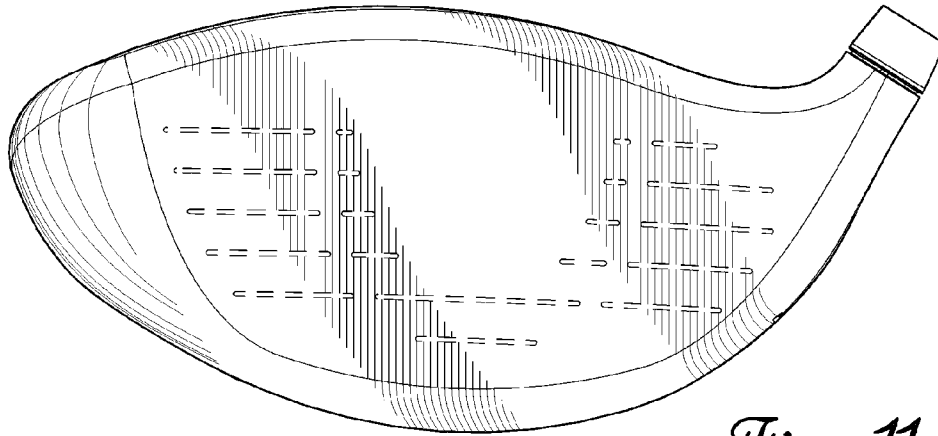

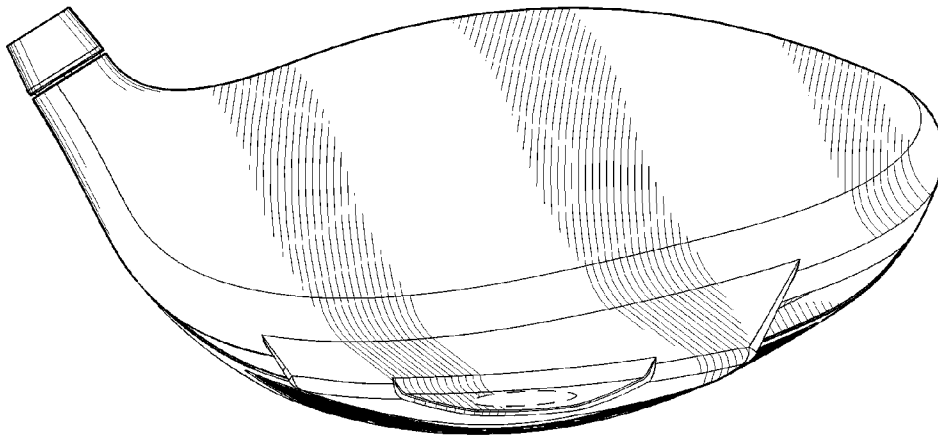

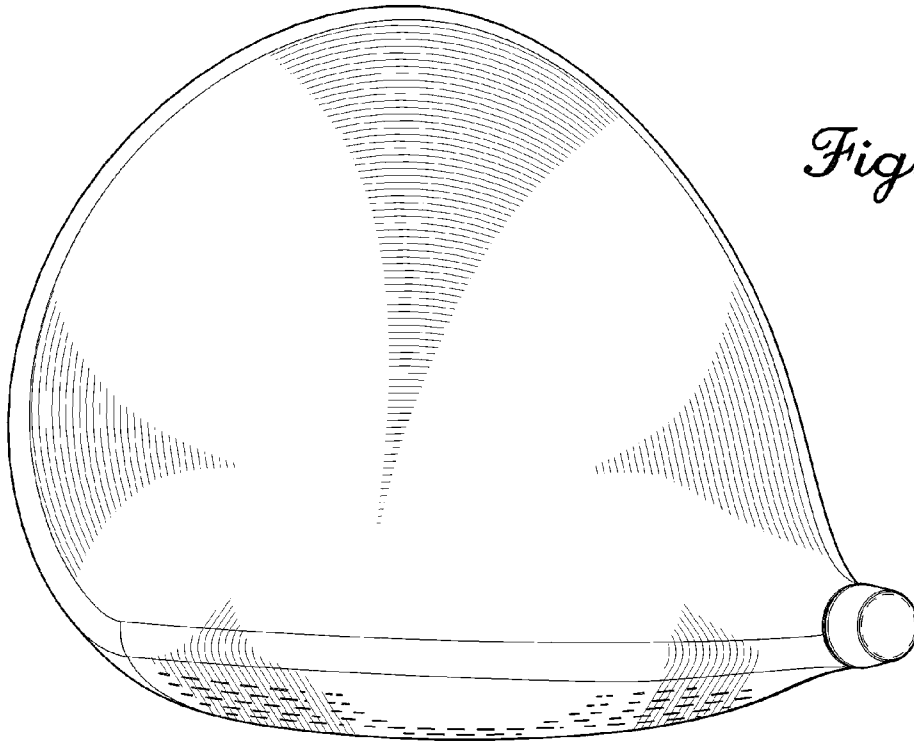

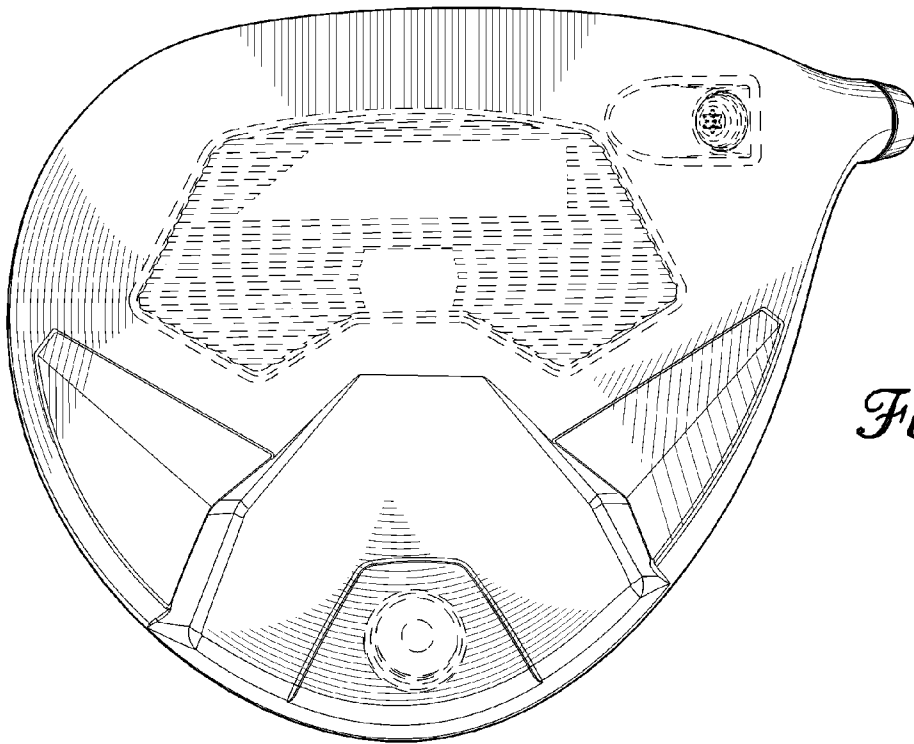

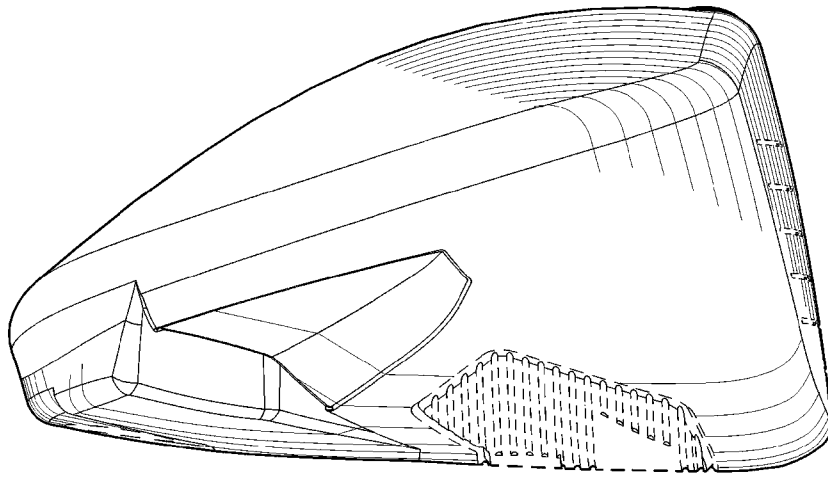
