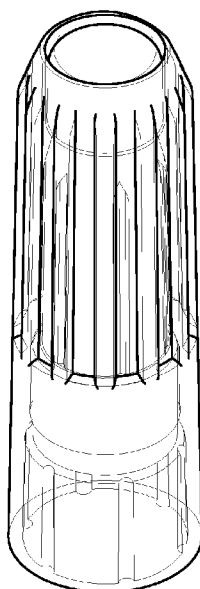
(57) **CLAIM**

The ornamental design for a syringe cap, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the syringe cap;  
FIG. 2 is a perspective view thereof;  
FIG. 3 is a front view thereof, the rear view being identical;  
FIG. 4 is a top view thereof;  
FIG. 5 is a bottom view thereof;  
FIG. 6 is a right side view thereof, the left side view being identical;  
FIG. 7 is an enlarged sectional view taken along line 7-7 of FIG. 3;  
FIG. 8 is an enlarged sectional view taken along line 8-8 of FIG. 3; and,  
FIG. 9 is a reference view showing the actual use of the syringe cap.  
The portions shown in broken lines do not form part of the design.

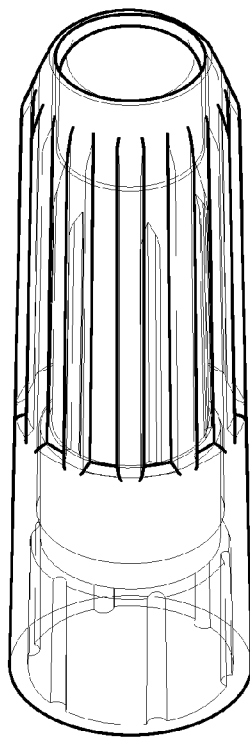

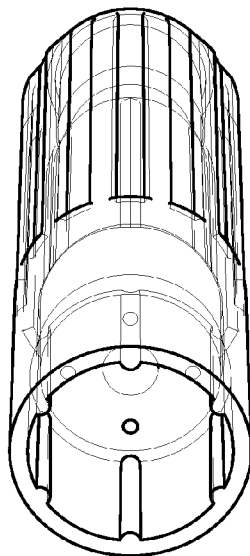

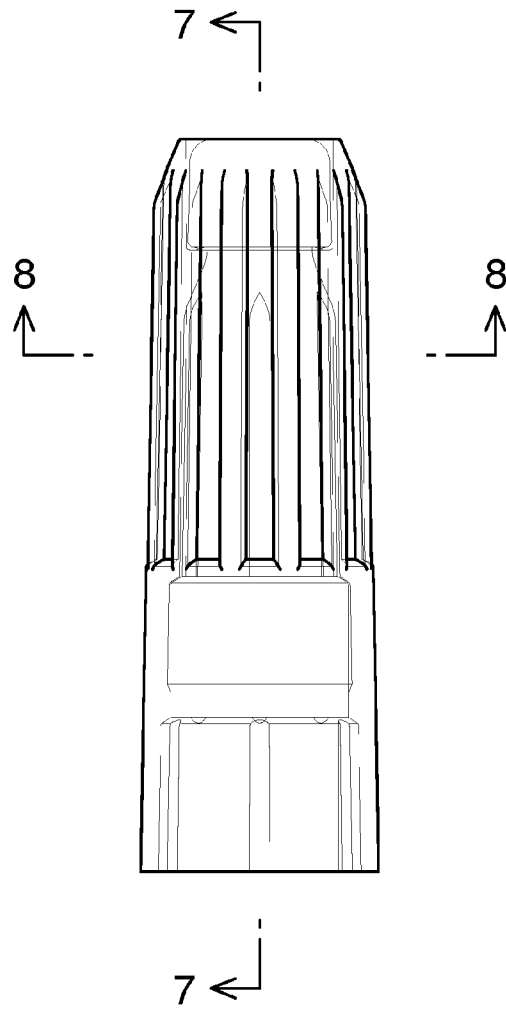

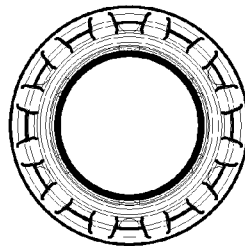

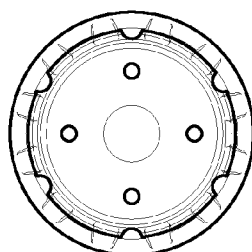

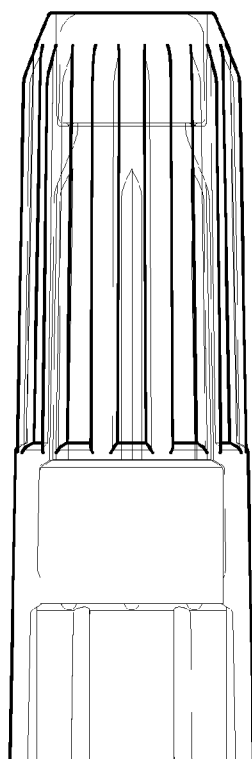

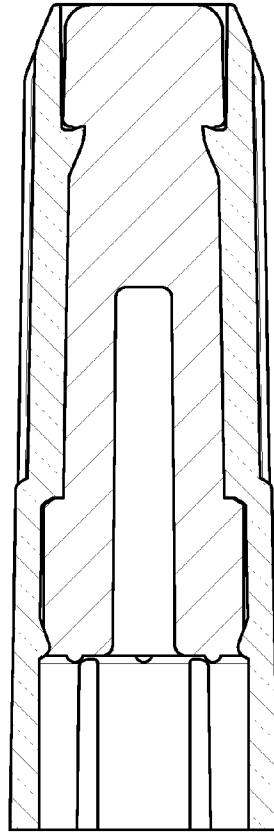

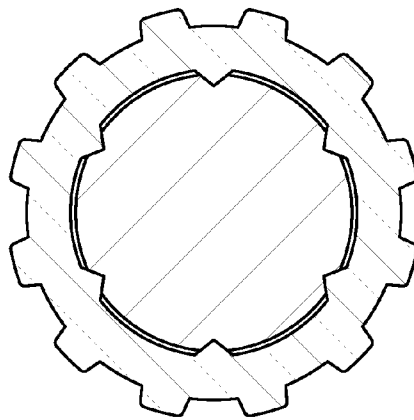
