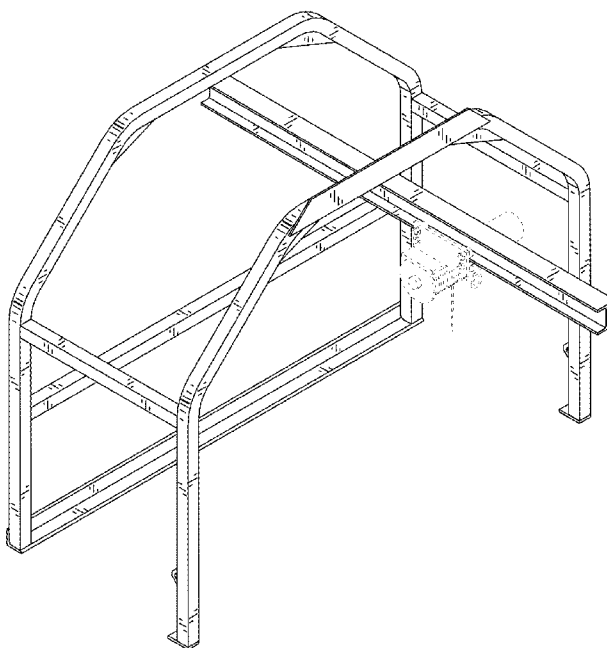

FIG. 2 is a front view of the lift for utility vehicle;
FIG. 3 is a first side view of the lift for utility vehicle;
FIG. 4 is a top view of the lift for utility vehicle;
FIG. 5 is a rear view of the lift for utility vehicle;

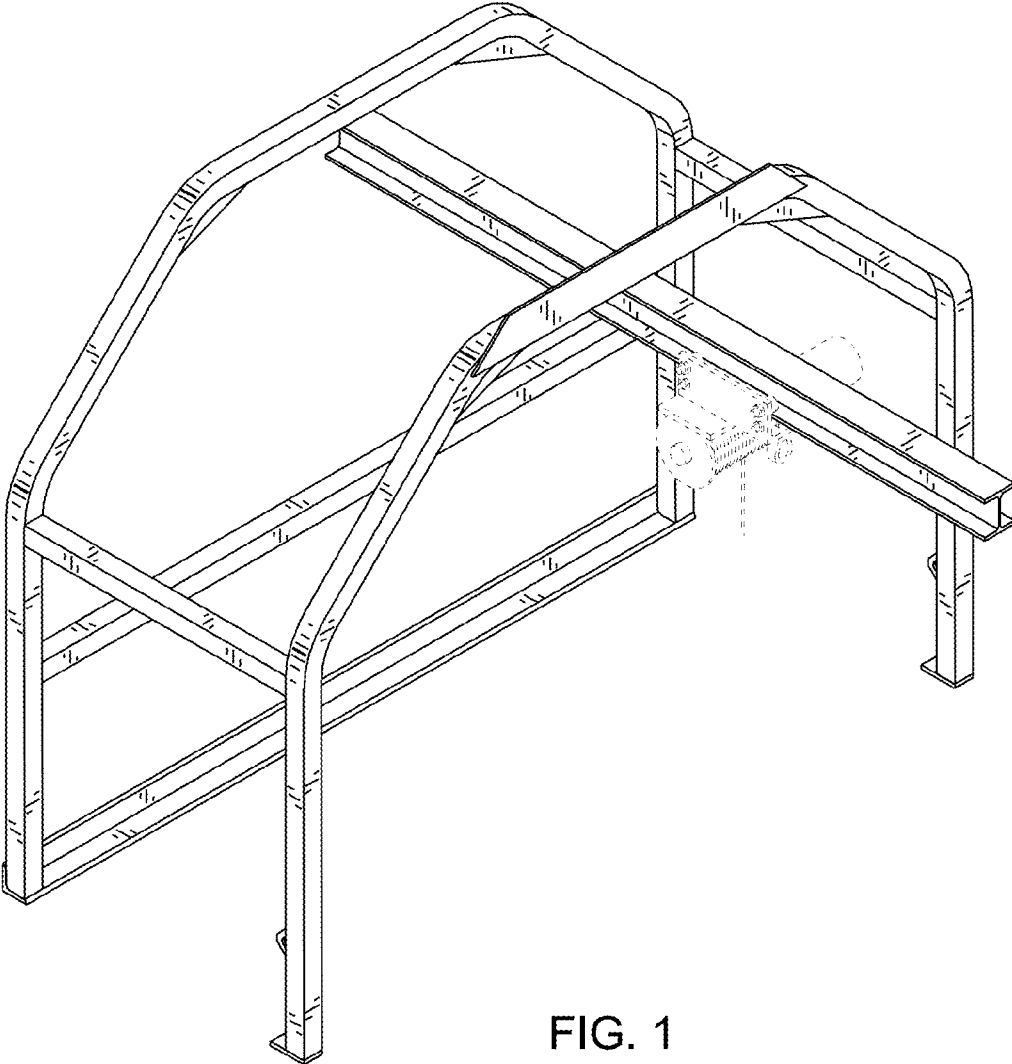

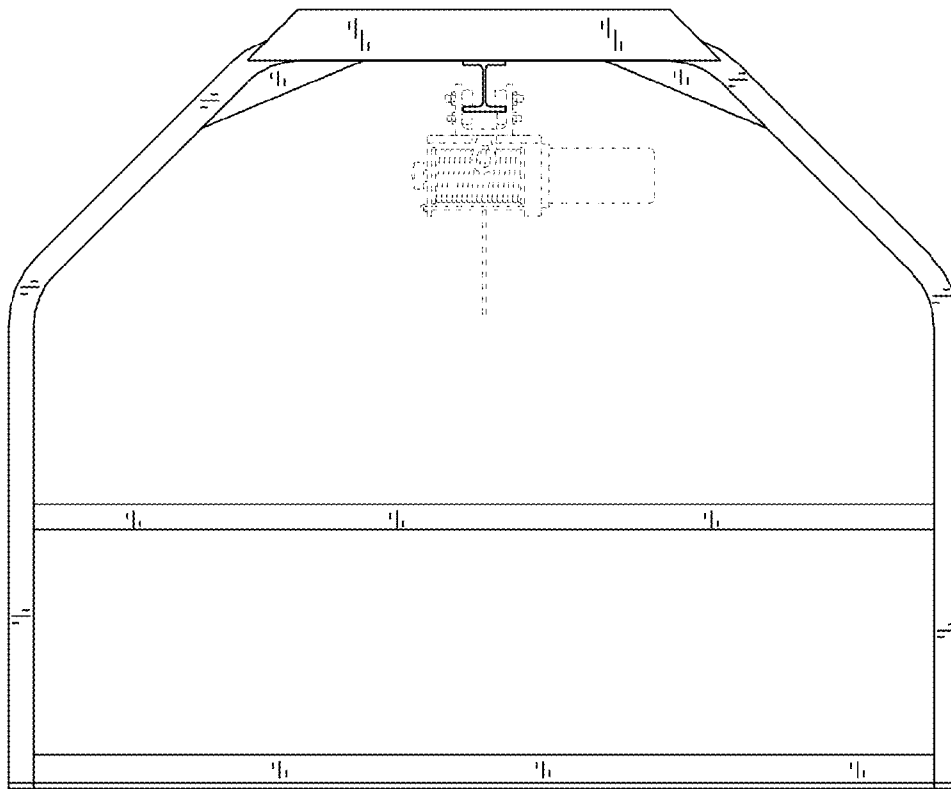

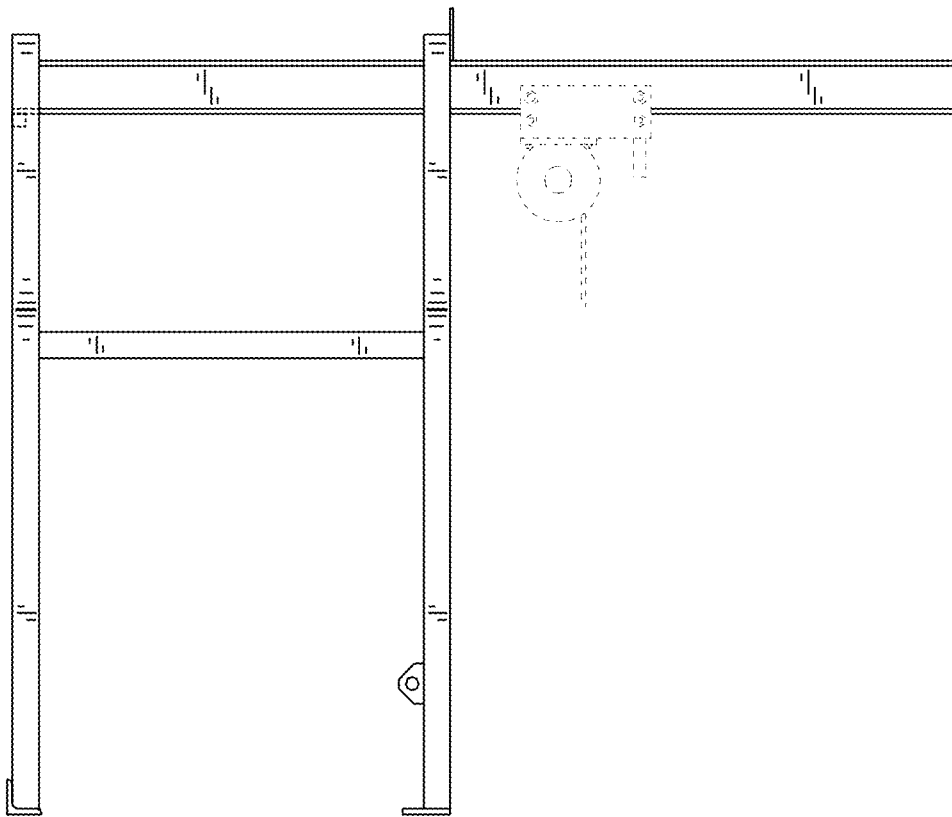

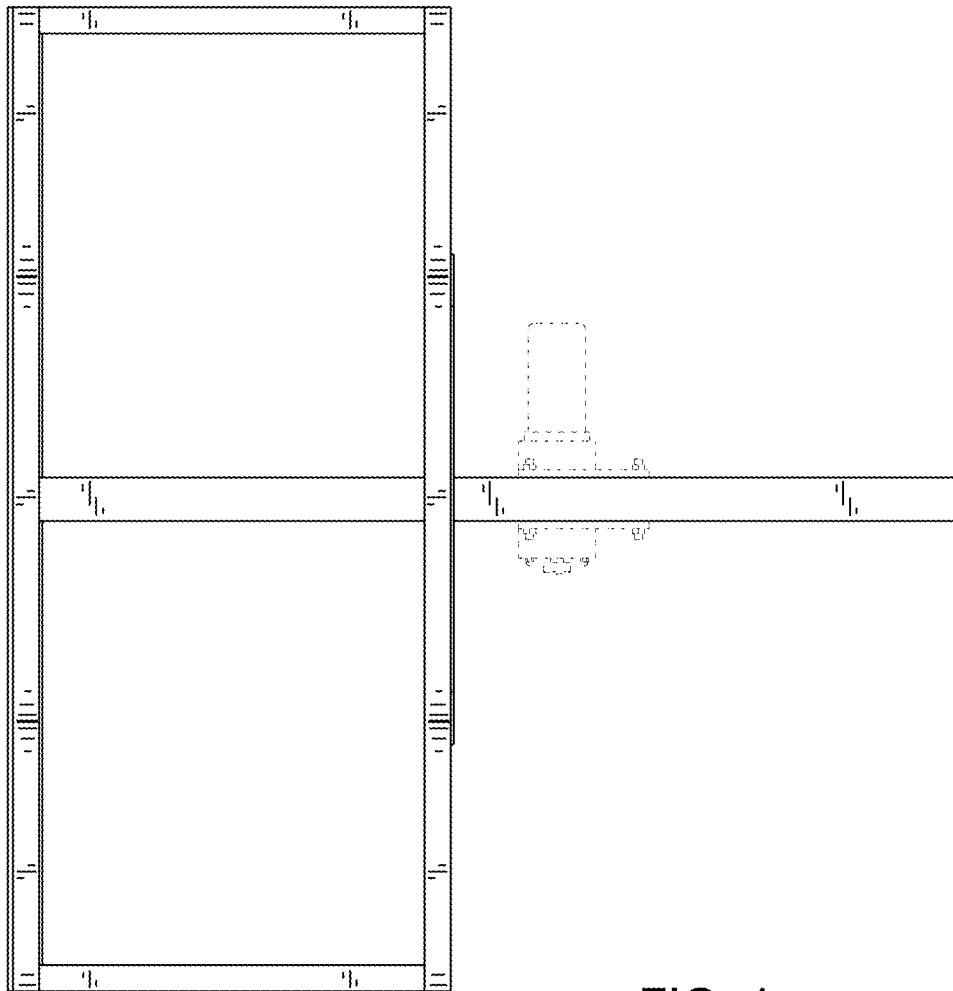

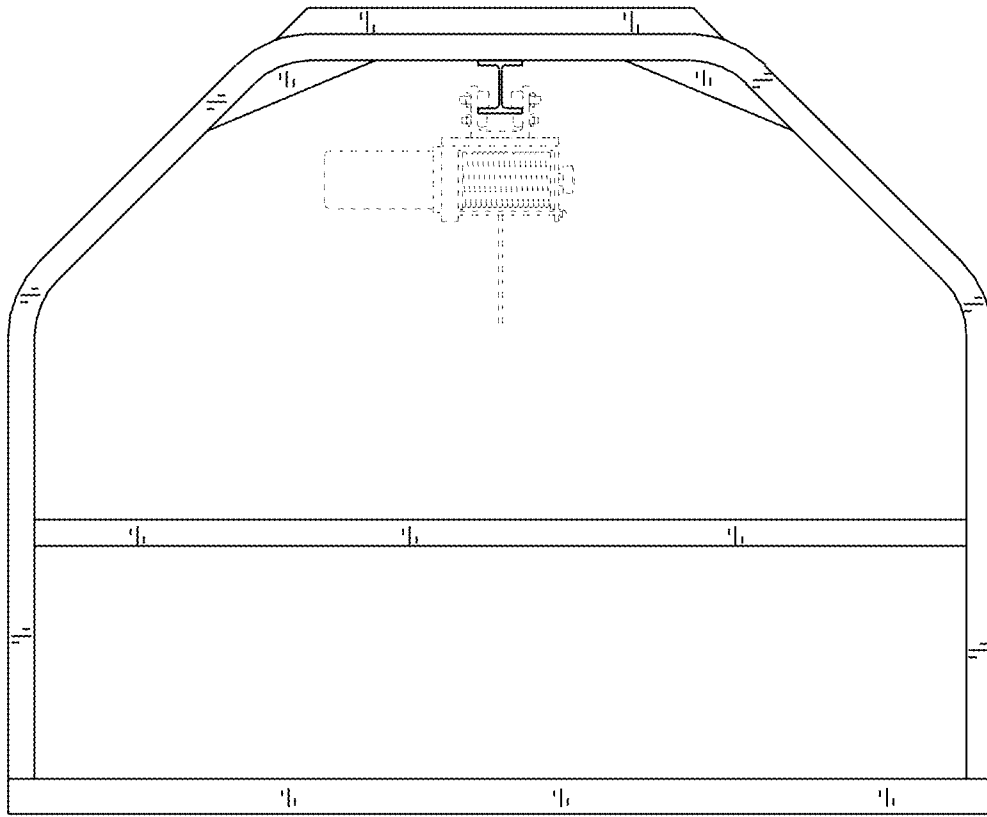

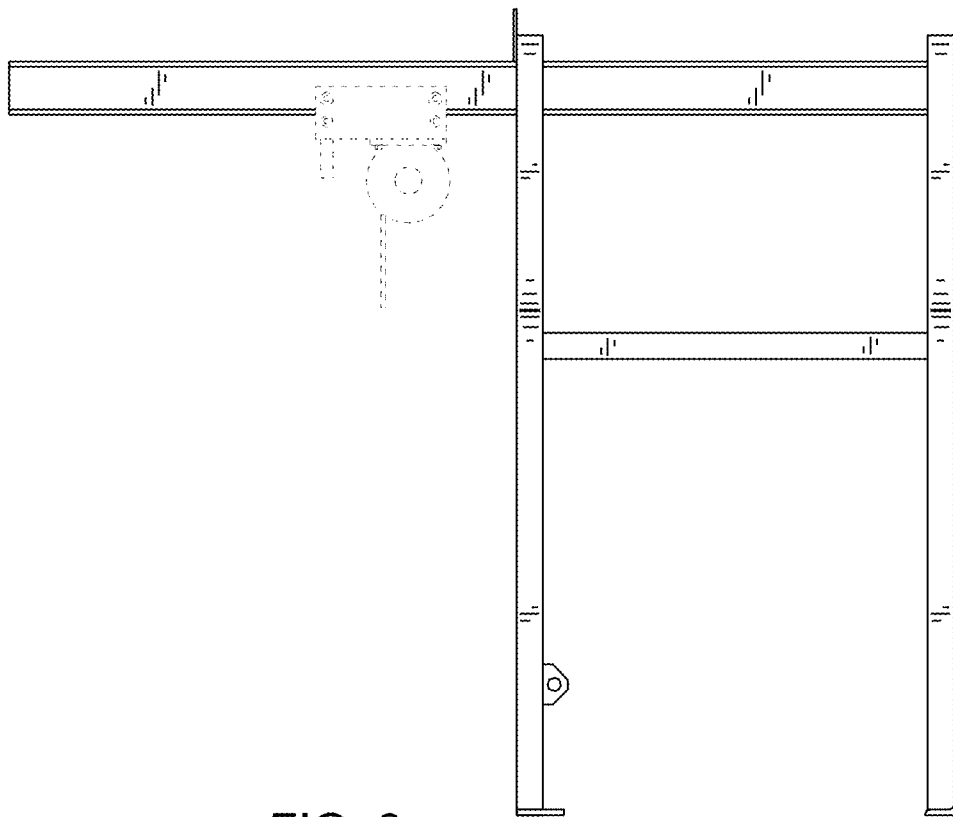

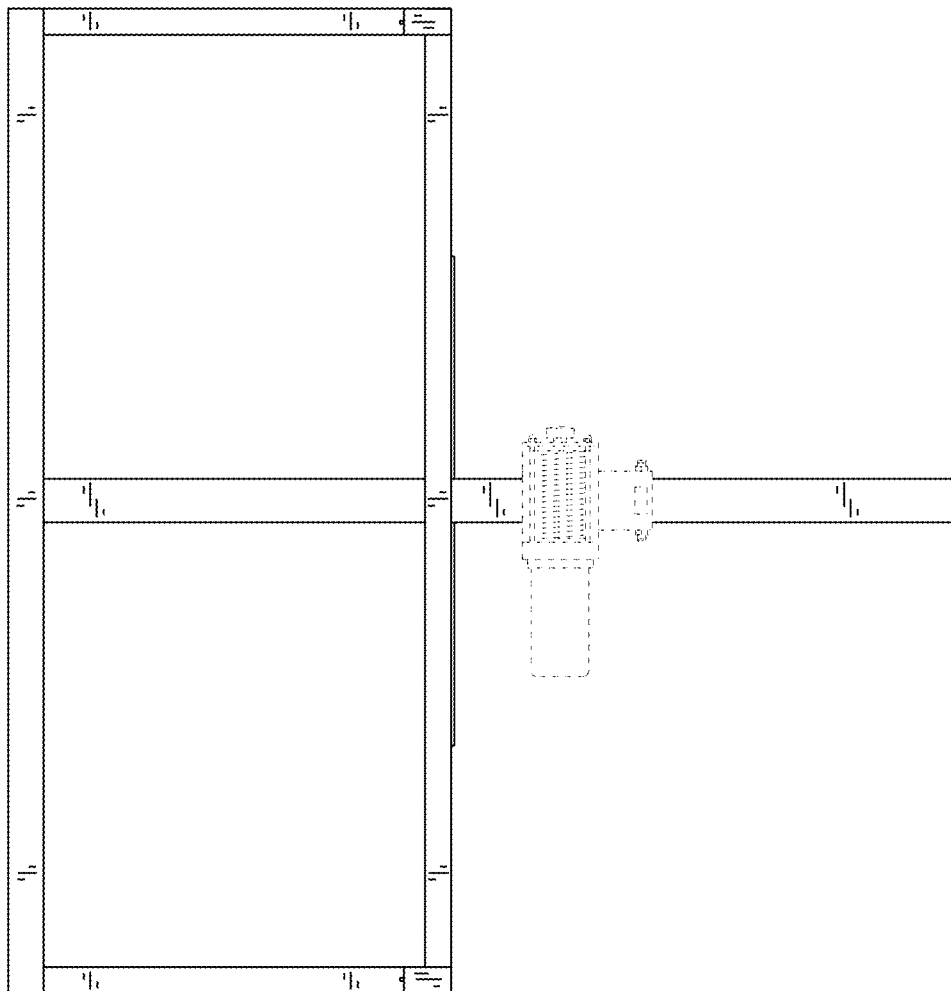
