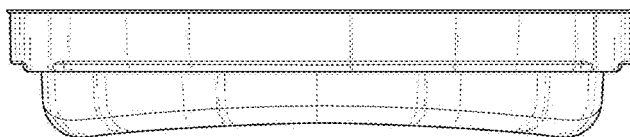
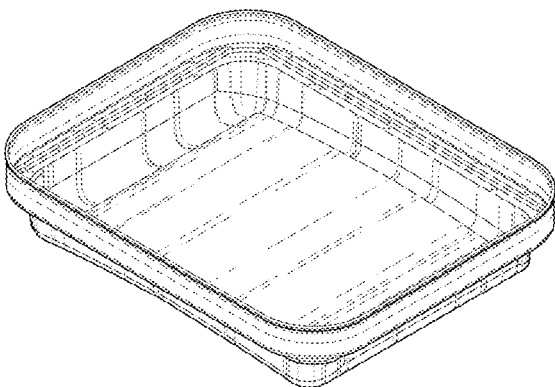
(57) **CLAIM**

The ornamental design for a transport tray, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, right side perspective view of a transport tray showing my new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a left side elevational view thereof, the right side elevational view being a mirror image thereof;  
FIG. 4 is a rear elevational view thereof, the front elevational view being a mirror image thereof; and,  
FIG. 5 is a bottom plan view thereof.

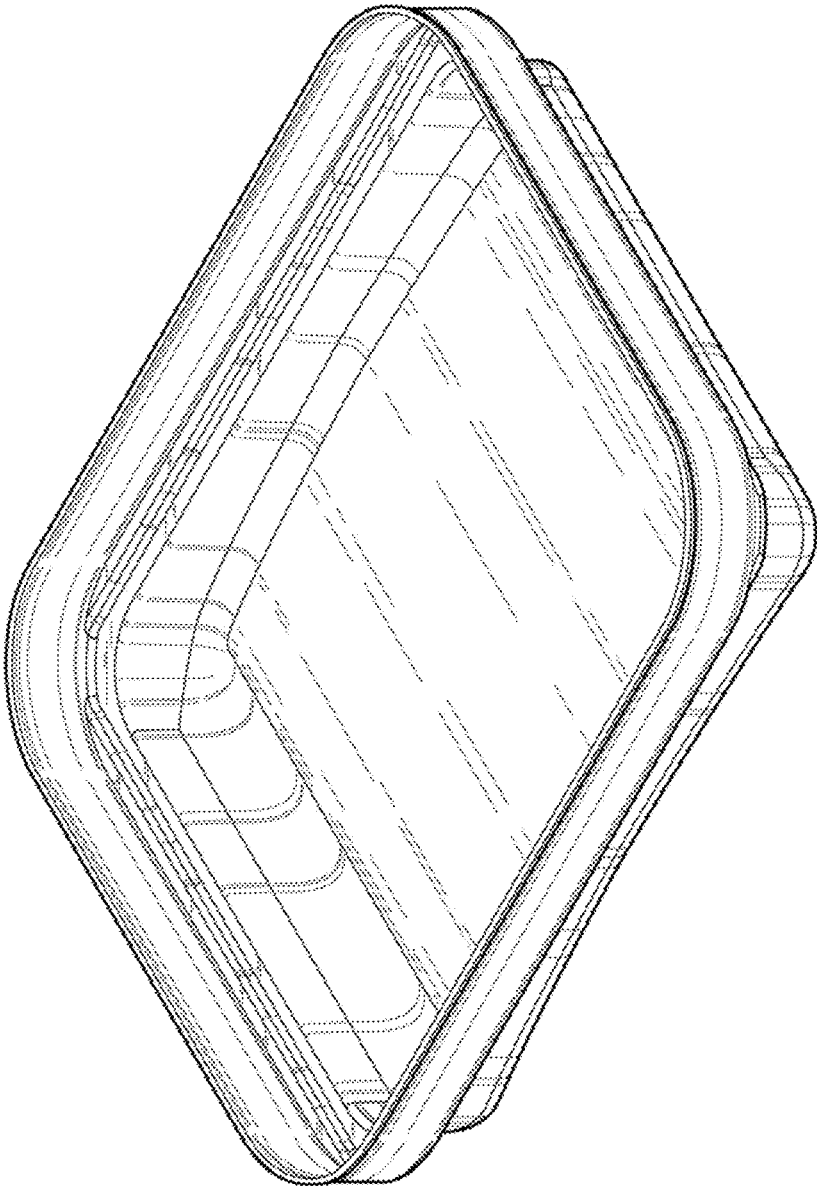

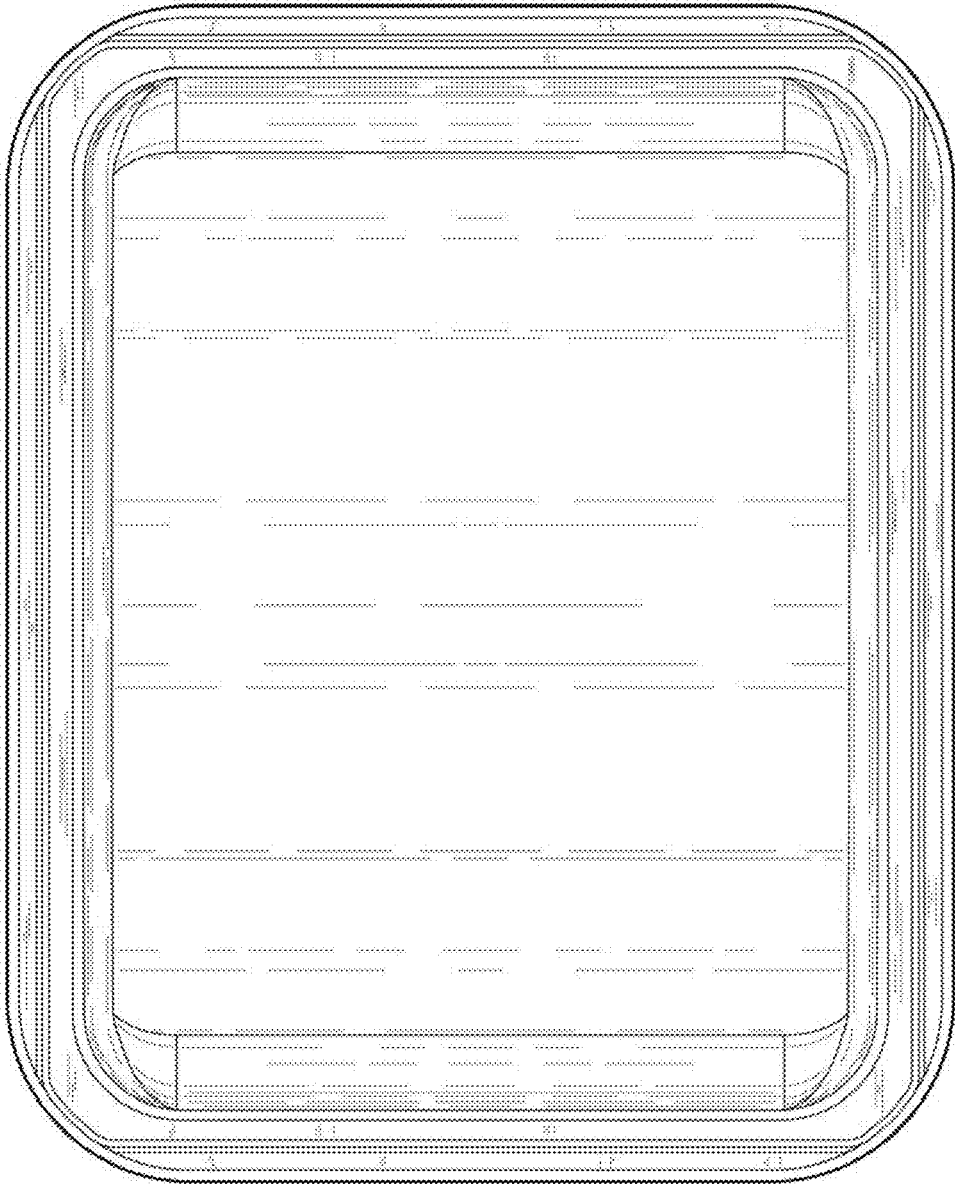

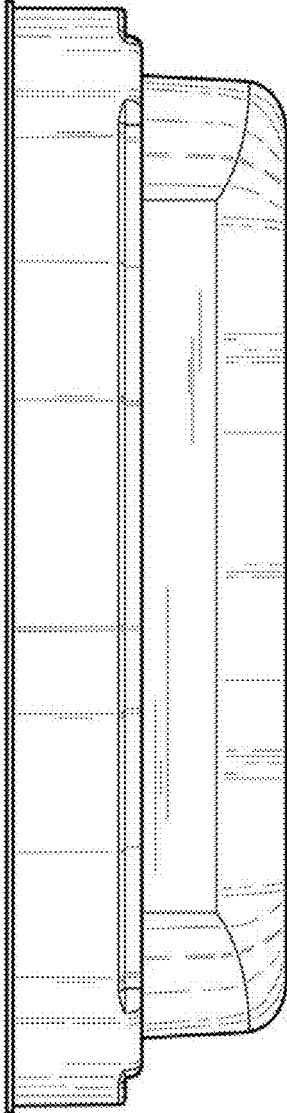

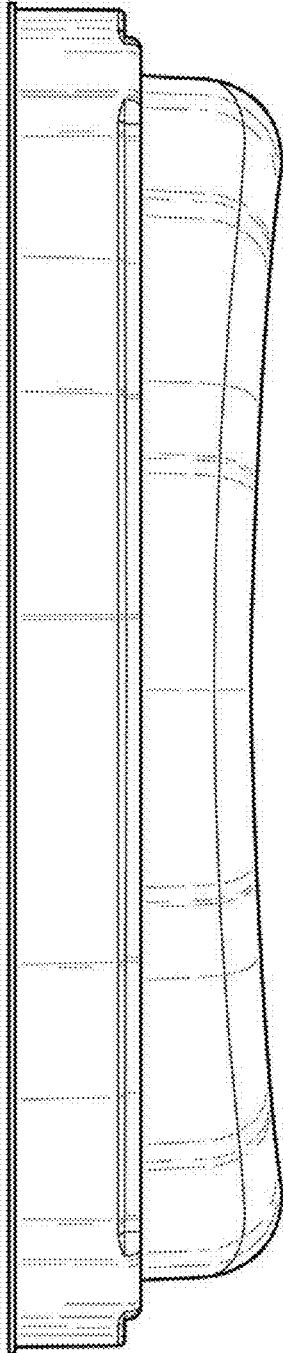

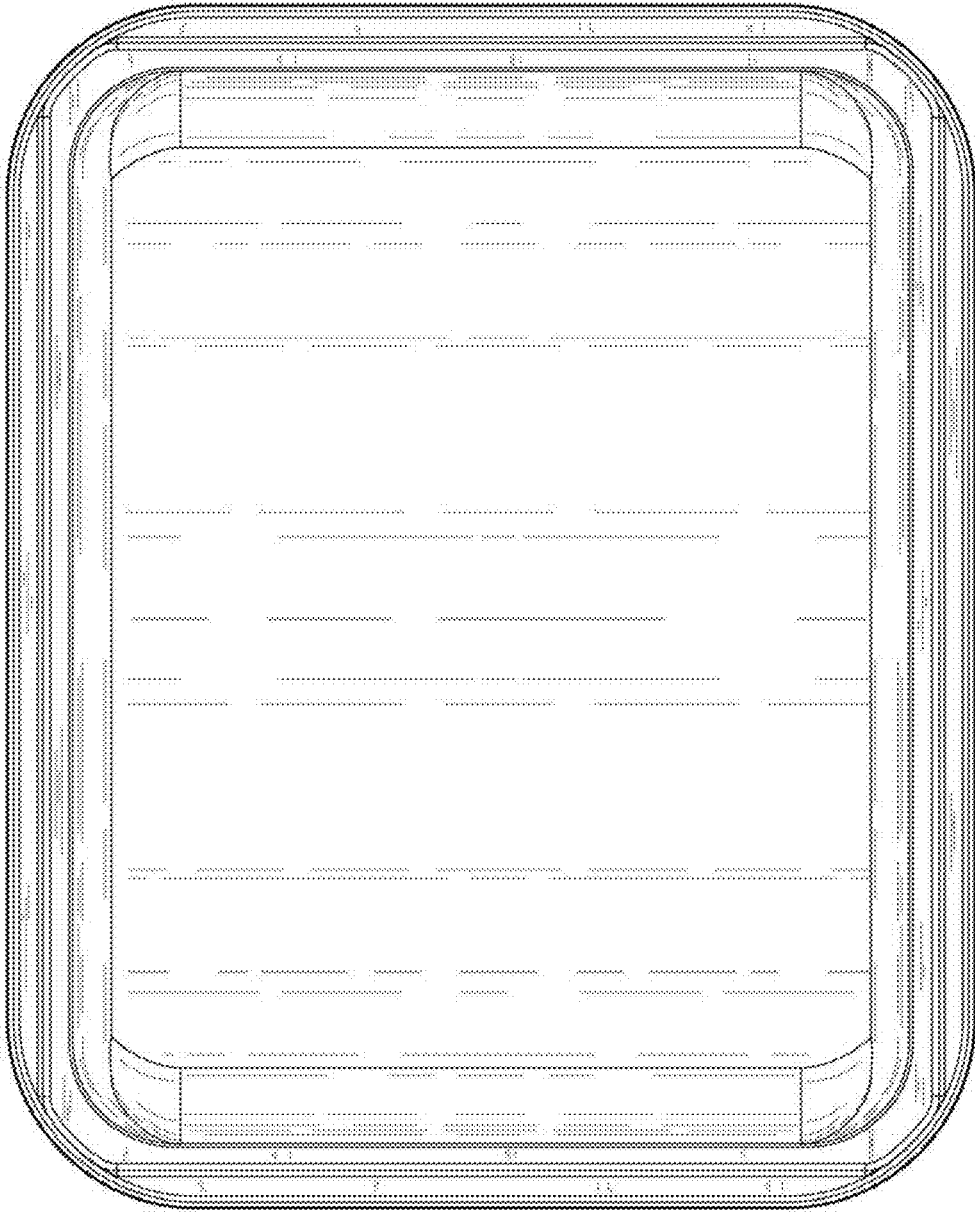
