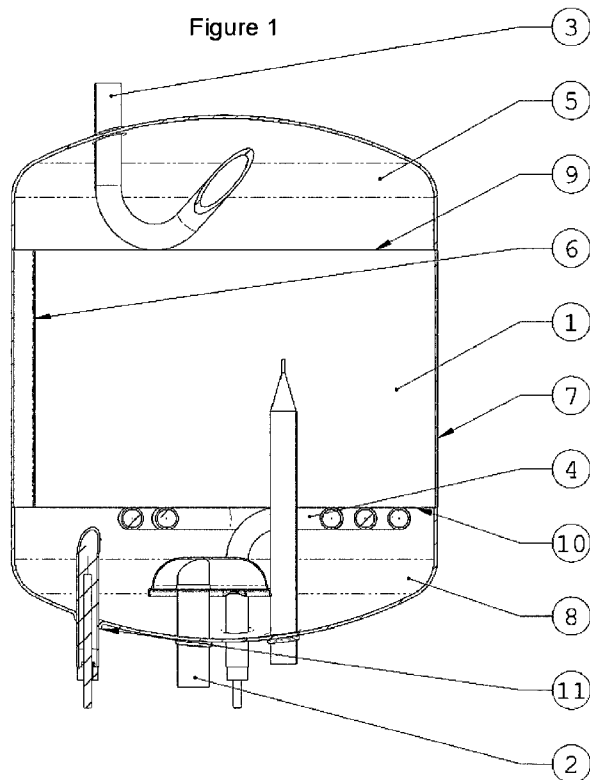

(57) Abstract: Apparatus for heating and supplying hot and/or boiling tap water of at least 80 °C, comprising a main water supply connector (2) for connecting the apparatus to a main water pipe, and furthermore a water storage and heating tank, which tank has a bottom and a top, in which the tank has an inlet which is connected to the main water supply connector, in which the inlet is provided on the bottom part of the tank, in which the tank furthermore has an outlet which is provided on the top part of the tank, which outlet can be connected to a tap, and in which an electrical water heating element (3) is fitted in the water tank, above the inlet. The invention is characterized by the fact that the inner surface of the water storage and heating tank is made of or coated with titanium.
