(57) **CLAIM**
We claim the ornamental design for a fitting with swivel D-ring, as shown and described.

DESCRIPTION

FIG. 1 is a first-end, top, and side perspective view showing our new design for a fitting with swivel D-ring, where the D-ring is pivoted to a top position;
FIG. 2 is a side elevational view thereof;
FIG. 3 is a second-end, top, and side perspective view thereof;
FIG. 4 is a first-end elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a first-end, top, and side perspective view thereof showing the D-ring pivoted to an end position;
FIG. 7 is a side elevational view thereof;
FIG. 8 is a second-end, top, and side perspective view thereof;
FIG. 9 is second-end elevational view thereof; and,
FIG. 10 is a top plan view thereof.

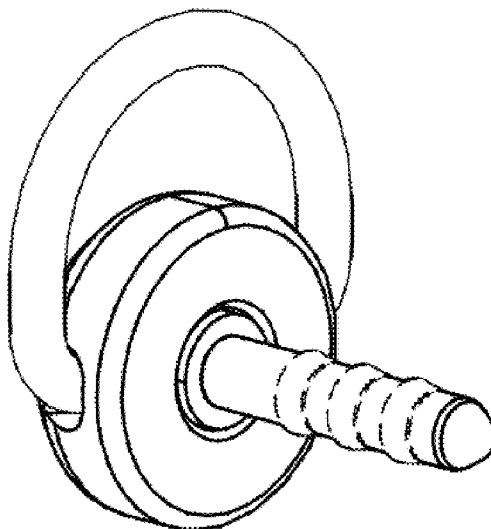

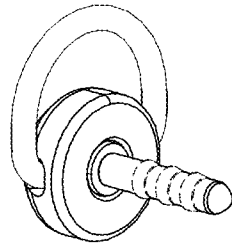

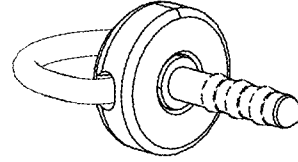

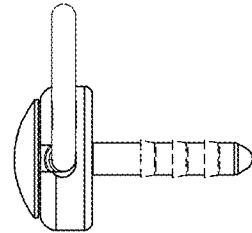

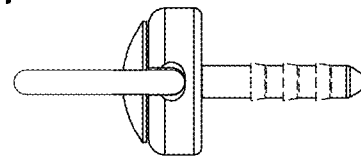

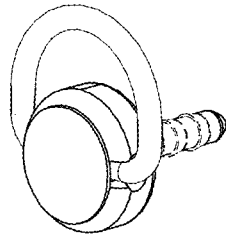

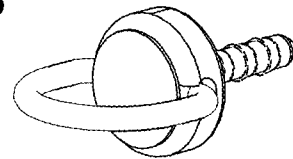

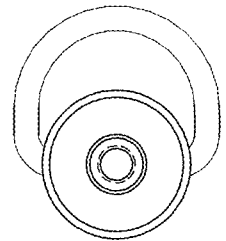

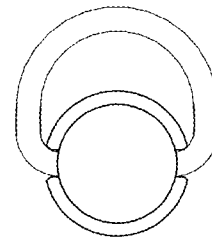

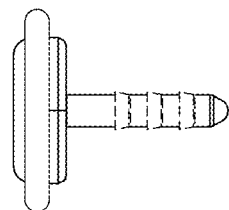
