
(57) **CLAIM**

The ornamental design for a battery, as shown and described.

DESCRIPTION

FIG. 1 is a top and right front perspective view of a battery, showing our design;
 FIG. 2 is a front elevational view of the battery;
 FIG. 3 is a rear elevational view of the battery;
 FIG. 4 is a left side elevational view of the battery;
 FIG. 5 is a right side elevational view of the battery;
 FIG. 6 is a top plan view of the battery, rotated ninety degrees clockwise; and,
 FIG. 7 is a bottom plan view of the battery, rotated ninety degrees counterclockwise.
 The phantom lines shown in the figures are included for the purpose of illustrating environmental structure and form no part of the claimed design.










