FIG. 4 is a rear elevational view thereof;

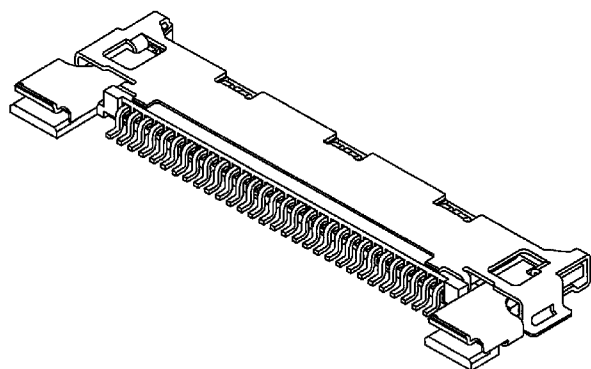
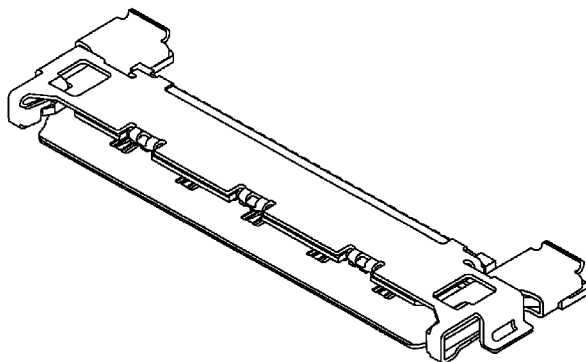
FIG. 5 is a right side elevational view thereof, the left side elevational view being a mirror image of the right side elevational view;

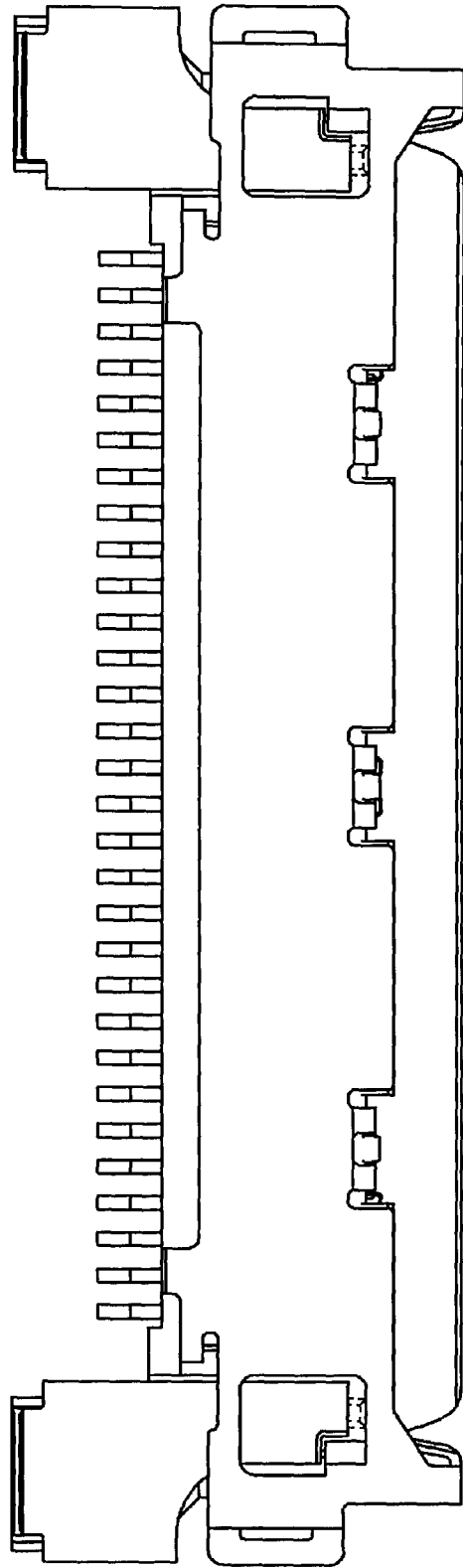

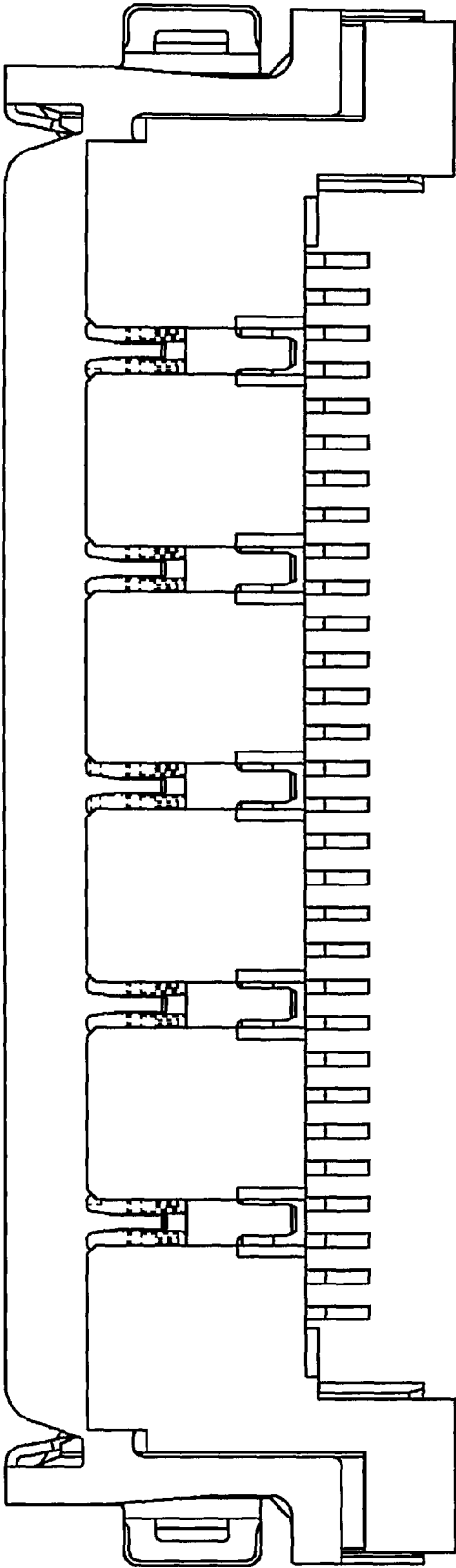

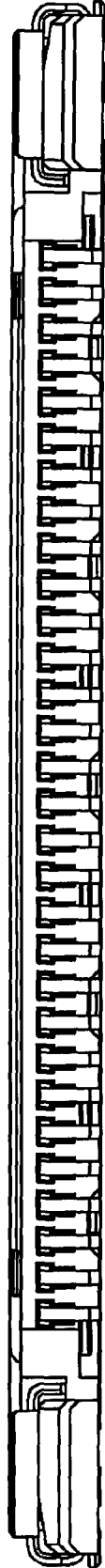

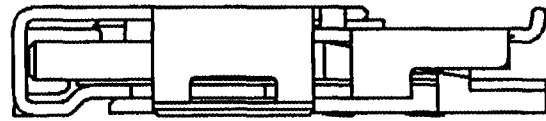

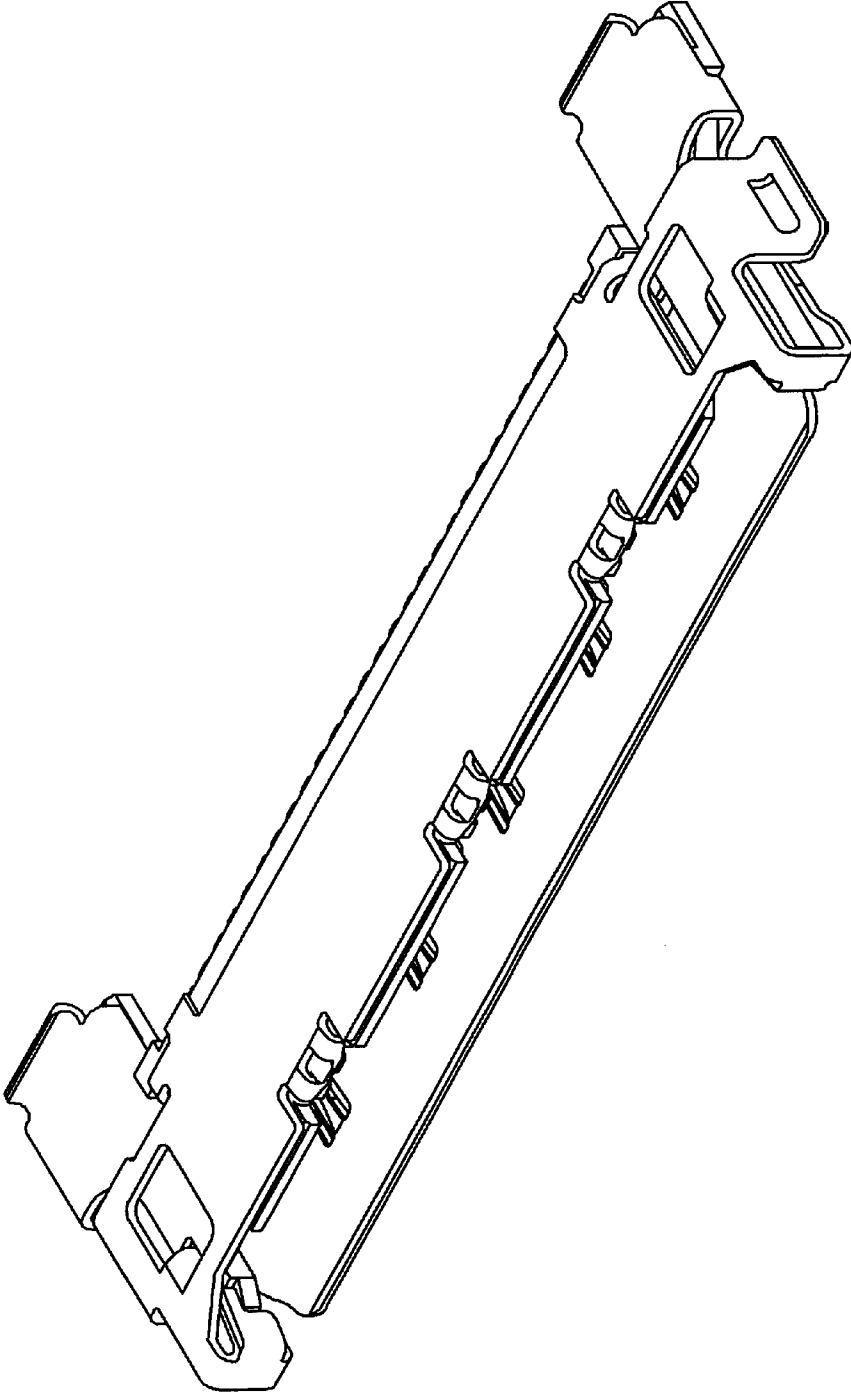

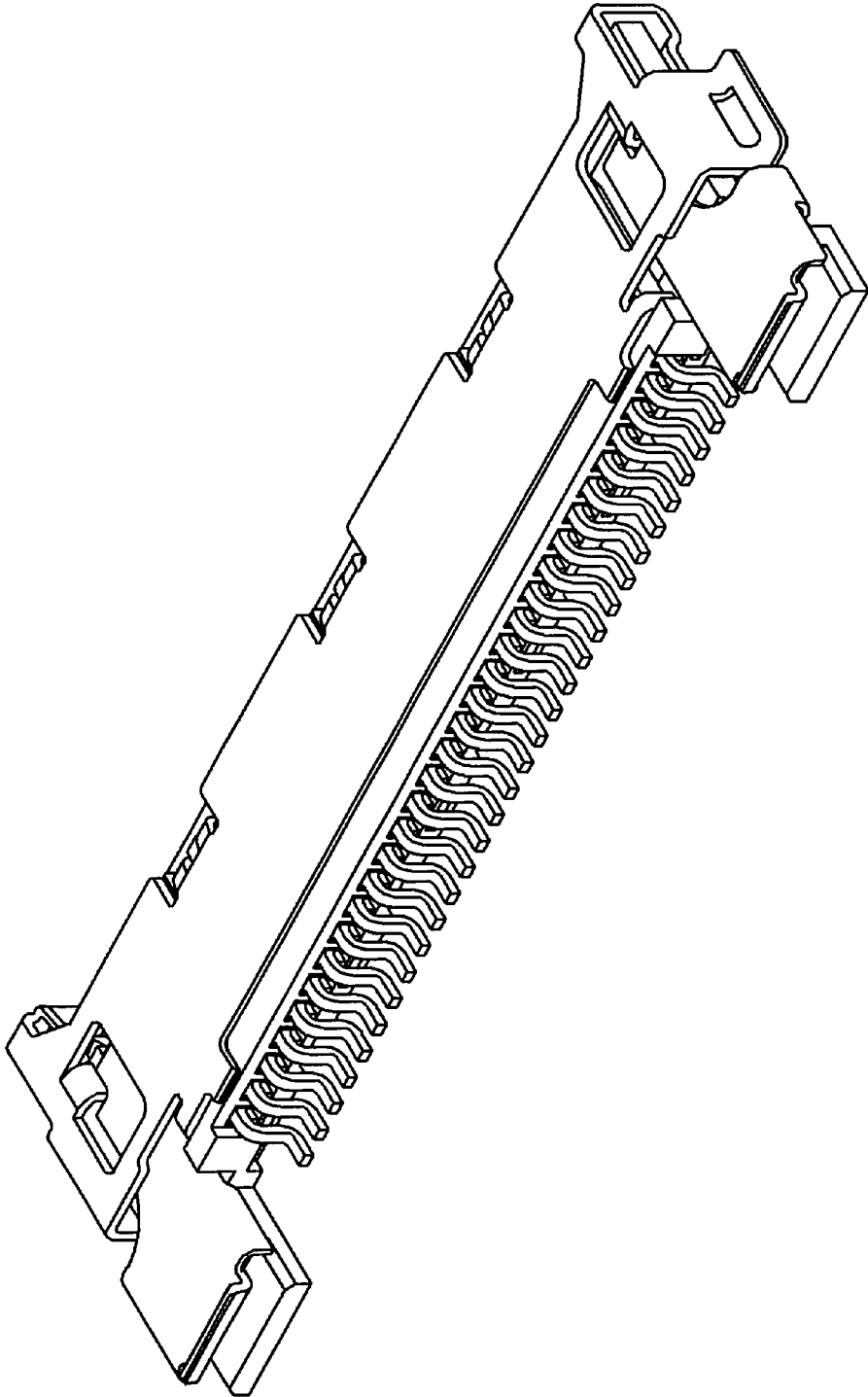
