(57) **CLAIM**

The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

DESCRIPTION

The FIGURE is a front view of a display screen or portion thereof with graphical user interface showing our new design. The broken lines around the FIGURE showing a display screen or portion thereof form no part of the claimed design. The broken lines within the FIGURE show portions of the graphical user interface which form no part of the claimed design. The dot-dash lines in the FIGURE and the areas within the dot-dash lines show portions of the graphical user interface which form no part of the claimed design.
