(57) **CLAIM**

The ornamental design for a toy block, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the toy block of this design; FIG. 2 is a front view thereof, the bottom plan view being a mirror image thereof;

FIG. 3 is a top plan view thereof, the bottom plan view being a mirror image thereof;

FIG. 4 is a rear view thereof;

FIG. 5 is a right side view thereof;

FIG. 6 is a left side view thereof;

FIG. 7 is a sectional view taken along line 7—7 of FIG. 2;

FIG. 8 is a sectional view taken along line 8—8 of FIG. 5;

FIG. 9 is a reduced perspective view showing a state of use thereof;

FIG. 10 is another reduced perspective view showing another state of use thereof; and,

FIG. 11 is a right side view showing another state of use thereof.

The broken lines shown in FIGS. 9–11 are directed to environment and are for illustrative purposes only and form no part of the claimed design.





















