ments (2,3,4) are provided with connection means (9,10) adapted to obtain a modular structure making said forms.

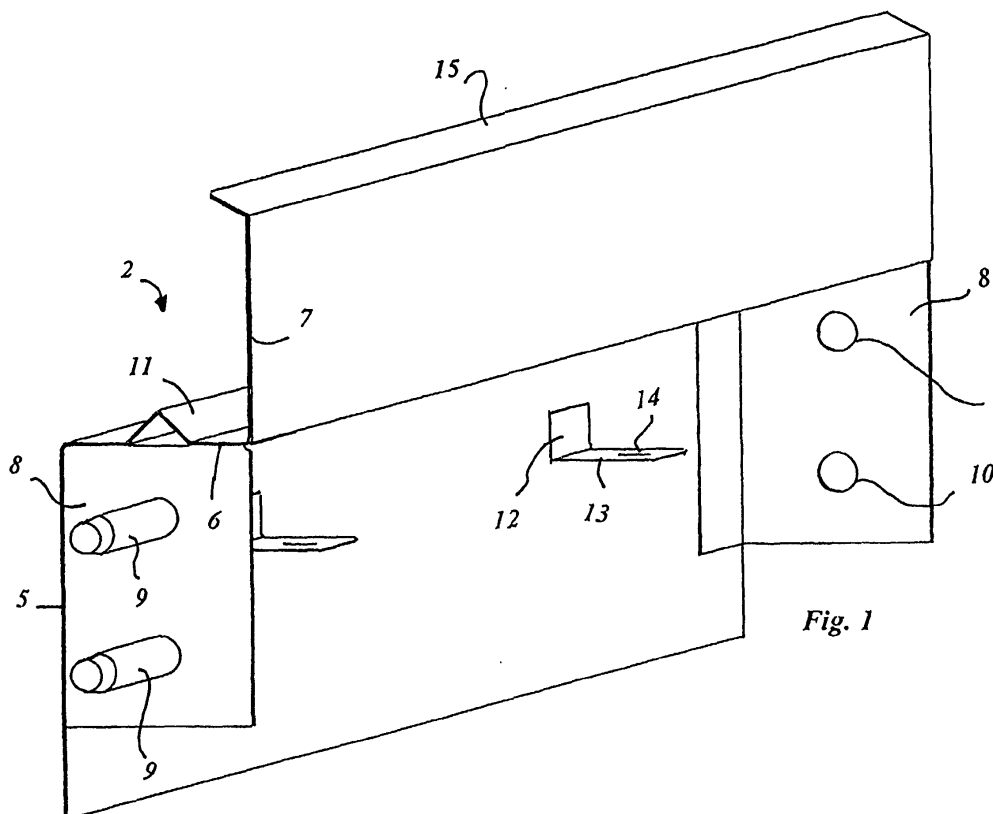
