The ornamental design for a lighting fixture, as shown and described.

DESCRIPTION

This application is related to commonly assigned, co-filed U.S. design patent application Ser. No. 29/791,096, filed on Dec. 29, 2021 by Daniel A. Montecino, entitled “Lighting Fixture”, which application is incorporated herein by reference in its entirety.

FIG. 15 is a top view thereof; and,


FIG. 16 is a bottom view thereof.
































