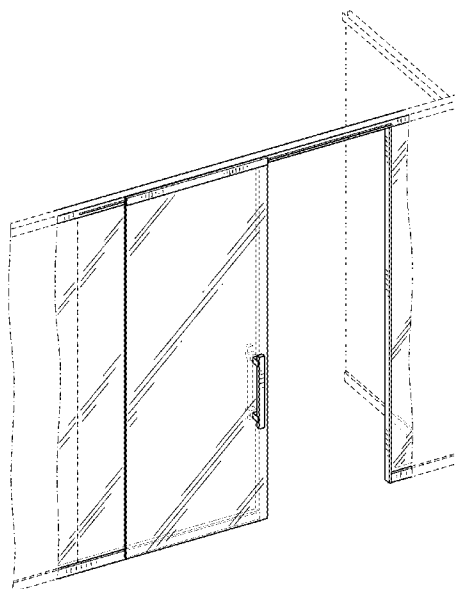
(57) **CLAIM**

The ornamental design for a combined wall panel and moveable door, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of combined wall panel and movable door;  
FIG. 2 is a magnified isometric view of the wall panel and movable door;  
FIG. 3 is a front view thereof;  
FIG. 4 is a back view thereof;  
FIG. 5 is a top view thereof; and,  
FIG. 6 is a bottom view thereof.

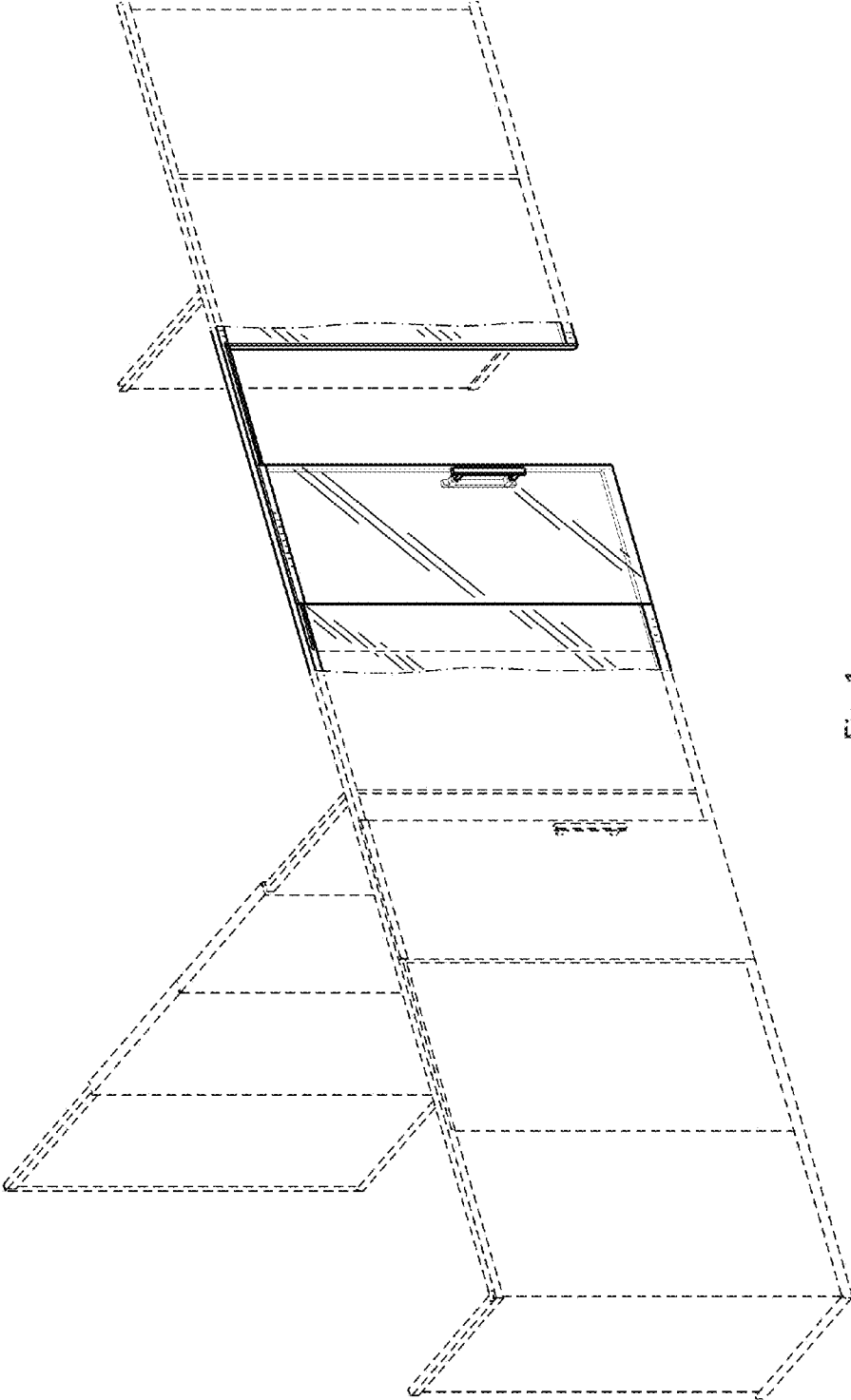

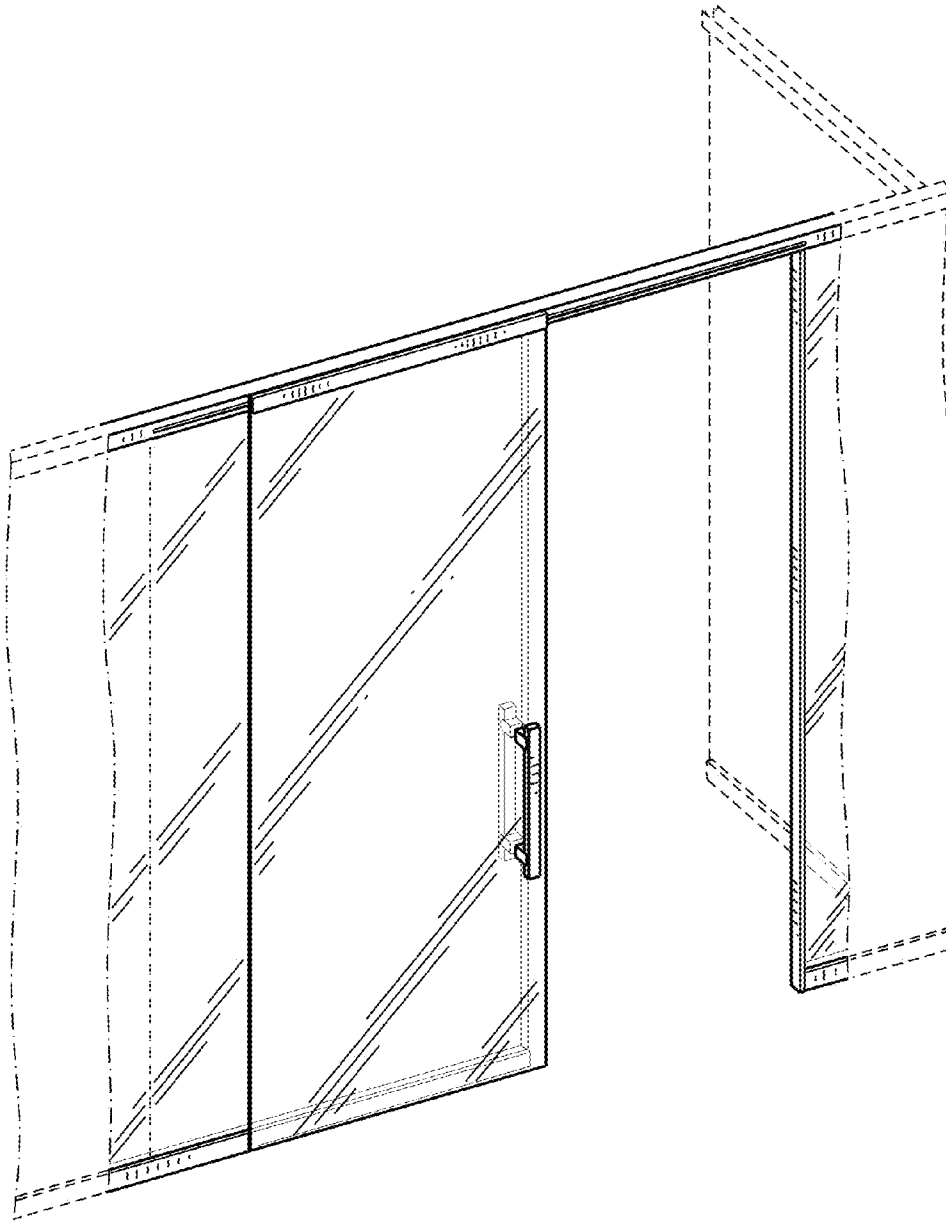

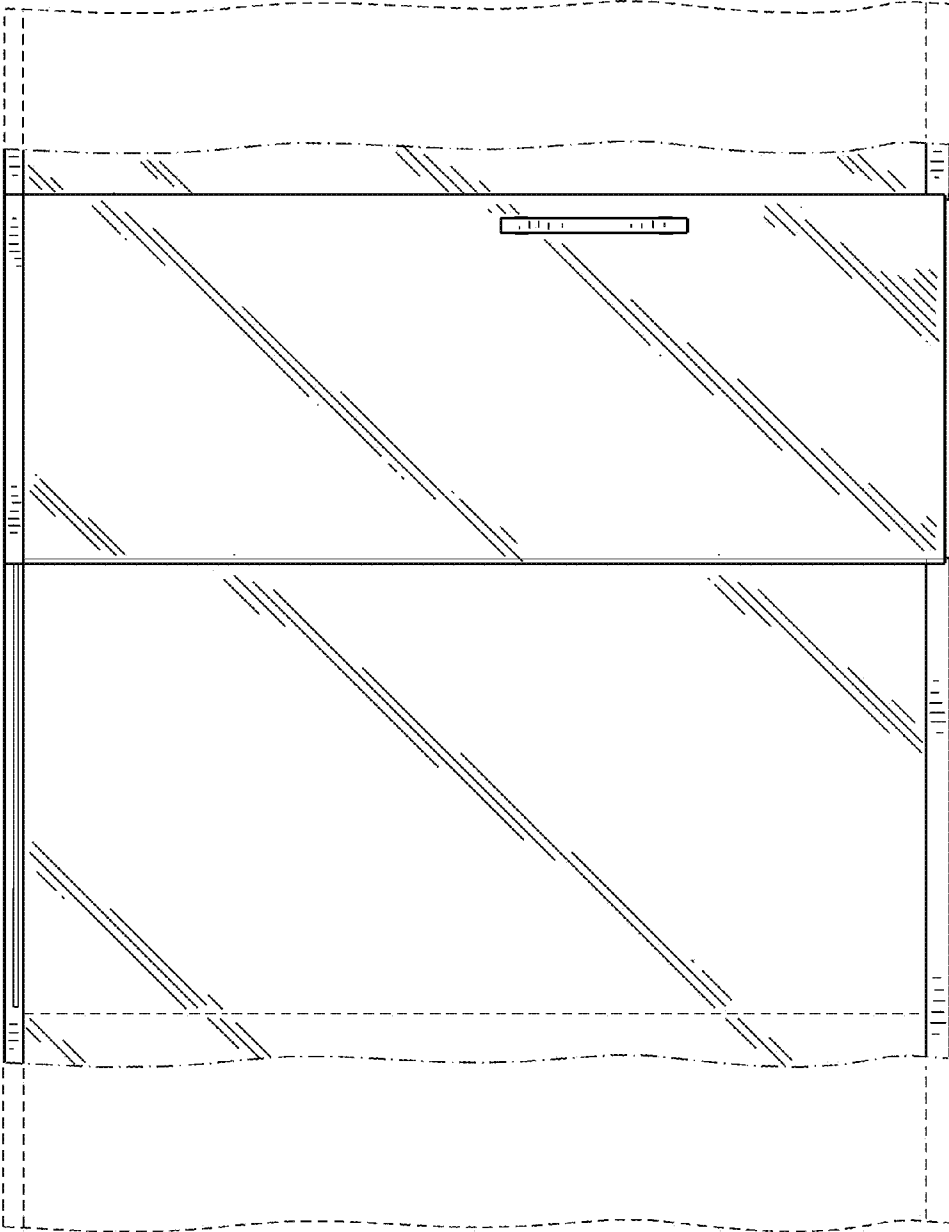

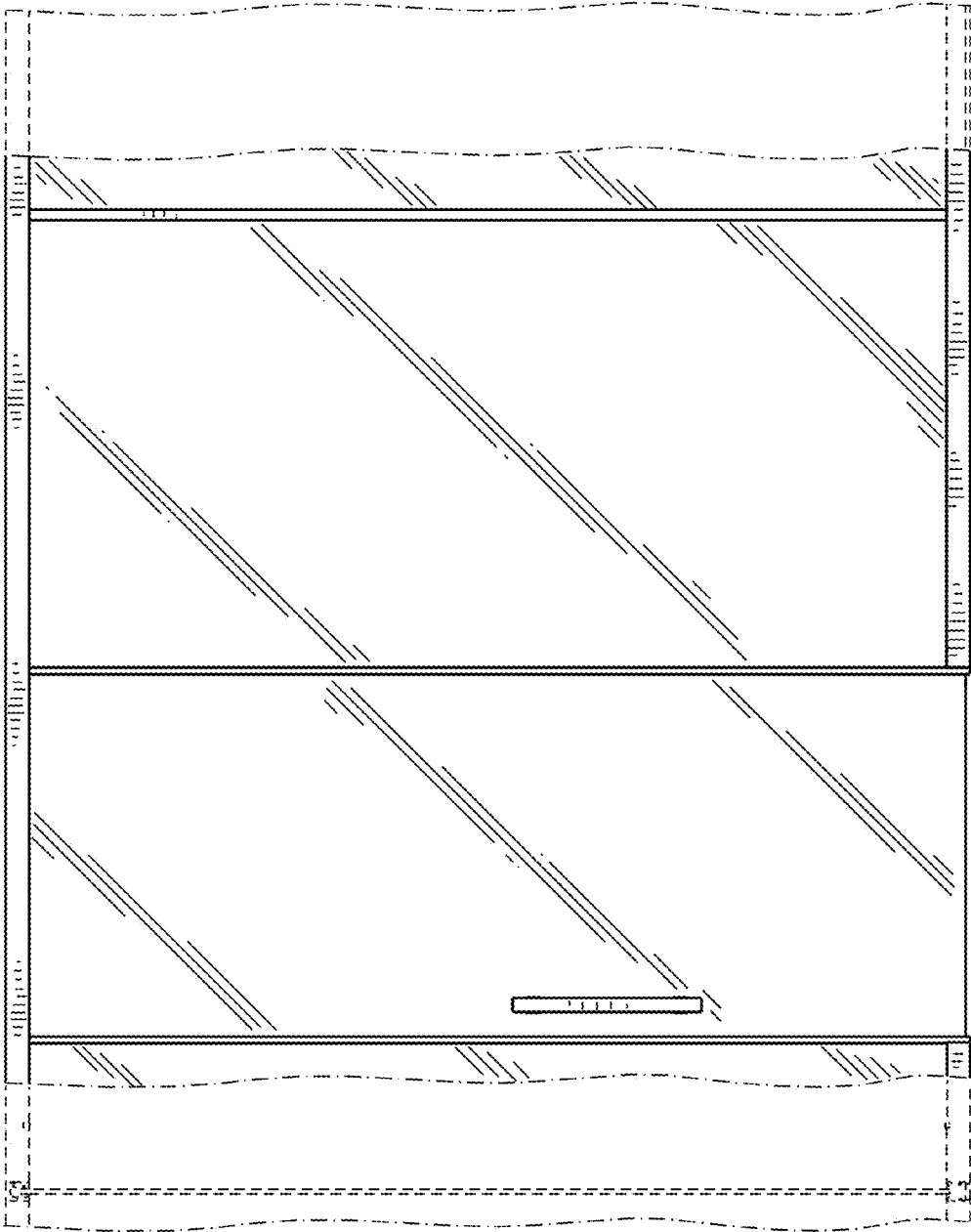

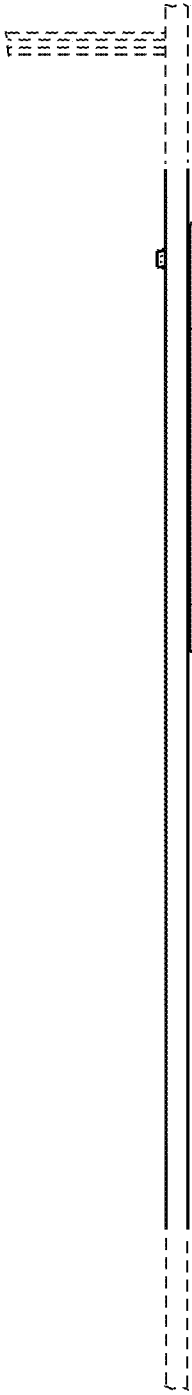

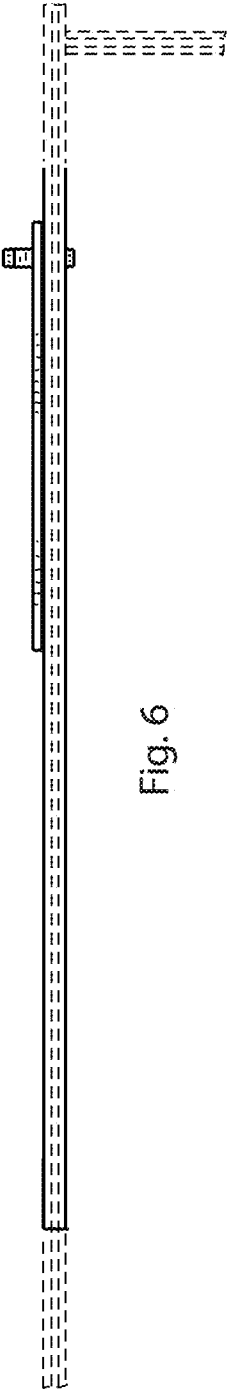
